## PETITION

The Petitioner herein, by the Borough Solicitor John H. Klemeyer, Esquire hereby enters a Petition as hereinafter set forth, averring as follows: 1. The Petitioner is a body corporate and politic with offices at Catharine Street, Milford, PA 18337.

2. The Borough Code provides

in part that: "The Council of the Borough shall have the power, by ordinance, to levy and collect annually, a tax, not exceeding 30 mills for general Borough purposes, unless the Council by majority action shall, upon due cause shown by resolution, petition the court of common pleas, in which case the court may order a rate of not more than 5 mills additional to be levied.... " 53 P.S. § 46302(a). 3. Expenses for insurance continued to increase in the tax year 2013.

4. Tax receipts for the year 2013 came at budget levels but not enough to cover the shortfall.

5. The total assessed value of real estate in the Borough was again decreased.

6. Income from realty transfer tax remained depressed.

7. Fuel costs have increased beyond the expense level of prior years.

8. The Council of the Borough of Milford has attempted to increase its revenues from other sources and has done so to the extent of its legal ability.

9. The Borough residents will be deprived of essential and needed services unless the increase is authorized,

WHEREFORE, THE COUNCIL OF THE BOROUGH OF MILFORD Petitions this Honorable Court to grant leave to the Council to charge 35 mills on assessed value for the tax year 2014 for general fund purposes.
