Adams vs. Barrett

Transfer venue

- The court at any time may transfer an action to the appropriate court of any other county where the action could originally have been brought or could be brought if it determines that it is an inconvenient forum under the circumstances and the court of another county is the more appropriate forum.
- 2. An action may be brought in any county which is the home county of the child at the time of commencement of the proceeding. A county qualifies as a home county if the child has lived there for at least six consecutive months immediately preceding the filing of the action.
- 3. The court identified factors used to identify which county is the more appropriate county to hear the case, which include: (a) whether domestic violence has occurred and is likely to continue in the future and which county could best protect the parties and the child; (b) the length of time the child has resided outside this county; (c) the distance between the court of this county and the court in the other county; (d) the relative financial circumstances of the parties; (e) any agreement of the parties as to which county should have venue; (f) the nature and location of the evidence required to resolve the pending litigation, including testimony of the child; (g) the ability of the court of each county to decide the issue expeditiously and the procedures necessary to present the evidence; and (h) the familiarity of the court of each county with the facts and issues in the pending litigation.
- 4. Here, Mother and the children have resided in Bucks County for well over 2 years; Father has resided in Bucks County for nearly 1½ years; the children have attended school in Bucks County since the Fall of 2018; the Bucks County Justice Center is closer for the parties and had issued a Protection from Abuse Order to Mother. Upon consideration of Plaintiff's Petition to Transfer Venue, the Court noted the case had languished in Chester County and belonged in Bucks County; accordingly, the Court ordered the Chester County Prothonotary to transfer the matter to Bucks County.

MEMORANDUM

Plaintiff/Father, Defendant/Mother, and their two (2) children used to live in Chester County. On August 9, 2018, the date when Plaintiff/Father commenced this action, Defendant/Mother had moved to Bucks County but Plaintiff/Father remained in Chester County. On September 18, 2018, the children began living in Bucks County with Defendant/Mother pursuant to the interim custody order entered on September 18, 2018 by the Honorable Patrick Carmody.¹

A second interim order was entered on October 15, 2018 by the Honorable Jeffrey R. Sommers. That second interim order modified custody² and appointed a custody evaluator to issue a report and recommendation. Plaintiff/Father moved to Bucks County in November of 2019.³ The custody evaluator issued her report and recommendation in March of 2020 and since then there has been no progress in Chester County toward the entry of a final custody order.

By his Petition to Transfer Venue, Plaintiff/Father argued to this court that "[v]enue is not proper in Chester County pursuant to Pa.R.C.P. [No.] 1915.2, as another county, being Bucks County, would be the more appropriate forum." Petition, 11/5/20, p. 1. Defendant/Mother argued that this case should remain in Chester County.

It is the law that "[t]he court at any time may transfer an action to the appropriate court of any other county where the action could originally have been brought or could be brought if it determines that it is an inconvenient forum under the circumstances and the court of another county is the more appropriate forum." Pa.R.C.P. No. 1915.2(c). Here, the parties and the children have lived in Bucks County for more than six (6) consecutive months and there is no dispute that a child custody action could be brought in Bucks County. Pa.R.C.P. No. 1915.2(a) (1)(i) ("An action may be brought in any county which is the home county of the child at the time of commencement of the proceeding . . ."). See also Pa.R.C.P. No. 1915.1(b) (defining "home county" generally as the county where the child has lived "for at least six consecutive months immediately preceding the filing of the action, . . .).

Here, the dispute is whether Chester County or Bucks County is the more appropriate county. The court identifies the more appropriate county by considering the factors used to identify the more appropriate state set out at 23 Pa.C.S. § 5427(b)

¹ That order awarded sole physical custody to Defendant/Mother pursuant to the Interim Stipulation of the parties dated September 13, 2018 and filed September 18, 2018.

² That order awarded primary physical custody to Defendant/Mother. Plaintiff/Father's partial custody was limited to every Saturday from 10:00 a.m. to 2:00 p.m. In addition, Plaintiff/Father was awarded six (6) hours every other Thanksgiving and seven (7) hours every Christmas. Plaintiff/Father was awarded no overnight custody.

³ Plaintiff/Father testified that he moved to Yardley in August of 2018 which Defendant/Mother disputed. Plaintiff/Father testified that he moved to Doylestown in November of 2019 which this court credited as consistent with Plaintiff/Father's claim that the family home in Chester County went into foreclosure in the Fall of 2019.

(Inconvenient forum). See 23 Pa.C.S. § 5471("The provisions of this chapter allocating jurisdiction and functions between and among courts of different states shall also allocate jurisdiction and functions between and among the courts of common pleas of this Commonwealth."). See also B.A.B. v. J.J.B., 166 A.3d 395 (Pa.Super. 2017) (applying 23 Pa.C.S. § 5427(b) factors to appeal from order denying petition to transfer venue), appeal denied, 170 A.3d 990 (Pa. 2017); A.C. v. H.S.G., 2020 WL 201713 (Pa. Super. 2020) (applying 23 Pa.C.S. § 5427(b) factors to appeal from order transferring venue) (persuasive authority). Thus, the factors the court is to consider are as follows:

- (1) whether domestic violence has occurred and is likely to continue in the future and which [county] could best protect the parties and the child;
- (2) the length of time the child has resided outside this [county];
- (3) the distance between the court [of this county] and the court in [the other county];
- (4) the relative financial circumstances of the parties;
- (5) any agreement of the parties as to which [county should have venue];
- (6) the nature and location of the evidence required to resolve the pending litigation, including testimony of the child;
- (7) the ability of the court of each [county] to decide the issue expeditiously and the procedures necessary to present the evidence; and
- (8) the familiarity of the court of each [county] with the facts and issues in the pending litigation.

23 Pa.C.S. § 5427(b).

Here, in deciding whether Chester County or Bucks County is the more appropriate county, this court gave great weight to the fact that Defendant/Mother and the children have resided in Bucks County for well over two (2) years and to the fact that Plaintiff/Father has resided in Bucks County for nearly one and one-half (1½) years. 23 Pa.C.S. § 5427(b)(2) (length of children's residency). This court also gave great weight to the fact that the children have attended school in Bucks County since the Fall of 2018 and the Bucks County Justice Center is closer for the parties. 23 Pa.C.S. § 5427(b)(6) (location of evidence); 23 Pa.C.S.A. § 5427(b)(3) (comparative distance).⁴ It weighs somewhat in favor of Bucks County that Defendant/Mother obtained a Protection from Abuse Order from the Bucks County Court of Common Pleas. 23 Pa.C.S. § 5427(b)(1) (domestic violence).

The remainder of the factors are of comparatively little importance. The relative financial circumstances of the parties recommends neither Chester County nor

⁴ If the custody evaluator must testify, it would be better that she appear remotely or travel to Bucks County in deference to the parties and the children just as it would be better for Defendant/Mother's counsel to appear remotely or travel to Bucks County.

Bucks County. 23 Pa.C.S. § 5427(b)(4) (relative wealth). There is no reason to think that Chester County is any more able to decide the issues expeditiously than Bucks County and the undersigned has no familiarity with this case apart from hearing the evidence on the Petition to Transfer Venue. 23 Pa.C.S. § 5427(b)(7) (expeditious resolution); 23 Pa.C.S.A. § 5427(b)(8) (familiarity). There is no agreement between the parties that venue should remain in Chester County.⁵ 23 Pa.C.S. § 5427(b)(5) (agreement of parties). In sum, this is a case that has languished in Chester County and changed into a case that belongs in Bucks County.

Accordingly, for the reasons set forth above, this court will enter an order granting Plaintiff's Petition to Transfer Venue.

⁵ Defendant/Mother argued that "[t]he parties have agreed that the Chester County Court of Common Pleas shall retain jurisdiction over this matter (see Custody Order and Interim Order marked as Exhibit 'A' attached hereto and incorporated herein by reference.)" Response, 11/24/20, p. 2 (emphasis omitted). However, the Interim Order and Interim Stipulation say nothing about venue. The Custody Order entered October 15, 2018 commands that "[t]he Chester County Court of Common Pleas shall retain jurisdiction over this matter" but that order was not entered by agreement of the parties.
