Arias v. Sousa

Special relief regarding custody - Special Immigrant Juvenile Status

- 1. There is no provision in our statutes or rules that address special relief for an effort to obtain lawful Special Immigrant Juvenile Status (SIJS).
- 2. Special relief is limited to temporary orders affecting custody.
- 3. The law does not permit this court to grant a final custody order as a form of special relief.
- 4. This court has no jurisdiction over immigration matters, which are the province of the federal government; however, the federal government has thrust upon state courts the responsibility to make findings of fact and issue an order in dependency and custodial matters which, under certain circumstances, may allow an individual to be eligible for SIJS.
- 5. The federal government defines a Special Immigrant Juvenile as an immigrant who is present in the United States (a) who has been declared dependent in a juvenile court located in the United States or whom such a court has legally committed to, or placed under the custody of, an agency or department of a State, or an individual or entity appointed by a State or juvenile court located in the United States, and whose reunification with one or both of the immigrant's parents is not viable due to abuse, neglect, abandonment, or a similar basis found under state law; (b) for whom it has been determined in administrative or judicial proceedings that it would not be in the alien's best interest to be returned to the alien's or parent's previous country of nationality or country of last habitual residence.
- 6. The regulations of the United States Citizenship and Immigration Service require that a juvenile court make a judicial determination related to the child's custodial placement or dependency in accordance with state law, that either declares the child dependent upon the juvenile court, or legally commits to or places the child under the custody of an agency or department of the Commonwealth, or an individual or entity appointed by a state or juvenile court.
- 7. In order to be SIJS eligible, the child needs to obtain an order of dependency from a state juvenile court. The order may not be sought primarily for purposes of obtaining lawful immigration status.
- 8. Not all courts having jurisdiction over juveniles under state law may be acting as juvenile courts for the purposes of SIJS classification. For example, a court of general jurisdiction that issues an order with SIJ-related findings outside of any juvenile custody or dependency proceeding would generally not be acting as a juvenile court for SIJ purposes.
- 9. In Pennsylvania, a juvenile is defined as a person who has attained ten years of age and is not yet twenty-one years of age who is alleged to have, upon or after the juvenile's tenth birthday, committed a delinquent act before reaching eighteen years of age or who is alleged to have violated the terms of juvenile probation

prior to termination of juvenile court supervision.

- 10. In Pennsylvania, a child may only be found dependent when he or she is without proper parental care or control necessary for physical, mental, or emotional health. Whether a child is lacking proper parental care and control encompasses two discreet questions: (a) is the child at this moment without proper parental care or control? and (b) if so, is such care and control immediately available? These determinations must be based on clear and convincing evidence.
- 11. Plaintiff seeks special relief to include a final custody order with regard to her son and specific findings of fact that would permit him to seek SIJS and the benefits attendant thereto. There is no evidentiary record upon which the child in the instant case could be found dependent. Further, he is also not a juvenile as defined by Pennsylvania law. There is no emergency or other circumstance present, which warrants special relief in this case. There is no evidence of record that the child faces an imminent threat nor that there would be a change in circumstance in the absence of special relief. Mother seeks to have this court issue its custody order using language specific to dependency and juvenile court proceedings. It is clear to the court that Mother seeks an order, with specific findings of fact, primarily for the purpose of obtaining lawful SIJS for her son. Such an order could be used to induce a federal agency or court, reviewing the child's application for SIJS, to rely on that order. This Court will not grant relief that may create the temptation to misuse its order in such manner. The Court Held Plaintiff's request for special relief and request for specific findings of fact were denied.

DECISION

Plaintiff, Gersika Thamara Ribeiro Arrais ("Mother"), seeks special relief pursuant to Pa.R.Civ.P. 1915.13 and C.C.R.C.P. 1915.13.A, to include a final custody order, with regard to her son, M.A., age 12. Mother also seeks specific findings of fact that would permit M.A. to seek Special Immigrant Juvenile Status ("SIJS") and the benefits attendant thereto. *See*, 8 U.S.C. § 1101(a)(27)(J) (defining "special immigrant"); 8 C.F.R. § 204.11 (special juvenile immigrant classification). After hearing, the court denies Mother's Petition for Special Relief and request for specific findings of fact.¹

PROCEDURAL HISTORY

On June 15, 2022, Mother filed a Complaint for Custody seeking sole legal and physical custody of her son, M.A. Mother alleges, *inter alia*, that it is in the best interest of M.A. to be granted the relief requested. Mother also filed a Petition for Special Relief pursuant to Pa.R.Civ.P. 1915.13 and C.C.R.C.P. 1915.13.A contemporaneously with the Complaint for Custody. This matter was not scheduled for mediation as required by C.C.R.C.P. 1915.4.A(a)(1), nor was it scheduled for conciliation pursuant to C.C.R.C.P. 1915.5.B(c). A hearing was held before this court on the Petition for Special Relief and Custody on August 19, 2022.

Mother's Position in Support

Mother seeks sole legal and physical custody of M.A. Mother also seeks specific findings that will allow M.A. to be eligible for SIJS, which would, in turn, permit him to become a lawful permanent resident of the United States. M.A. was born in Brazil on December 15, 2009, and is nearly 13 years of age. Mother testified that Father was "physical" with M.A. and that she was required to obtain a restraining order against Father in Brazil because of the abuse and his threat to kill her. M.A. has lived with Mother since 2017 and she provides him with his daily

needs, including educational opportunities. Mother also testified that it would be safer for M.A. to remain in her custody. Mother believes she should have sole legal and physical custody of M.A.

M.A., age 12, testified that Mother provides for his needs. He is attending school and doing well. M.A. testified that it is his preference to remain with Mother.

Father's Position in Support

Father, a resident of Brazil, did not participate in these proceedings, but did sign a Declaration and Acceptance of Service of the Complaint in Custody and Petition for Special Relief, in which he represented that he agreed that Mother should have sole legal and physical custody of M.A. (Exh. P-1).

ANALYSIS

In this matter, unlike most custody cases in the Commonwealth, where both Mother and Father are present to address the issues presented to the court, this case offers a markedly different situation because Father, a foreign national, did not participate in the hearing. This case is also unusual because it involves a request for special relief and specific findings of fact for purposes of facilitating M.A.'s application for SIJS.

Request for Special Relief

Mother requests special relief pursuant to Pa.R.Civ.P. 1915.13 and C.C.R.C.P. 1915.13.A in the form of a final custody order with specific findings of fact to support M.A.'s effort to obtain lawful SIJS. There is no provision in our statutes or rules that address special relief for this purpose or permit a departure from the requirement that the factors set forth in 23 Pa. C.S. §5328(a) be addressed by the court. Moreover, Mother's request for special relief is defective for two reasons.

First, special relief is limited to temporary orders affecting custody. *H.L.J. v. R.G.J.*, 239 A.3d 107 (Pa. Super. 2020) (nonprecedential decision) ("Under Rule 1915.13, the court's authority is limited to temporary or interim awards of physical custody."). The law does not permit this court to grant a final custody order as a form of special relief. *Id*.

Second, there is no emergency or other circumstance present, which warrants special relief in this case. *Cf.*, *Steele v. Steele*, 545 A.2d 376 (Pa. Super. 1988) (finding that the court had authority to temporarily suspend visitation to protect child from violent and irrational tendencies of Mother). Mother has not sought a protection from abuse order on behalf of M.A. There is no evidence of record that M.A. faces an imminent threat nor that such issues will not be

addressed by a final custody order. The *status quo* in this instance favors Mother and there is no evidence of record that M.A. would be put at risk or that there would be a change in circumstance in the absence of special relief.

For the foregoing reasons, Mother's request for special relief is denied.

Request for Specific Findings

Mother comes before the court seeking custody and special relief for custody. It is clear to the court that Mother seeks an order, with specific findings of fact, primarily for the purpose of obtaining lawful SIJS for M.A. (Petition for Special Relief, ¶6). In every custody matter, this court is *required* to address the factors set forth in 23 Pa. C.S. §5328(a) in support of its decision rather than make limited specific findings of fact, requested by a party, to facilitate an application for SIJS.

This court has no jurisdiction over immigration matters, which are the province of the federal government. However, the federal government has thrust upon state courts the responsibility to make findings of fact and issue an order in dependency and custodial matters which, under certain circumstances, may allow an individual to be eligible for SIJS. This is not such a case.

The federal government defines a Special Immigrant Juvenile as:

An immigrant who is present in the United States –

- (i) who has been declared dependent in a juvenile court located in the United States or whom such a court has legally committed to, or placed under the custody of, an agency or department of a State, or an individual or entity appointed by a State or juvenile court located in the United States, and whose reunification with 1 or both of the immigrant's parents is not viable due to abuse, neglect, abandonment, or a similar basis found under State law;
- (ii) for whom it has been determined in administrative or judicial proceedings that it would not be in the alien's best interest to be returned to the alien's or parent's previous country of nationality or country of last habitual residence...

8 U.S.C. § 1101(a)(27)(J). The regulations of the United States Citizenship and Immigration Service ("USCIS"), also require that a "juvenile court make a judicial determination related to the child's custodial placement or dependency in accordance with state law, that either declares the child dependent upon the juvenile

court, or legally commits to or places the child under the custody of an agency or department of the Commonwealth, or an individual or entity appointed by a state or juvenile court." 8 C.F.R. § 204.11(b)(4) (requiring juvenile court order for SIJS eligibility); 8 C.F.R. § 204.11(c)(1)(i)(A-B) (addressing juvenile court orders). See also, Osorio-Martinez v. Attorney General of the United States of America, 893 F.3d 153 (3d. Cir. 2018) (In order to be SIJS eligible, the child needs to "obtain an order of dependency from a state juvenile court."). The order may not be sought primarily for purposes of obtaining lawful immigration status. See, 87 Fed. Reg. 10368 (2022) (Department of Homeland Security Summary of Proposed Rule).

"Not all courts having jurisdiction over juveniles under state law may be acting as juvenile courts for the purposes of SIJS classification. For example, a court of general jurisdiction that issues an order with SIJ-related findings outside of any juvenile custody or dependency proceeding would generally not be acting as a juvenile court for SIJ purposes." USCIS POLICY MANUAL VOL. 6, PART J, CHAP. 2(C) (2022) (eligibility requirements) (emphasis added).² "The state law definition of "juvenile" controls jurisdiction to determine dependency or custody proceedings before the juvenile court." USCIS POLICY MANUAL VOL. 6, PART J, CHAP. 2(C)(4) (2022) (eligibility requirements). In Pennsylvania, a juvenile is defined as "a person who has attained ten years of age and is not yet twenty-one years of age who is alleged to have, upon or after the juvenile's tenth birthday, committed a delinquent act before reaching eighteen years of age or who is alleged to have violated the terms of juvenile probation prior to termination of juvenile court supervision." Pa. R.J.C.P. 120.

Finally, in Pennsylvania, a child may only be found dependent when he or she "is without proper parental care or control . . . necessary for physical, mental, or emotional health . . ." *Matter of C.R.S.*, 696 A.2d 840, 842 (Pa. Super. 1997). Moreover, "whether a child is lacking proper parental care and control encompasses two discreet questions: (1) is the child at this moment without proper parental care or control? and (2) if so, is such care and control immediately available?" *Id.* These determinations must be based on clear and convincing evidence. *Id.* at 843; see also, 42 Pa. C.S. §6302 (defining dependent child).

The matter before the court is a custody case. The court is not sitting as a juvenile court as defined by federal law. USCIS POLICY MANUAL VOL. 6, PART J, CHAP. 2(C) (2022) (eligibility requirements); Pa. R.J.C.P. 120. (defining the term "juvenile"). There is no dependency matter before the court regarding M.A., and even if there were, the record is clear beyond question that he has parental care and control provided by his Mother. There is no evidentiary record upon which M.A. could be found dependent. *Matter of C.R.S.*, 696 A.2d 840 (Pa. Super. 1997). M.A. is also not a juvenile as defined by Pennsylvania law. Pa. R.J.C.P. 120.

Mother seeks to have this court issue its custody order using language

specific to dependency and juvenile court proceedings. It appears that if the court were to sign such an order it could then be used to induce a federal agency or court, reviewing M.A.'s application for SIJS, to rely on that order in concluding that the statutory requirements of 8 U.S.C. § 1101(a)(27)(J) and accompanying regulations have been met when that is not the case. This court will not grant relief that may create the temptation to misuse its order in such manner.

For the foregoing reasons, Mother's request for specific findings is denied.

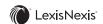
