PUBLIC NOTICE FOR REAPPOINTMENT OF BANKRUPTCY JUDGE

The current 14-year term of office for U.S. Bankruptcy Judge Magdeline D. Coleman for the Eastern District of Pennsylvania is due to expire on April 11, 2024. The United States Court of Appeals for the Third Circuit is considering the reappointment of Judge Magdeline D. Coleman to a new 14-year term of office.

Upon reappointment, the incumbent would continue to exercise the jurisdiction of a bankruptcy judge as specified in Title 28, United States Code; Title 11, United States Code; and the Bankruptcy Amendments and Federal Judgeship Act of 1984, Pub. L. No. 98-353, §§ 101-122, 98 Stat. 333-346. In bankruptcy cases and proceedings referred by the district court, the incumbent would continue to perform the duties of a bankruptcy judge that might include holding status conferences, conducting hearings and trials, making final determinations, entering orders and judgments, and submitting proposed findings of fact and conclusions of law to the district court.

Members of the bar and the public are invited to submit comments for consideration by the Court of Appeals regarding the reappointment of Judge Magdeline D. Coleman. All comments should be directed to one of the following addresses:

Public Notice Appointment of New Magistrate Judge in the United States District Court for the Eastern District of Pennsylvania

The Judicial Conference of the United States has authorized the appointment of а full-time United States magistrate judge for the Eastern District of Pennsylvania at Philadelphia. The appointee may be required to preside at court sessions to be held at Reading, Philadelphia, Allentown, and Easton. The essential function of courts is to dispense justice. An important component of this function is the creation and maintenance of diversity in the court system. A community's belief that a court dispenses justice is heightened when the court reflects the community's diversity.

The duties of the position are demanding and wide-ranging, and will include, among others: (1) conduct of most preliminary proceedings in criminal cases; (2) trial and disposition of misdemeanor cases; (3) conduct of various pretrial matters and evidentiary proceedings on delegation from a district judge; and (4) trial and disposition of civil cases upon consent of the litigants. The basic authority of a United States magistrate judge is specified in 28 U.S.C. § 636.

To be qualified for appointment an applicant must:

- 1. Be, and have been for at least five years, a member in good standing of the bar of the highest court of a state, the District of Columbia, the Commonwealth of Puerto Rico, the Territory of Guam, the Commonwealth of the Northern Mariana Islands, or the Virgin Islands of the United States, and have been engaged in the active practice of law for a period of at least five years;
- 2. Be competent to perform all the duties of the office; be of good moral character; be emotionally stable and mature; be committed to equal justice under the law; be in good health; be patient and courteous; and be capable of deliberation and decisiveness;
- 3. Be less than seventy years old; and
- 4. Not be related to a judge of the district court.

A merit selection panel composed of attorneys and other members of the community will review all applicants and recommend to the district judges in confidence the five persons it considers best qualified. The court will make the appointment following an FBI full-field investigation and an IRS tax check of the applicant selected by the court for appointment. The individual selected must comply with the financial disclosure requirements pursuant to the Ethics in Government Act of 1978, Pub. L. No. 95-521, 90 Stat. 1824 (1978) (codified at 5 U.S.C. app. 4 §§ 101-111) as implemented by the Judicial Conference of the United States. An af-

firmative effort will be made to give due consideration to all qualified applicants without regard to race, color, age (40 and over), gender, religion, national origin, or disability. The current annual salary of the position is \$213,992.00. The term of office is eight (8) years.

The application is available on the court's web site at https://www.paed.uscourts.gov/ Only applicants may submit applications and applications must be received by Friday, December 15, 2023.

All applications will be kept confidential, unless the applicant consents to disclosure, and all applications will be examined only by members of the merit selection panel and the judges of the district court. The panel's deliberations will remain confidential.

Applications will only be accepted by email. Applications sent by mail will not be considered. Due to the overwhelming number of applications expected, applicants should not contact the court regarding the status of their application.

Commonwealth v. Javier Gomez Ineffective Assistance – Evidence of Third-Party Guilt

A petitioner is not entitled to post-conviction relief for trial counsel's failure to introduce evidence of third-party guilt where the Petitioner cannot show prejudice because the evidence connecting the petitioner to the contraband underlying his charges was overwhelming.

OPINION BY WRIGHT, J., August 7, 2023. Petitioner Javier Gomez ("Petitioner") has filed a counseled appeal from my May 30, 2023, Order denying relief under the Post Conviction Relief Act (PCRA), 42 Pa. C.S.A. §§ 9514–46. This Opinion is written pursuant to Rule 1925(a) of the Pennsylvania Rules of Appellate Procedure and, for the reasons that follow, Petitioner's appeal is meritless.

BACKGROUND

On September 22, 2017, Lancaster City Police Officers observed a Town & Country Minivan weaving down East Orange Street in Lancaster City, Pennsylvania, nearly striking the vehicles parked alongside the road. (Notes of Testimony, Jury Trial, Aug. 6–7, 2018, at 130–31 [hereinafter "N.T. Jury Trial, at ____"]; Notes of Testimony, Bench Trial, Oct. 15, 2018, at 50–52 [hereinafter "N.T. Bench Trial, at ____"]). Officers followed the van and initiated a traffic stop when the vehicle failed to use a turn signal as required by law. (N.T. Jury Trial, at 131; N.T. Bench Trial, at 51–52). Petitioner was driving the van—which was owned by and registered to him—and was accompanied by two passengers, Annie Roth and Andrew Lundgren. (N.T. Jury Trial, 133–35; N.T. Bench Trial, at 54).

During the stop, Officers at the scene observed Petitioner, Ms. Roth, and Mr. Lundgren exhibit odd, non-complaint behaviors. All three occupants refused to roll down their windows more than a quarter or half inch and were reaching around in the vehicle, Petitioner refused to provide his license and registration, and Petitioner was observed reaching toward the pocket side door and center console areas of the vehicle. (N.T. Jury Trial, at 133–35; N.T. Bench Trial, at 54). Further, Officers observed Mr. Lundgren scratching his arms and kicking a bag inside the vehicle and noticed Ms. Roth using animated hand expressions including flailing her arms and moving her hands on her breast area. (N.T. Jury Trial, at 133–35, 165, 203; N.T. Bench Trial, 54).

Because of the occupants' behavior, Officers decided to break one of the van's windows to gain entry into the vehicle. (N.T. Jury Trial, at 157, 175–76; N.T. Bench Trial, at 55–56). After Petitioner, Ms. Roth,

and Mr. Lundgren were removed, Officers searched the van. (N.T. Jury Trial, at 175; N.T. Bench Trial, at 55-56). In the van's center console, underneath Petitioner's registration and insurance information, Officers found a Charter Arms .38 caliber revolver, heroin, and cocaine. (N.T. Jury Trial, at 176-77; N.T. Bench Trial, at 124-26). Petitioner's DNA was later discovered on the revolver. (N.T. Jury Trial, at 291–94; N.T. Bench Trial, at 65).

Officers also found a "stow and go" compartment on the floor of the vehicle directly behind the driver's seat that contained a locked safe and a backpack. (N.T. Jury Trial, at 156–60; N.T. Bench Trial, at 159–63). The key to the safe was found on the key ring that was still inserted in the ignition of Petitioner's van. (N.T. Jury Trial, at 156-60; N.T. Bench Trial, at 171). When Officers used the key to open the safe, they discovered bags of heroin and cocaine and a Ruger 9-millimeter handgun. (N.T. Jury Trial, at 156-60; N.T. Bench Trial, at 159-60). Petitioner's DNA was discovered on the handgun. (N.T. Jury Trial, at 291–94; N.T. Bench Trial, at 65). The backpack found in the compartment contained various drugs and paraphernalia including methamphetamines, marijuana, cocaine, Naloxone, needles, and packaging materials. (N.T. Bench Trial, at 162-63). A casino rewards card with Petitioner's name was also found inside the backpack. (N.T. Bench Trial, at 161). Officers later discovered that both firearms removed from the van had been reported stolen. (N.T. Bench Trial, at 38, 80).

Following Petitioner's arrest, he was charged with the following offenses: Possession with Intent to Deliver,1 five counts; Possession of Drug Paraphernalia²; Persons Not to Possess Firearms,³ two counts; Firearms Not to be Carried without a License,4 two counts; Receiving Stolen Property,⁵ two counts; and two traffic violations.

A jury trial on the Persons not to Possess charges commenced on August 6, 2018. Following two days of trial, the jury convicted Petitioner on both counts. Petitioner elected to have a bench trial on the remaining counts. Following the October, 2018, bench trial before the Honorable Donald R. Totaro, Petitioner was convicted on all remaining counts.⁶ Judge Totaro sentenced Petitioner on October 25, 2018, to twelve and one-half to twenty-five years of incarceration. Petitioner thereafter filed a post-sentence motion, which was denied on November 9, 2018. On December 7, 2018, Petitioner filed a direct appeal to the Superior Court. The Superior Court affirmed on December 19, 2019. See Commonwealth v. Gomez, 224 A.3d 1095 (Pa. Super. 2019). The Pennsylvania Supreme Court denied discretionary review on July 21, 2020.

Petitioner timely filed the instant Petition for Post Conviction Relief—his first—on September 27, 2021. I appointed Daniel C. Bardo, Esquire, as counsel and, after several requests for extension of time,

Attorney Bardo filed an Amended Petition on May 25, 2022. The Commonwealth filed an Answer to the Amended Petition on August 9, 2022, and I issued a 907 Notice of Intent to Dismiss⁷ the Amended Petition on September 1, 2022. On September 22, 2022, Petitioner filed a counseled Objection to my 907 Notice and I determined that a hearing was, in fact, necessary. The hearing was held on February 27, 2023.

During the hearing, Petitioner's counsel advanced numerous arguments in support of post-conviction relief. Relevant to the instant appeal, Attorney Bardo argued that Petitioner's trial counsel, Michael Marinaro, Esquire, was ineffective for failing to introduce evidence of fellow passenger Andrew Lundgren's prior convictions for dealing drugs. Attorney Marinaro testified that, at trial, his theory of the case was that Mr. Lundgren and Ms. Roth were actually the owners of the guns and the drugs found in Petitioner's van. (Notes of Testimony, PCRA Hearing, Feb. 27, 2023, at 9 [hereinafter "N.T. PCRA Hearing, at "]). Attorney Marinaro explained that he was aware that Mr. Lundgren had three prior convictions for Possession with Intent to Deliver. (N.T. PCRA Hearing, at 16). When asked why he did not seek to introduce the prior convictions at trial, Attorney Marinaro referenced the "totality of the evidence" but admitted he was "not exactly sure why" he did not offer the convictions as evidence. (N.T. PCRA Hearing, at 16).

Following the hearing, Petitioner filed a counseled Brief in Support of his Amended Petition and the Commonwealth responded on May 2, 2023. On May 31, 2023, I entered an Order dismissing Petitioner's Amended Petition. Petitioner timely filed a Notice of Appeal to the Superior Court on June 30, 2023, and simultaneously filed a Statement of Errors Complained on Appeal. The Commonwealth filed its response on July 11, 2023.

DISCUSSION

Petitioner raises a single appellate claim: that trial counsel was ineffective for failing to introduce Mr. Lundgren's three prior PWID convictions and, accordingly, that I erred by denying his claim for post-conviction relief on that ground.

The Post Conviction Relief Act ("PCRA") provides for an action by which an individual convicted of a crime they did not commit or serving an illegal sentence may obtain collateral relief. 42 Pa. C.S.A. § 9542. Ordinarily, a PCRA Petition must be filed within one year of the date that the judgment becomes final. Id. § 9545(b)(1). For purposes of the PCRA, "a judgment becomes final at the conclusion of direct review, including discretionary review in the Supreme Court of the United States and the Supreme Court of Pennsylvania, or at the expiration of time for seeking the review." Id. at § 9545(b)(3). The instant Petition was timely filed.8

To be eligible for relief under the PCRA, Petitioner must also plead and prove beyond a preponderance of the evidence that: (1) he was

convicted of a crime in the Commonwealth; (2) he is currently serving a sentence of imprisonment, probation, or parole for the crime; (3) the issue(s) that he asserts have not been previously litigated; (4) his conviction or sentence resulted from, *inter alia*, ineffective assistance of counsel that so undermined the truth-determining process that no reliable adjudication of guilt or innocence could have taken place; and (4) the failure to previously litigate the issue(s) now raised could not have been the result of any rational, strategic, or tactical decision by counsel. 42 Pa. C.S.A. § 9543(a)(i)–(iv). Here, Petitioner was found guilty of the numerous offenses outlined above and is still serving his aggregate twelve and one-half to twenty-five year sentence. Further, the issues that he now asserts have not been previously litigated.

Petitioner claims that his conviction resulted from ineffective assistance of counsel-namely, Attorney Marinaro's decision not to introduce Mr. Lundgren's prior PWID convictions. To prevail on a claim of ineffective assistance of counsel, Petitioner must show by a preponderance of the evidence that "(1) the underlying claim is of arguable merit; (2) the particular course of conduct pursued by counsel had no reasonable basis designed to effectuate [Petitioner's] interests; and (3) but for counsel's ineffectiveness, there is a reasonable probability that the outcome of the proceedings would have been different." Commonwealth v. Lambert, 797 A.2d 232, 243 (Pa. 2001); Commonwealth v. Chmiel, 30 A.3d 111, 1127 (Pa. 2011); see Commonwealth v. Pierce, 527 A.2d 973 (Pa. 1987); see also Strickland v. Washington, 466 U.S. 668 (1984). Petitioner must satisfy all three elements of the test; failure to meet any single prong of the test is fatal to an ineffectiveness claim. Commonwealth v. Walker, 36 A.3d 1, 7 (Pa. 2011) (citing Commonwealth v. Basemore, 744 A.2d 717, 738 n.23 (Pa. 2000)).

Instantly, assuming, *arguendo*, that Mr. Lundgren's prior convictions were admissible and that Attorney Marinaro's decision not to introduce the evidence lacked a reasonable basis, Petitioner cannot show that he was prejudiced by the error. Even if Mr. Lundgren's convictions were admitted and the jury and Judge Totaro believed that Mr. Lundgren was, in fact, a drug dealer, it would not change the fact that the evidence against Petitioner on each charge was overwhelming. Simply put, Mr. Lundgren's status as a drug dealer would not have changed that the evidence sufficiently demonstrated that Petitioner himself possessed the guns and drugs recovered from his van.

Regarding Petitioner's convictions for Possession with Intent to Deliver and Possession of Drug Paraphernalia, the Commonwealth was required to prove "actual, constructive, or joint constructive possession of the contraband." Commonwealth v. Vargas, 108 A.3d 858, 868 (Pa. Super. 2014) (quoting Commonwealth v. Thompson, 428 A.2d 223, 224 (Pa. Super. 1981)). Here, because the drugs and paraphernalia were not found on Petitioner's person, the Commonwealth needed to prove that Petitioner had constructive or joint possession of the contraband by introducing "evidence demonstrating either [Petitioner's] participation in the drug related activity or evidence connecting [Petitioner] to

the specific . . . areas where the drugs were kept." <u>Commonwealth v. Vargas</u>, 108 A.3d 858, 868 (Pa. Super. 2014) (quoting <u>Commonwealth v. Macolino</u>, 469 A.2d 132, 134–35 (Pa. 1983)).

The Commonwealth overwhelmingly satisfied its burden. The controlled substances and paraphernalia were found in a van that was owned by and registered to Petitioner. Some of the substances were found in the van's center console underneath Petitioner's vehicle registration and insurance information. Other substances and associated paraphernalia were found inside a backpack and in a locked safe located in a "stow and go" compartment on the floor of the van directly behind Petitioner's seat. The backpack where drugs and paraphernalia were found contained a casino card with Petitioner's name on it and the safe where other substances were located was opened by a key on Petitioner's own key ring. Thus, even if the evidence of Mr. Lundgren's past PWID convictions had been introduced, the evidence presented by the Commonwealth unquestionably established that Petitioner participated in the drug related activity and connected Petitioner to the specific areas where the drugs were found.

The same logic applies to Petitioner's firearms-related convictions, for which the Commonwealth was required to establish "that [Petitioner] was 'in physical possession or control of a firearm." <u>Commonwealth v. Gomez</u>, 224 A.3d 1095, 1101 (Pa. Super. 2019) (quoting 18 Pa.C.S. § 6106(a.1)(1.1)(B)). As explained by the Superior Court in its Opinion addressing Petitioner's direct appeal, this language has been interpreted "to mean 'the knowing exercise of power over a weapon, which may be proven through evidence of a direct, physical association between the defendant and the weapon or evidence of constructive control." <u>Id</u>. (quoting <u>Commonwealth v. Hanson</u>, 82 A.3d 1023, 1036–37 (Pa. 2013)).

Instantly, there was "substantial evidence" that Petitioner knowingly exercised power over the guns found in his van. Id. at 1101. The .38 caliber revolver was found in the center console of Petitioner's van underneath his vehicle registration and insurance information. Importantly, Petitioner's DNA was found on the revolver. Officers located the Ruger 9-millimeter handgun in a locked safe in the "stow and go" compartment found on the floor of the vehicle directly behind the seat where Petitioner had been sitting. The locked safe was opened using a key that Officers found on the key ring that was inserted in Petitioner's van. Petitioner's DNA was also found on the Ruger handgun. The DNA evidence recovered from the weapons demonstrated that Petitioner had physical possession of the guns, "thus exerting actual control over the weapon(s)." Id. Further, the locations in which the firearms were found suggested "that [Petitioner] 'had the ability to exercise a conscious dominion [over the [weapons]] and the intent to do so." Id. (quoting Hanson, 82 A.3d at 1037). Again, to the extent that Mr. Lundgren's prior PWID convictions had any relevance to the gun charges that Petitioner faced, the admission of these convictions would not have altered the outcome of Petitioner's trials. The Commonwealth presented extensive

evidence showing that Petitioner possessed the at-issue weapons.

CONCLUSION

For the reasons detailed above, Petitioner cannot show that he was prejudiced by trial counsel's failure to offer Mr. Lundgren's three prior PWID convictions. Appellant's claim that I erred by denying his PCRA Petition is, therefore, without merit and I enter the following:

ORDER
