A petition has been filed asking the Court to put an end to all rights you have to your child, E.T.. The Court has set a hearing to consider ending the rights to your child on Tuesday, May 10, 2016 at 1:30 p.m. in the Franklin County Court House, Chambersburg, PA. If you do not appear at this hearing, the Court may decide that you are not interested in retaining your rights to the child, and your failure to appear may affect the Court's decision on whether to end your rights to your child. You are warned that even if you fail to appear at the scheduled hearing, the hearing will go on without you and the Court may end your rights to your child without you being present. You have a right to be represented by a lawyer. Paul Tucci's attorney is Michael Connor, Esq. who can be reached at 717-262-2185. Heather Johnson's attorney is Elizabeth Johnson, Esq. who can be reached at 717-597-0200.

The Court of Common Pleas of Franklin County is required by law to comply with the Americans With Disabilities Act of 1990. All arrangements must be made at least 72 hours prior to a hearing or business before the Court. You must attend the scheduled hearing. Under A.C.T. 101 of 2010, there may be an option to enter into a voluntary, enforceable post-adoption contact agreement.
