FINAL DECREE

AND NOW, this 15th day of December, 2016, at 8:40 a.m., upon consideration of the Petition for Involuntary Termination of Parental Rights of Christopher Hazlett, as natural father of Christopher Damon Hazlett, Jr., a minor, and after hearing held thereon, the Court by clear and convincing evidence finds that the facts set forth in the petition have been demonstrated and proven to the satisfaction of the Court.

The Court further finds and concludes

1. that this Court has jurisdiction;
2. that notice of the hearing on the petition for involuntary termination was provided to Christopher Hazlett, and to all persons entitled to notice;
3. that Christopher Hazlett, the natural father of Christopher Damon Hazlett, Jr., by conduct continuing in excess of six (6) months, has evidenced a settled purpose of relinquishing parental claim to the child and has failed to perform parental duties;
4. that the repeated and continued incapacity, neglect or refusal of Christopher Hazlett has caused Christopher Damon Hazlett, Jr., to be without essential parental care, control or subsistence necessary for his physical or mental well-being and the conditions and causes of the incapacity, neglect or refusal cannot or will not be remedied by Christopher Hazlett;
5. that Christopher Damon Hazlett, Jr., was removed from the care of Christopher Hazlett, natural father, by the court for a period of at least six (6) months, the conditions which led to

the removal of the child continue to exist, Christopher Hazlett cannot or will not remedy those conditions within a reasonable period of time, and the services or assistance reasonably available to Christopher Hazlett are not likely to remedy the conditions which led to the removal of the child within a reasonable period of time;

6. that Christopher Damon Hazlett, Jr., has been removed from the care of Christopher Hazlett under a voluntary agreement with the agency, twelve (12) months have elapsed from the date of placement, and the conditions which led to the placement of the child continue to exist;

7. that the termination of the parental rights of Christopher Hazlett is best for the developmental, physical and emotional needs and welfare of Christopher Damon Hazlett, Jr.; and

8. that the custody of Christopher Damon Hazlett, Jr. is awarded to Schuylkill County Children & Youth Services, intermediary.

It is directed that all papers in this case and testimony shall be withheld from public inspection and no person shall be allowed access thereto except upon Order of this Court granted upon cause shown.

Under Pennsylvania law, you have a right, now or at any time hereafter, to place on file with the Court and with the Department of Health certain personal information which may be made available to your child.

YOU MAY FILE A CONSENT FORM GRANTING PERMISSION FOR THE COURT OR THE DE-

PARTMENT TO DISCLOSE THE INFORMATION CONTAINED IDENTIFYING OR NON-IDENTIFYING INFORMATION, AT ANY TIME AFTER YOUR CHILD ATTAINS THE AGE OF 18, OR, IF LESS THAN 18, TO HIS ADOPTIVE PARENT OR LEGAL GUARDIAN.

YOU SHALL BE ENTITLED TO UPDATE THOSE RECORDS, AS NECESSARY, TO REFLECT YOUR CURRENT ADDRESS OR ANY OTHER PERTINENT INFORMATION.

THE INFORMATION MAY ONLY BE DISCLOSED UPON REQUEST OF YOUR CHILD OR HIS ADOPTIVE PARENT OR LEGAL GUARDIAN.

YOUR CONSENT MAY BE WITHDRAWN AT ANY TIME BY FILING A WITHDRAWAL OF CONSENT FORM WITH THE COURT AND THE DEPARTMENT OF HEALTH.

NOTICE TO BIRTH PARENTS
PENNSYLVANIA ADOPTION
MEDICAL HISTORY

This is to inform you about an Adoption Law provision relating to medical history information. As the birth parent of a Pennsylvania born child, who is being or was ever adopted in the past, you have the op-

portunity to voluntarily place on file medical history information. The information which you choose to provide could be important to your child's present and future medical care needs.

The law makes it possible for you to file current medical information, but it also allows you to update the information as new medically related information becomes available. Request to release the information will be honored if the request is submitted by a child 18 years of age or older. The law also permits that we honor requests for information as submitted by the adoptive parents or legal guardians of adoptees who are not yet 18 years of age. All information will be maintained and distributed in a manner that fully protects your right to privacy.

You may obtain the appropriate form for you to file medical history information by contacting the Adoption Medical History Registry. Registry staff are available to answer your questions. Please contact them at:
