P. W. to be an incapacitated person and appoint a guardian to act on her behalf.

To be an incapacitated person means that C. P. W. is not able to receive and effectively evaluate information and communicate decisions and that she is unable to manage her money and other property, or to make necessary decisions about where she will live, what medical care she will get or how her money will be spent.

If the Court decides that C. P. W. is an incapacitated person, the Court may appoint a guardian for her, based on the nature of any condition or disability and her capacity to make and communicate decisions. The

guardian will be of her person and her money and other property and will have either limited or full powers to act for her.

If the Court finds C. P. W. is totally incapacitated, her legal rights will be affected and she will not be able to make a contract or gift of her money or other property. If the Court finds that she is partially incapacitated, her legal rights will also be limited as directed by the Court.

If you do not appear at the hearing (either in person or by an attorney representing you) the Court will still hold the hearing in your absence and may appoint the guardian requested.
