Commonwealth of Pennsylvania v. Anjan M. Garjurel**No. CP 22-CR-0001912-2023****Criminal – Motion to Suppress/Custodial Interrogation/
Reasonableness of Belief of Restriction of Freedom of Action**

1. Pennsylvania State Trooper arrived at Defendant's address to determine the owner of a vehicle involved in a hit and run accident. Defendant answered the door and spoke to the trooper from the porch as the trooper remained on the walkway. Defendant denied that he had a cell phone to contact the investigating Swatara Township officer, and stated he would not contact that officer in person. Defendant returned to the inside of the house. When the trooper returned a few minutes later and knocked on the door Defendant answered the door. Defendant then came outside and spoke to the investigating officer over the trooper's cell phone. Defendant told the investigating officer that he was involved in an accident at the location in question and that he did not remain at the scene after the accident.

At the suppression hearing, Defendant acknowledged that he could have ended the phone conversation with the investigating officer and could have returned to his house.

The Commonwealth charged Defendant with Aggravated Assault, Recklessly Endangering Another Person, Accident Involving Damage/Attended Vehicle, Vehicle Turning Left.

2. Defendant sought suppression of statements made to police asserting that he believed he was subject to custodial interrogation, not feel free to leave, and that police did not provide *Miranda* warnings.
3. The test for whether an individual is subject to custodial interrogation which requires police to give *Miranda* warnings focuses on whether the individual being interrogated reasonably believes his freedom of action is being restricted.

The Court denied Defendant's Motion to Suppress statements finding that no custodial interrogation occurred which required officers to give Miranda rights in that Defendant could not reasonably believe that police restricted his freedom to leave or end conversation.

MEMORANDUM OPINION AND ORDER

This matter comes before the Court on the Motion to Suppress statements made by Anjan Gajurel ("Defendant") to Officer Richard LeCadre and Trooper Darnell Williams. For the reasons set forth, we DISMISS the Motion to Suppress.¹

FACTS

¹ The Defense and Commonwealth resolved Count 2 of the Omnibus Pre-Trial Motion regarding discovery.

On March 28, 2023, at approximately 8:00 pm, Trooper Williams contacted Anjan M. Gajurel ("Defendant") at his residence in Carlise. (Transcript of Proceedings, Suppression Hearing, March 6, 2024, p.6) (Hereinafter, "N.T."). Officer LeCadre of the Swatara Township Police department asked Trooper Williams to visit the residence and make contact with the Defendant. (N.T., p. 6). Officer LeCadre determined that the owner of a vehicle involved in a hit and run accident in Harrisburg lived at the Carlise address. (N.T., p. 18). Officer LeCadre requested that Trooper Williams contact the individual to gather information. (N.T., p. 18).

Trooper Williams arrived at the address in a marked police vehicle and in full uniform. (N.T. p. 13). Trooper Williams looked to see if the vehicle was in the driveway of the home. *Id.* He did not look in other areas of the property. *Id.* Trooper Williams approached the door and knocked several times. (N.T., p. 13). Trooper Williams testified that it took the Defendant a long time to answer the door. (N.T., p. 7). Defendant testified that he was asleep when Trooper Williams knocked. (N.T., p. 26). When Defendant answered the door, Trooper Williams spoke to him while Defendant was on the porch and Trooper Williams was on the walkway to the driveway. (N.T., p. 8). Defendant acknowledged that he did not have to open the door when Trooper Williams knocked. (N.T. p. 32).

Trooper Williams relayed to Defendant that Officer LeCadre was attempting to contact Defendant. (N.T., p. 8). Trooper Williams asked Defendant if he had a cell phone with which he could contact Officer LeCadre, or, if he could speak to Officer LeCadre in person. (N.T. pp. 8-9). Defendant responded "no" to both questions. (N.T., p. 9). Following the responses, Trooper Williams told Defendant he would be right back. (N.T., p. 9). Defendant then went back inside his residence and Trooper Williams returned to his patrol vehicle. (N.T., p. 9). While inside his vehicle, Trooper Williams contacted Officer LeCadre. Trooper Williams informed Officer LeCadre that Defendant was unable or unwilling to call him or to meet in person. (N.T., p. 10). Officer LeCadre agreed that it would be sufficient for him to speak with Defendant over Trooper Williams' phone. (N.T., p. 10).

Trooper Williams returned to the residence and knocked on the door. (N.T., p. 10). Defendant again opened the door. (N.T. p. 31). Defendant acknowledged that he could have refrained from answering the door, closed the door, or gone back inside. (N.T. p. 35). However, Defendant came outside and spoke to Officer LeCadre on the speakerphone over Trooper Williams' phone. (N.T., p. 10). Trooper Williams held his phone. (N.T. p. 15). Trooper Williams heard Officer LeCadre tell Defendant that he was not under arrest. (N.T., p. 16). Trooper Williams and Defendant stood on the front porch during the conversation. (N.T. p. 10).

While responding to Officer LeCadre's questions, Defendant told Officer LeCadre that he was involved in an accident at the location in question and that following the accident, did not remain at the scene. (N.T., p. 23-24). Defendant indicated that after the accident occurred, a friend who was also in the car, took over driving and drove the car away from the scene. (N.T., 23-24). Officer LeCadre stated that Defendant never acknowledged that he was the driver when the accident occurred. (N.T., p. 24). Following the phone conversation,

Officer LeCadre informed Defendant that he would receive a summons in the mail regarding the incident. (N.T., p. 24-25).

Defendant acknowledged that he could have hung up the phone while speaking with Officer LeCadre. (N.T. p. 35). From the location where he spoke on the phone, Defendant could easily access his residence. (N.T. pp. 10-11). Defendant testified that he was made to feel that he must speak with Officer LeCadre. (N.T. p. 27).

DISCUSSION

No custodial interrogation occurred which required that officers to give Defendant Miranda rights where Defendant could not reasonably believe that police restricted his freedom of action.

The test for whether an individual is in custodial interrogation which requires police to give Miranda warnings focuses on whether the individual being interrogated reasonably believes his freedom of action is being restricted. *Com. v. Brown*, 473 Pa. 562, 570 (1977). Custodial interrogation does not require that the police make a formal arrest, nor does it require that the police intend to make an arrest. *Id.* An officer's unarticulated plan has no bearing on the question of whether the individual was in custody. *Berkemer v. McCarty*, 468 U.S. 420, 421 (1984). The only relevant inquiry is "how a reasonable man in the suspect's position would have understood his situation." *Id.* at 422. The standard is an objective one, not subjective.

Applying this objective standard to the facts of the instant case, we find that a reasonable person in Defendant's position would understand that he could terminate his interaction with Officer LeCadre and Trooper Williams. Defendant voluntarily answered the door when Trooper Williams first knocked on Defendant's front door. When Trooper Williams asked Defendant about calling Officer LeCadre or speaking to him in person, Defendant responded "no" to both questions. After Trooper Williams told Defendant "he'll be right back" and returned to his patrol vehicle, Defendant returned to the inside of his home. At each point of contact, Defendant retained the ability to either refrain from or cease the interaction. Nevertheless, Defendant chose to answer the door twice and speak to Officer LeCadre over a speaker phone, which conversation he could have ended.

We find Defendant's reliance upon *Commonwealth v. Zogby*, 689 A.2d 280 (1997) unpersuasive as the facts are distinguishable. There, the Superior Court held that defendant was subjected to custodial interrogation where a trooper went to the defendant's house, was admitted into the house by a roommate, and aroused the defendant by shaking him. The trooper instructed the defendant to dress to discuss a hit and run incident. *Id.* at 623. After he dressed, the defendant made incriminating statements to the trooper. *Id.* The Superior Court concluded that by entering an area of privacy in defendant's home, rousing him from sleep, and telling him to dress to be questioned, the defendant could reasonably feel he had no choice but to follow the officer's order. *Id.* at 626.

Here, the testimony supports the conclusion that Defendant could not reasonably conclude that he lacked a choice but to speak with the officers. Rather, Defendant had unfettered opportunity refuse to do so.

Accordingly, we enter the following:

ORDER

AND NOW, this 26th day of June, 2024, it is hereby ORDERED that:

Defendants Ominibus Pre-Trial Motion to Suppress is DENIED.
