Seiffert v. Whitfeld, et al.

Motion to compel independent medical examination – 100 mile radius – Traveling costs

- 1. Pa.R.Civ.P. 4010 governs a party's right to require a party to attend an independent medical examination (IME) when the mental or physical condition of a party is in controversy; the court may order the party to submit to a physical or mental examination on motion for good cause shown and shall specify the time, place, manner, conditions and scope of the examination.
- 2. The rule is silent on which party bears the cost for traveling to an IME.
- 3. As to depositions, Pa.R.Civ.P. 4008 provides if a deposition is to be taken more than one hundred miles from the courthouse, the court, upon motion, may make an order requiring the payment of reasonable expenses, including attorney's fees, as the court shall deem proper.
- 4. Pa.R.C.P. 4011(b) provides that no discovery shall be permitted which would cause unreasonable expense to a party.
- 5. Payment for expenses to attend an IME should not be required where a distance of less than 100 miles is involved.
- 6. Based upon the foregoing, the Court <u>Held</u> (a) Defendants may elect to require Plaintiff to attend an IME within 100 miles of Plaintiff's home residence in Florida without having to pay for Plaintiff's costs; (b) Defendants may elect to require Plaintiff to attend an IME with a physician in Pennsylvania and pay for Plaintiff's reasonable costs for flights, hotel, and car rental; (c) Defendants may elect to require Plaintiff to attend an IME in Pennsylvania on the day before trial without having to pay for Plaintiff's costs; and (d) Defendants may otherwise elect to require Plaintiff to attend an IME in Pennsylvania on a day that Plaintiff is visiting Pennsylvania without having to pay for Plaintiff's costs.

ORDER and MEMORANDUM

AND NOW, this 16th day of May, 2024, upon consideration of Defendants' Motion to Compel Independent Medical Examination¹ filed March 13, 2024, Plaintiff's response thereto, and oral argument on May 13, 2024, for the reasons set forth in the accompanying Memorandum it is hereby **ORDERED** as follows:

- Defendants may elect to require Plaintiff to attend an IME within 100 miles of Plaintiff's home residence in Florida without having to pay for Plaintiff's costs;²
- Defendants may elect to require Plaintiff to attend an IME with Dr.
 Kelly Murray or another physician in Pennsylvania paying for Plaintiff's
 reasonable costs for flights, hotel, and car rental/taxi/uber;
- Defendants may elect to require Plaintiff to attend an IME with Dr. Kelly Murray or another physician in Pennsylvania on the day before trial without having to pay for Plaintiff's costs; and
- 4. Defendants may otherwise elect to require Plaintiff to attend an IME with Dr. Kelly Murray or another physician in Pennsylvania on a day that Plaintiff is visiting Pennsylvania without having to pay for Plaintiff's costs.³

² Should Defendants choose this option, this court would view favorably any request by Defendants for their IME physician to testify remotely at trial.

³ Plaintiff's counsel represented at the hearing that Plaintiff returned recently to Pennsylvania to see family but the dates were not conducive to Defendant's chosen physician's availability. Moreover, Plaintiff's counsel advised that Plaintiff is undergoing medical treatment and does not have plans to return to Pennsylvania in the near future; however, if that is to change, Plaintiff shall promptly notify Defendants so that they may consider this option and Plaintiff's cooperation under this option shall not be unreasonable withheld.

MEMORANDUM

Defendants Lauren Whitfield and Omar Whitfield (Defendants) seek to compel Plaintiff Stephanie Seiffert to attend an independent medical examination (IME) with Dr. Kelly Murray in Pennsylvania. Plaintiff lives in Florida and agrees to attend an IME with Dr. Murray or another physician in Pennsylvania so long as Defendants pay the expense.⁴ The issue before this court in this particular case is whether Defendants' right to require Plaintiff to attend an IME is broad enough to require Plaintiff to attend an IME pursuant to terms dictated by Defendants without consideration of the cost to Plaintiff.

The rule of civil procedure that specifically governs a party's right to require another party to attend an IME provides in relevant part as follows:

(2) When the mental or physical condition of a party, or of a person in the custody or under the legal control of a party, is in controversy, the court in which the action is pending may order the party to submit to a physical or mental examination by an examiner or to produce for examination the person in the party's custody or legal control.

. . .

(3) The order may be made only on motion for good cause shown and upon notice to the person to be examined and to all parties and shall specify the time, place, manner, conditions and scope of the examination and the person or persons by whom it is to be made.

Pa.R.Civ.P. 4010.

The rule is silent on which party bears the cost for traveling to an IME. However, caselaw provides some guidance. In Klusko v. Gaines-Murfit Chevrolet, Inc., 16 Pa. D. & C. 2d 86 (Bucks Cty. 1959), the defendant's IME was 75 miles away in another county and the plaintiff asked the court to order the defendant to pay plaintiff's travel expenses. The court noted that expense alone is not a valid objection to an IME unless it is an unreasonable expense. Id. at 88 (citing Pa.R.Civ.P. 4011(b), which provides in relevant part "no discovery . . . shall be permitted which would cause unreasonable . . . expense to the . . . party."). The Klusko court adopted the standards set by Pa.R.Civ.P. 40085 which expressly authorizes cost-shifting for depositions:

Moreover, by Pa. R. C. P. 4008, it has also provided an analogy for measuring reasonableness of expense in this connection. The latter rule authorizes the payment of expenses attendant upon the taking of oral depositions, but only if the examination occurs more than 100 miles from the courthouse. Adopting as a rule of thumb, in the interests of certainty and practicality, the 100-mile standard so enunciated, we do not believe that traveling expenses incident to the parallel discovery device of a medical examination in this age of modern transportation should be considered unreasonable if less than that distance be involved, at least in the absence of unusual circumstances which are not even hinted in these proceedings.

<u>Id.</u> at 88-89. Ultimately, the court held that payment for expenses would not be required where a distance of less than 100 miles was involved.

In <u>Jamison v. Saul</u>, 2 Pa. D & C. 3d 495 (Lehigh Cty. 1977), the court considered whether a plaintiff in Colorado could be compelled to return to Pennsylvania without payment of travel expenses for an IME. The <u>Jamison</u> court considered Rules 4008, 4010, 4011, and 4012 and ultimately held:

Similar [expense] considerations can and should guide this court in ordering wife plaintiff to submit to a physical examination pursuant to Pa. R.C[iv].P. 4010. We should not order her to submit to a pre-trial examination in Pennsylvania unless defendants agree to pay the travel and lodging expenses incidental to her coming to Pennsylvania for that purpose.

Defendants will not be prejudiced nor will their rights under Pa. R.C[iv].P. 4010 be impaired by such action. They can, if they prefer, wait until wife plaintiff comes to Pennsylvania for trial and have her examined by a physician at that time. It will undoubtedly be her physical condition at the time of trial which will be in issue, and defendants will in that event be the beneficiaries of an up-to-date report. Neither party need then incur the additional expense of a separate pre-trial trip to Pennsylvania by plaintiff for examination.

Id. at 498. Compare Meeker v. Sarris, 40 Pa. D. & C. 2d 643 (Beaver Cty. 1966) (providing that a twenty-mile distance into the City of Pittsburgh did not constitute an unreasonable expense and that Rule 4010 did not require the IME to be held in the county of plaintiff's residence or where the suit was brought); State Farm Mut. Auto. Ins. Co. v. Morris, 432 A.2d 1089 (Pa.Super. 1981) (holding that the expense to travel from Delaware County to Philadelphia for an IME was slight and the trial court was not unreasonable in requiring the plaintiff to make the trip without expense reimbursement); Christian v. Weis Mkts., Inc., 61 Pa.D&C.5th (Lackawanna Cty. 2016)

(holding that Defendant must pick a physician from Luzerne or Lackawanna County and that requiring Plaintiff to travel 126 miles to a Delaware County physician was unreasonable); <u>Judge v. Solid Waste Services</u>, <u>Inc.</u>, 41 Pa.D.&C.4th (Lackawanna Cty. 2016) (holding that, inter alia, over 100 miles for an IME was unreasonable in light of the physicians available in Lackawanna or Luzerne County); <u>Kapp v. Oasis Enterprises</u>, <u>Inc.</u>, 83 Lacka.Jur. 190 (Lackawanna Cty. 1982) (holding that a plaintiff could not be compelled to attend a Rule 4010 exam in a county approximately 100 miles outside of the forum county).

This court finds the reasoning of the <u>Klusko</u> and <u>Jamison</u> line of cases persuasive. There is no question that Defendants are entitled to an IME pursuant to Pa.R.Civ.P. 4010. Similarly, there is no question that Defendants would have Plaintiff bear the expense of travelling each way a distance much greater than 100 miles. Given the distance involved and the resulting cost and time to travel to Pennsylvania, consideration of the principles of Rule 4008, 4010, 4011, and 4012, and the availability of modern remote appearance technology, Defendants are entitled to compel Plaintiff to attend an IME pursuant to the terms and conditions set forth in this court's Order.

Accordingly, this court will enter an Order deciding Defendants Lauren and Omar Whitfield's Motion to Compel Plaintiff to Attend an Independent Medical Examination Pursuant to Pa.R.C[iv].P. 4010 consistent with the foregoing.
