E.R. Stuebner, Inc. v. West Chester Area School District

Direct damages – Consequential damages – Speculative damages – Disparity in bargaining power – Prompt Payment Act

- Generally, damages for breach of contract include the amount of money that will
 put the non-breaching party in the position it would have been in if the breach had
 not occurred. This includes not only damages that directly result from the breach,
 but also those damages that were foreseeable at the time the parties entered into
 their contract, referred to as consequential damages.
- 2. A contract does not necessarily have to identify consequential damages for such damages to be recoverable.
- 3. In a commercial setting, a contractual provision excluding liability for special, indirect, and consequential damages is generally valid and enforceable. In analyzing such a provision, courts must look to the parties involved to ensure that there is no disparity between the entities in either bargaining power or sophistication.
- 4. Damages are considered remote or speculative only if there is uncertainty concerning the identification of the existence of damages, rather than the ability to precisely calculate the amount or value of damages.
- 5. The Prompt Payment Act (PPA) governs construction projects between a government agency and a contractor, where the contract involves competitive sealed bidding or competitive sealed proposals. Absent a good faith claim, the PPA mandates payment to a contractor when the contractor performs in accordance with the provisions of the contract.
- 6. The PPA provides for an award of interest on payments not timely made; the right to seek penalties in the amount of 1% per month; costs; and reasonable attorney fee for violations of the Act. In determining whether a penalty or reasonable attorneys' fees should be awarded, a court must inquire into whether monies were withheld in bad faith.
- 7. Plaintiff, E.R. Stuebner, Inc. (ERS), signed a construction contract with West Chester Area School District ("WCASD") to perform renovations at a school. Plaintiff was the prime General Contractor and Project Coordinator; there were 4 other prime contractors. WCASD terminated Plaintiff "for cause", based chiefly on delays in producing and maintaining a construction schedule, failures that WCASD maintained were Plaintiff's sole responsibility. The court found none of ERS's work had been rejected as defective and ERS encountered several challenges and delays caused by others, including: a broken sanitary sewer line discharging raw sewage; WCASD changed the method of asbestos removal and the location of the HVAC unit; lead paint was discovered; an existing structural steel column, which was to be incorporated into the renovation, was significantly different than what had been represented; installation of new columns could not be installed as planned and designed; failures of several other prime contractors

to timely complete their scope of work; and the architect's failure to coordinate its design documents resulted in contract documents that included several errors. The Court found ERS was not responsible for the timing of the submission of the Contractors' Construction Schedule and that was not a valid reason for termination. Further, the electrical contractor, not ERS, prevented the Contractors' Construction Schedule from being submitted on time. The court also found the plumbing contractor placed defective concrete, yet was not terminated and WCASD failed to give ERS the opportunity to perform any corrective measures, as provided for in the contract. The court found WCASD knew its asserted reasons for termination were unfounded. Because WCASD refused for months to pay Plaintiff for work done, even though certified by the Architect, and WCASD's representative refused to meet and discuss the matter, the court determined WCASD engaged in arbitrary and vexatious conduct and awarded interest, penalties and attorneys' fees to ERS pursuant to the Prompt Payment Act. ERS sought to recover both direct and consequential damages. The court found there was sufficient evidence presented which identified the existence of lost profits on the part of ERS. The court found for ERS and against WCASD for damages approximating 1.8 million dollars plus interest and attorney's fees.

DECISION

Plaintiff, E.R. Stuebner, Inc., signed a construction contract to perform renovations at the East Goshen Elementary School with defendant, the West Chester Area School District ("WCASD"). The contract award amount was \$7,437,000. Plaintiff was the prime General Contractor and Project Coordinator. There were four (4) other prime contractors.

On March 26, 2019, WCASD terminated Plaintiff "for cause", based chiefly on delays in producing and maintaining a construction schedule. WCASD maintained that these failures were Plaintiff's sole responsibility. The court finds this not to be so and that WCASD knew its asserted reasons were unfounded.

Moreover, because WCASD refused for months to pay Plaintiff for work done, even though certified by the Architect, and its representative on the job refused to meet and discuss the matter, the court, in the sound exercise of its discretion and after a two-week bench trial, determines WCASD engaged in arbitrary and vexatious conduct and awards interest, penalties and attorneys' fees to Plaintiff, E.R. Stuebner, Inc., pursuant to the Prompt Payment Act.

The court makes the following:

FINDINGS OF FACT

I. The Contracted Project

- 1. On April 25, 2018, WCASD entered into a contract with E.R. Stuebner, Inc. ("ERS") (the "Contract") for the renovations and additions to East Goshen Elementary School (the "School").
- 2. The work involved the construction of an approximately 22,798 square foot two-story addition to the School comprised of 16 classrooms, a storage room, and a mechanical room. Also included in the scope of work were renovations to the existing school building (the "Project").

- 3. The Contract amount was \$7,437,000.
- 4. WCASD previously contracted with Blackney Hayes Architects ("BHA") in August, 2016 to serve as the Architect for the Project. BHA was tasked with preparing plans and specifications for the Project.
- 5. The Contract identified Kevin Campbell, Director of Facilities and Operations for WCASD, to serve as WCASD's representative for the Project.
- 6. In addition to ERS, WCASD retained four (4) other prime contractors for the following scopes of work: Clinger Electric as the Electrical Contractor, JR Reynolds as the Plumbing Contractor, JBM Mechanical as the HVAC Contractor and Sargent Enterprises as the Asbestos Abatement Contractor.
- 7. WCASD entered into separate contracts with each contractor for work at the Project.
 - 8. ERS was not a party to any of the other prime contracts.
- 9. The terms and conditions of each of the five (5) prime contracts were identical, differing only as to scope of work and price.
- 10. The Contract included numerous documents, which together constituted the "Contract Documents."
- 11. The plans and specifications for the Project, as well as the general conditions, were contained therein.
- 12. The Contract stated that construction would commence on June 20, 2018, and that Substantial Completion was to be achieved by August 15, 2020.
 - 13. Work under the Contract was to be performed in five (5) phases.
- 14. Each of the five (5) phases required work in multiple areas of the building; these areas were assigned letters A–E.
 - 15. Each phase had its own Substantial Completion date.
- 16. The start date, finish date and the duration for each of the five (5) phases, as well as the entire Project, were identified in the Contract as follows:

17. Other than the Substantial Completion Dates for the above phases, the Contract did not define any other dates or deadlines that the prime contractors were required to meet.

II. Termination of the Contract

- 18. WCASD first met to consider terminating ERS's Contract on January 28, 2019.
 - 19. A draft termination letter was produced and circulated on February 27, 2019.
- 20. ERS was never informed at that time that WCASD was considering terminating the Contract.
- 21. WCASD transmitted a letter to ERS on March 26, 2019 signed by Kevin Campbell terminating ERS's Contract. ("the Termination Letter")
- 22. According to the Termination Letter, WCASD terminated ERS for cause pursuant to Article 14.2.1 of the Contract.
 - 23. The Contract permitted "for cause" termination as follows:

§ 14.2 TERMINATION BY THE OWNER FOR CAUSE

- § 14.2.1 The Owner may terminate the Contract if the Contractor
- 1.repeatedly refuses or fails to supply enough properly skilled workers or proper materials; materials, or to increase working hours, or to increase the number of working days per week in order to keep up with the Contractors' Construction Schedule:
- 2.fails to make payment to Subcontractors for materials or labor in accordance with the respective agreements between the Contractor and the Subcontractors;
- 3. **repeatedly** disregards applicable laws, statutes, ordinances, codes, rules and regulations, or lawful orders of a public authority; or
- 4.otherwise is guilty of substantial breach of a provision of the Contract Documents. Documents:
- 5.if the Contractor is adjudged bankrupt or files for bankruptcy or credit protection under the laws of this United States. Contractor shall provide Owner thirty (30) days written notice before filing.
- 24. According to WCASD, the following grounds justified termination:
 - Failure to provide a submittal schedule within 15 days of receiving the executed Contract
 - Failure to submit a schedule within 45 days of Contract award
 - Failure to increase manpower and working hours to meet "deadlines"
 - Failure to properly update the schedule
 - Failure to meet Phase 1A and Phase 1B deadlines
 - Performing the following work that was "defective":
 - o Items listed on the Phase 1A punchlist
 - o Installing concrete infills in Phase 1A that did not achieve

- 3,500 psi compressive strength
- o Installing concrete on the 2nd floor that exceeded 3,500 psi
- o Portions of concrete slabs installed on 2nd floor that needed leveling
- 25. Prior to termination, neither WCASD nor BHA analyzed the Project schedule to determine the cause of any delays.
 - 26. None of ERS's work had been rejected as "defective."

III. Purported Grounds for Termination

A. Submittal Schedule Within 15 Days

- 27. The Termination Letter first alleged that ERS breached the Contract by failing to submit a schedule within fifteen (15) days of the Notice to Proceed as required in the Contract at Section 310.2.
- 28. WCASD's Architect held a pre-construction meeting on May 4, 2018. Representatives of each of the five (5) prime contractors attended the meeting.
- 29. The written minutes from that meeting which were prepared by the Architect reiterate that a submittal schedule was due fifteen (15) days from the issuance of the Notice to Proceed.
- 30. The Notice to Proceed was issued on May 17, 2018; a submittal schedule was thus due by June 1, 2018.
- 31. On May 25, 2018, eight (8) days following the Notice to Proceed, ERS provided its submittal schedule to the Architect.
- 32. Neither WCASD or the Architect (or anyone else) informed ERS that the submittal schedule was insufficient in any manner, untimely or failed to comply with the Contract's requirements.
- 33. As of June 6, 2018, ERS was the only prime contractor to have provided a submittal schedule.

B. Submittal Schedule within 45 Days

- 34. The Termination Letter also alleged that ERS breached the Contract by failing to submit a construction schedule within forty-five (45) days of Contract Award, which was April 25, 2018.
- 35. The detailed process and the requirements for preparation of the construction schedule are set forth in the Contract at Section 3.10 entitled "Construction Progress Schedule."
- 36. Pursuant to Section 3.10.1. of the Contract, each prime contractor was to provide a list of its work activities and the durations for each to ERS within twenty-one

- (21) days of Contract Award.
- 37. As the Project Coordinator, ERS then was to incorporate the other prime contractor activities into a baseline schedule (the "Contractors' Construction Schedule"), to be submitted to WCASD and the Architect within forty-five (45) days of Contract Award date, in accordance with Section 3.10.1.2.
- 38. The Contractors' Construction Schedule was to break out activities both by phase and area.
 - 39. The maximum duration for any activity was ten (10) days.
- 40. The Contract required ERS to employ a professional scheduler with offices located within fifty (50) miles of the job site. ERS engaged Trauner Consulting Services, a professional scheduling firm in Philadelphia.
- 41. The Contract stated that requests for payments by the prime contractors would not be processed or paid until the Contractors' Construction Schedule was (1) in place and (2) approved by WCASD and the Architect.
- 42. The Contract also required the prime contractors to periodically update the Contractors' Construction Schedule.
- 43. Requests for payment would not be processed until schedule updates had been submitted.
- 44. As required, ERS requested each prime contractor to provide ERS with its activities, broken out by phase and area.
- 45. As of May 29, 2018, none of the other prime contractors had provided scheduling information to ERS.
- 46. ERS did not receive the required information from the electrical contractor (EC), William H. Clinger Corporation ("Clinger").
- 47. Sargent Enterprises, the asbestos contractor, was unable or failed to provide information to ERS in a timely manner.
- 48. Three (3) payment applications were submitted by ERS. Each was reviewed by the Architect and the Architect certified each of them, affixing the following statement next to the signatures:

In accordance with the Contract Documents, based on on-site observations and the data comprising the application, the Architect certifies to the Owner that to the best of the Architect's knowledge, information and belief the Work has progressed as indicated, the quality of the work is in accordance with the Contract Documents, and the Contractor is entitled to payment of the AMOUNT CERTIFIED.

- 49. Payments under the Contract were due thirty (30) days following submission of the request for payment.
 - 50. WCASD nonetheless withheld three (3) payments from ERS in the total

amount of \$1,103,437.64 for the months of July, August and September 2018 because ERS had not provided a Contractors' Construction Schedule.

- 51. WCASD knew that the electrical contractor, Clinger, had not provided ERS with the required scheduling information.
- 52. ERS requested that WCASD invoke its contractual mechanisms to compel Clinger's compliance with its scheduling obligations.
- 53. In response, WCASD advised ERS that it would not be paid until it presented a schedule signed and accepted by all prime contractors.
 - 54. WCASD did not withhold payment from any other prime contractors in 2018.
- 55. WCASD paid Clinger, in most instances, a short time after it submitted a request for payment.
- 56. WCASD blamed ERS for the scheduling issues and joked internally about how ERS must be "hurting for money."
- 57. When ERS requested a meeting with WCASD's representative, Kevin Campbell, to discuss the schedule challenges and payment, the latter refused to meet.
- 58. Campbell told ERS to file legal papers to which WCASD's attorneys would respond and said that he considered ERS's inquiries "harassment."
- 59. In an effort to move forward, ERS's scheduling consultant, Trauner, repeatedly prepared and circulated draft schedules that accounted for the electrical activities.
- 60. The schedules included assumptions and durations that were appropriate given the other work that needed to be completed by phase and area within the time allotted.
- 61. On October 26, 2018, Clinger finally submitted its schedule and apologized for its previous delays.
- 62. ERS thereafter provided the Contractors' Construction Schedule to which all prime contractors had agreed to WCASD and requested that WCASD release the withheld payments.
 - 63. WCASD refused to release payment.
- 64. Instead, WCASD's Capital Projects Manager, Mark Groves, added dozens of discrete activities to the schedule, insisted that his additions be incorporated into the schedule and demanded a revised schedule be resubmitted to WCASD for additional review.
- 65. In response, ERS requested that the other prime contractors promptly review WCASD's changes to the schedule.
- 66. On December 17, 2018, ERS submitted a revised Contractors' Construction Schedule signed by each prime contractor and incorporating WCASD's changes to WCASD.
- 67. Almost a month later, on January 8, 2019, WCSD notified ERS that the Contractors' Construction Schedule was unacceptable.
- 68. By this point, construction work had been ongoing at the Project for seven (7) months.
 - 69. ERS again undertook to update the schedule. It circulated updates in mid-

February 2019 and mid-March 2019 to the other primes prior to its termination.

C. Phase 1A Deadlines and Additional Delays

- 70. WCASD's Termination Letter also alleged that ERS failed to meet Phase 1A deadlines.
- 71. The Contract defines Substantial Completion as the "stage in the progress of the Work when the Work, or designated portion thereof, is sufficiently complete in accordance with the Contract Documents so that the Owner can occupy in an acceptable condition or utilize the Work for its intended use."
- 72. After entering into the Contract, WCASD changed the method by which asbestos in Area C which was part of Phase 1A would be removed.
- 73. The Contract originally called for removal of the asbestos in Area C via non-friable chemical or dry-ice means.
- 74. WCASD later believed that the planned chemical means of removal might not remove all of the asbestos in the tile mastic (adhesive).
- 75. WCASD then changed the method of asbestos removal of the floor tile mastic in Area C to shotblasting.
- 76. The shotblasting process makes the asbestos friable and therefore requires critical barriers, also known as full containment, to be put in place.
- 77. This change in process was not disclosed to ERS or any other contractors before they submitted bids to perform the work. They were unaware that Area C would be shut down to all work while asbestos was removed.
- 78. The abatement contractor was not permitted by law to start asbestos removal until June 25, 2018, at the earliest.
- 79. Because of the change to shotblasting, most of Area C was completely blocked off (full containment) between June 29 and July 11, 2018.
- 80. During those two (2) weeks, no work could be performed by anyone other than the asbestos contractor, Sargent.
- 81. Specifically, J.R. Reynolds, the plumbing contractor, had to wait to begin in its scope of work, which included demolishing concrete floors in the corridor and bathroom areas to make way for extensive underslab sanitary waste piping.
- 82. Although anticipated to be completed by July 24, 2018, this work was not completed until August 1, 2018.
- 83. Only then could ERS finally begin building interior walls to partition the spaces into separate rooms and bathrooms.
- 84. On August 2, 2018, less than two (2) weeks before the scheduled Substantial Completion date, lead paint was discovered on several steel beams in Area C.
 - 85. This caused additional delay.
- 86. The original design called for new structural steel to be hot welded to existing steel beams in order to support a rooftop air conditioning and heating unit.

- 87. WCASD and the Architect decided on August 2, 2018 that the new steel supports could not be attached to the contaminated beams because doing so would vaporize the lead paint, render it airborne and create a serious health and safety violation.
- 88. The Architect and WCASD chose to move the HVAC unit to another location in Area C along with the steel supports.
- 89. This design change required removal of the HVAC piping and ductwork and electrical wiring that had been installed in accordance with the original design and reinstallation in the new location.
- 90. WCASD issued change orders to its electrical and mechanical contractors reflecting the additional cost for the redesign.
- 91. The HVAC system was not moved to the new location until August 16, 2018. It began functioning on August 26, 2018, which was after the August 15, 2018 Substantial Completion Date for Phase 1A.
- 92. Toward the middle to end of August 2018, WCASD's representatives complained that two (2) components, a CMU block and the ceiling grid, for which ERS was responsible, were behind schedule.
- 93. ERS, however, could not install interior CMU walls until the plumbing contractor reinstalled the concrete floor. This occurred on August 1, 2018.
- 94. ERS could not complete the install of the suspended ceiling grid and ceiling tiles until WCASD's electrical, plumbing and mechanical contractors installed their piping, wiring, ductwork and equipment above the ceiling.
- 95. As of August 25, 2018, the ceiling work by the other contractors was still not complete.
 - 96. ERS encountered other conditions that resulted in delays to its work.
- 97. Part of ERS's work in Phase 1A involved demolishing an existing classroom wing in Area B and installing two large steel columns both of which were approximately 30 feet high to support a new two-story addition.
- 98. As ERS was demolishing the existing classroom wing, it discovered that the existing structural steel column, which was to be incorporated into the new section, was significantly different than what was shown on the Contract Drawings.
 - 99. ERS immediately notified WCASD and the Architect of the discovery.
- 100. The Architect and its structural engineer inspected the condition and subsequently issued and then revised several engineering sketches.
- 101.Demolition in the area of the Gym Lobby and the portion of the existing classroom wing adjacent thereto had to be halted while the Architect and its structural engineering consultant revised the design.
- 102. Absent instruction from WCASD and its Architect on how to address the condition, ERS installed temporary support columns on October 3, 2018.
- 103. With the temporary support columns installed, ERS resumed demolition in the same vicinity.

- 104. The issue was not resolved until June 2019, after ERS had been terminated.
- 105.ERS encountered several other challenges and delays. It later uncovered a broken sanitary sewer line that was discharging raw sewage into the excavation area for the new two-story section.
- 106.Once again, an unanticipated issue had to be resolved by the Architect and the civil engineering consultant.
- 107.Repairs of the sewer line were completed by the plumbing contractor on October 10, 2018. Only then could work continue on the foundation.
- 108. During installation of new columns and footings for the addition, ERS realized that the columns could not be installed as planned and designed because they would hit existing steel structures that were to remain in place.
- 109.ERS again had to notify the Architect and await instructions on moving or modifying the columns, both of which were approximately 30 feet in height.
- 110. The Architect did not provide all of the information necessary to enable ERS to fabricate, deliver and install the columns (and the footings for the columns) at the new locations until December 19, 2018. At that point, ERS could then order the columns.
- 111. WCASD, however, would not allow ERS to install the columns until President's Day weekend in February, 2019. It advised ERS that it could not crane them into place while school was in session.
- 112. After the columns were installed, ERS then proceeded with work on the second-floor addition to the Gym Lobby.
- 113. The drawings called for the installation of a concrete pour stop and brick support angle for this particular work. The pour stop, an angled piece of steel around the perimeter of the concrete floor used to contain concrete poured on top of metal decking, would constitute the subfloor of the second-floor addition above the Gym Lobby in Area B.
- 114. The location of the concrete pour stop and brick support angle as designed by the Architect did not line up with the exterior wall.
- 115.ERS brought this issue to WCASD and Architect's attention on March 1, 2019.
- 116. This design issue prevented ERS from completing the concrete slab on deck for the second-floor addition, completing the exterior CMU wall installation, installing the exterior brick, completing the roof for the new addition, drying in the building and performing all the interior work that followed.
- 117. The Architect issued revised instructions to modify the pour stop and the brick support angle at this location, but it did not authorize ERS to proceed with this work until March 22, 2019, just four days before WCASD terminated ERS's Contract for alleged delays.
