SUMMARY OF OPINION:

In this malpractice action asserting negligence by various health care providers that caused the minor-plaintiff to develop catastrophic brain injuries and neurological damage during her birth in 2006, plaintiff conducted the discovery deposition of the labor and delivery nurse who is a named defendant. After that nurse had demonstrated current understanding of reassuring and nonreassuring signs on fetal monitoring strips and defined “tachycardia,” “variable,” “late,” “deep” and “prolonged” decelerations, and “absent,” “minimum,” “moderate” and “marked” variability, plaintiff’s counsel displayed the fetal monitoring strips to the nurse and attempted to question her regarding any reassuring and nonreassuring findings on those strips. Following suggestive interjections by her counsel, the nurse, who had worked as a labor and delivery nurse for almost 40 years until her retirement in 2008, stated “I don’t know . . . that I would be able to interpret it satisfactorily.” When plaintiff’s counsel attempted to explore the nurse’s current ability to review and comprehend the strips, her counsel objected and instructed the nurse not to answer questions concerning any fetal monitoring strips, thereby precipitating plaintiff’s discovery motion seeking (a) to compel the nurse to answer those inquiries and (b) to impose monetary sanctions upon her for requiring plaintiff to file a discovery motion.

Plaintiff was entitled to probe the legitimacy and extent of any claimed incompetency by the nurse regarding her ability to read or understand the fetal monitoring strips, and the jury would ultimately determine the believability of any claim by her that she is no longer capable of reading the numeric grids on the strips that are used to record the fetal heart rate, uterine activity, and their duration. Counsel for a deponent may direct the witness not to answer a specific question only if that instruction is necessary to (a) protect a recognized privilege, (b) enforce an evidentiary limitation established by an earlier court ruling in the case or (c) present a motion for a protective order based upon grounds identified in Pa.R.Civ.P 4012(a). Since the instruction not to answer plaintiff’s proposed inquiries in this case was not based upon one of those legitimate reasons, plaintiff was entitled under Rule 4019(a)(viii) and (g)(1) to be reimbursed for the counsel fees incurred in preparing and presenting this discovery motion. Consequently, the nurse was directed to submit to an additional deposition in order to answer questions concerning her interpretation of the fetal monitoring strips and her present ability to do so, and was further required to reimburse plaintiff for the counsel fees incurred in connection with plaintiff’s discovery motion.

SUMMARY OF OPINION:

Plaintiffs filed a motion *in limine* seeking to preclude any evidence of their witness's conviction for cyberstalking, 18 U.S.C. § 2261A(2)(B), on the basis that it was inadmissible under Pa.R.E. 609(a) since it is not a *crimen falsi* crime. Rule 609 permits a witness to be questioned regarding a criminal conviction provided that it is a *crimen falsi* offense that involved dishonesty or false statement. In determining whether a particular offense is *crimen falsi* under Rule 609, the court must conduct the following two-step analysis: first, it must examine the essential elements of the offense to determine if the crime is inherently *crimen falsi* since dishonesty or false statement was a necessary prerequisite to the commission of the crime; and, second, if the crime is not inherently *crimen falsi*, the court must consider the underlying facts that led to the conviction to determine if dishonesty or false statement facilitated the commission of the crime.

The federal cyberstalking statute makes it unlawful for a person, with the intent to kill, injure, harass, intimidate, or place under surveillance with the intent to kill, injure harass, or intimidate, to use any interactive computer service or electronic communication service or system to engage in a course of conduct that causes, attempts to cause, or would be reasonably expected to cause substantial emotional distress to another person. The witness's cyberstalking conviction was not inherently *crimen falsi* since neither dishonesty nor a false statement was an essential and stated element of that crime.

However, the underlying facts supporting his conviction reflected that dishonesty and falsehood facilitated his commission of that crime. The witness admitted that "he published 'false negative reviews of the victim's work performance,' used a 'call/texting spoofing device to contact the victim,' ordered 'two GPS tracking devices for placement on the victim's motor vehicle,' tracked 'the victim's movements with his iPad,' and 'physically followed [the victim]'" His negative publications concerning the victim's work performance, were replete with falsities. "Spoofing" refers to the deliberate falsification of caller identification information in order to disguise the caller's identity. Thus, in committing his cyberstalking offense, the witness employed dishonesty by using the spoofing application to deliberately falsify his identification information in order to enable him to harass and intimidate the victim. Accordingly, inasmuch as the underlying facts sustaining the witness's conviction support its classification as a *crimen falsi* offense for purposes of Pa.R.E. 609(a), plaintiffs' motion *in limine* was denied.
