NOTICE TO PROSPECTIVE TAX SALE BIDDERS

PROSPECTIVE BIDDERS AT ALL TAX SALES ARE REQUIRED TO PROVIDE A NOTARIZED AFFIDAVIT CERTIFYING TO THE TAX CLAIM BUREAU THE FOLLOWING:

1. Within any municipal jurisdiction, such bidder is not delinquent in paying real estate taxes owed to taxing bodies within the Commonwealth of Pennsylvania and is not delinquent in paying municipal utility bills owed to the municipalities within the Commonwealth of Pennsylvania.

2. The bidder is not the owner of any property being exposed at the upset tax sale, and is not a partner or shareholder of the owner of any property, nor in any of the following legal relationships with the owner: trust, partnership, limited partnership, corporation or any other business association.

3. No individual whose landlord license has been revoked in a municipality, pursuant to its ordinance, may purchase property in the county in which the local municipality is located at a tax sale.

Therefore, the bidder must certify they are not bidding for, or acting as an agent for, a person who is a barred landlord.

4. The bidder shall acknowledge they have read the conditions of sale governing the sale of properties by the Carbon County Tax Claim Bureau.

Prospective bidders must appear at the Bureau to register for the sale and provide a notarized affidavit (per bidder) no later than Tuesday, September 14th, 2021. A \$25.00 registration fee will be charged per registration form. Registration forms will not be accepted after this date. All upset sale documents, including this sale list, are available on the County's website at www.carboncounty.com, click departments, then Tax Claim Bureau.

It is strongly urged that prospective purchasers have an examination made of the title to any property in which they may be interested.
