Jason Krasley with information that the co-defendant, Raymond Clavell, was selling large quantities of heroin out of Room 267 at the Scottish Inn on Catasauqua Road in Allentown, Lehigh County. The CI further stated that Clavell was at the hotel with another Hispanic male; however, no additional information was provided about the other individual. Police were familiar with Clavell, having made two controlled purchases of heroin from him in the past utilizing other confidential informants.

On December 9, 2015, Krasley and other vice detectives, as well as members of the Pennsylvania State Police and Lehigh County Drug Task Force, set up surveillance at the Scottish Inn. Krasley saw Clavell's green Infiniti, which was used in one of the previous controlled buys, in the parking lot of the hotel. After approximately 20-30 minutes, Krasley observed Clavell exit the hotel from a common stairwell door. Clavell entered the Infiniti, started the engine, and then returned to the hotel. After another 10 minutes, Krasley observed Clavell exit the same door with another male, later identified as the defendant, Joseph Rodriguez-Valcarcel. Both men were carrying items in their hands—laundry and boxes-which they placed in the backseat of the vehicle. Clavell then got into the driver's seat of the vehicle and closed the door. Clavell was observed moving some items around in the vehicle. Rodriguez-Valcarcel was observed with boxes in his hands as he got into the front passenger seat of the vehicle. As officers approached, Rodriguez-Valcarcel sat down, but did not get the door closed. Krasley observed two boxes, approximately 6-8 inches by 4-5 inches, on Rodriguez-Valcarcel's lap. Based on his experience, Krasley knew these types of boxes to hold wax glassine bags used in the packaging of heroin.

Krasley leaned into the car and told Clavell to turn off the engine. Clavell put the car in reverse, looked around, put the car in park, and then ran from police. Clavell ran into a guard wire, fell to the ground, and was taken into custody by other officers. Clavell was searched and found to have 28 grams of suspected crack cocaine, \$242.00 in U.S. Currency, a room key for Room 267, and a Pennsylvania ID for Joshua Rivera.² Meanwhile, Krasley grabbed Rodriguez-Valcarcel's right wrist, took him out of the

²Police later learned the room at the Scottish Inn was rented under this name.

vehicle, and placed him in custody. Krasley observed the two small boxes on the passenger seat. Krasley testified he did not know whether Rodriguez-Valcarcel moved the boxes with this left hand or whether they fell onto the seat when he was removed from the car. Both men were *Mirandized* and spoke with detectives. Rodriguez-Valcarcel told police the vehicle belonged to Clavell. Clavell told police that there were no drugs in the hotel or the vehicle. Clavell consented to a search of his vehicle. Inside the two small boxes were glassine wax bags containing suspected heroin, which field-tested positive for heroin. Between the two boxes, there were 580 bags in bundles of 10 bags. No contraband was found on Rodriguez-Valcarcel's person.

DISCUSSION

Motion for Writ of Habeas Corpus

The defendant alleges the Commonwealth failed to establish a prima facie case for the crimes charged; specifically, that the Commonwealth failed to present evidence that the defendant constructively possessed the heroin. I cannot agree.

The court's sole determination during a habeas hearing is to determine if the Commonwealth has set forth a prima facie case with respect to each element of the crimes charged. Commonwealth v. Miller, 810 A.2d 178, 180 (Pa. Super. 2002). A prima facie case consists of evidence, read in the light most favorable to the Commonwealth, which establishes that a crime has been committed and that the defendant is probably the one that committed the crime. Id. In other words, the Commonwealth must produce evidence that, if accepted as true, would warrant the case going to a jury. Commonwealth v. Austin, 394 Pa. Superior Ct. 146, 151, 575 A.2d 141, 143 (1990); Miller, supra. This does not require the Commonwealth to prove guilt beyond a reasonable doubt nor to show that evidence is available for trial to prove guilt beyond a reasonable doubt. Austin, supra. Credibility is not at issue when deciding a motion to dismiss. Liciaga v. Court of Common Pleas of Lehigh County, 523 Pa. 258, 566 A.2d 246 (1989).

For possessory crimes, the Commonwealth must prove possession through actual or constructive possession. Constructive possession is the ability and intent to exercise conscious control or dominion over the item, and the intent to control may be inferred from the totality of the circumstances. Commonwealth v. Sanes, 955 A.2d 369 (Pa. Super. 2008). Circumstantial evidence may be used to establish possession. Commonwealth v. Carroll, 510 Pa. 299, 301, 507 A.2d 819, 820 (1986).

Looking at the totality of the circumstances, *read in the light most favorable to the Commonwealth*, the evidence showed that the defendant constructively possessed the heroin. There was certainly circumstantial evidence, including Detective Krasley's observations and the location of the boxes of heroin, to establish that the defendant had the ability and intent to exercise control over the boxes. While this court makes no opinion on the prospects for conviction at trial, I find the Commonwealth has presented sufficient evidence at this point to establish a prima facie case for the crimes charged.

Motion to Suppress

The defendant alleges his arrest was without reasonable suspicion or probable cause, and asks that all the evidence be suppressed. I find the defendant's claim to be without merit.

A police officer may make a warrantless arrest where he has probable cause to believe that a felony has been committed and that the person to be arrested is the felon. Commonwealth v. Jackson, 450 Pa. 113, 116, 299 A.2d 213, 214 (1973). "Probable cause exists where the facts and circumstances within the officers' knowledge are sufficient to warrant a person of reasonable caution in the belief that an offense has been or is being committed." Commonwealth v. Luv, 557 Pa. 570, 575, 735 A.2d 87, 90 (1999) (quoting Commonwealth v. Gibson, 536 Pa. 123, 638 A.2d 203, 206 (1994)). When determining whether probable cause exists, a court must view the evidence through eyes of a trained police officer. Commonwealth v. Nobalez, 805 A.2d 598, 600 (Pa. Super. 2002), appeal denied, 575 Pa. 692, 835 A.2d 709 (2003)). Probable cause determinations are based on the totality of the circumstances. Id. It is only the probability, and not a *prima facie* showing, of criminal activity that is the standard of probable cause for a warrantless

arrest. "Probable cause exists when criminality is one reasonable inference; it need not be the only, or even the most likely, inference." Commonwealth v. Quiles, 422 Pa. Superior Ct. 153, 167, 619 A.2d 291, 298 (1993) (citations omitted).

Finally, information received from a confidential informant may form the basis for a finding of probable cause. Luv, supra at 576, 735 A.2d at 90. "An informant's tip may constitute probable cause where police independently corroborate the tip, or where the informant has provided accurate information of criminal activity in the past, or where the informant himself participated in the criminal activity." *Id.* When the information is provided by a known informant, there is a strong case for acting upon the information. Commonwealth v. Kondash, 808 A.2d 943, 946 (Pa. Super. 2002). "One reason for crediting the known informant's information with more reliability is that the known informant, unlike the anonymous one, faces risk of prosecution for filing a false claim should the information be untrue." *Id.* at 947.

Here, a known CI, who had provided reliable information in the past, provided information to Detective Krasley about Clavell that they were able to corroborate. The CI provided the location where Clavell and an unidentified Hispanic male would be located. The police observed Clavell's vehicle, which Krasley knew from a previous controlled purchase, at that location and then observed Clavell and Rodriguez-Valcarcel, a Hispanic male, leaving that location with various boxes in their hands. Detective Krasley was familiar with Clavell based on two previous controlled buys of heroin from Clavell. Finally, as Krasley was approaching Clavell's vehicle, he observed—in plain view on the defendant's lap—two boxes that, in his experience, he knew held was glassine bags used in the packaging of heroin.

I find the trained, experienced police officers, in the totality of circumstances, had sufficient evidence to warrant a person of reasonable caution in the belief that it was probable that the defendant was engaged in criminal activity, and were justified in arresting him without a warrant. As such, the defendant's motion to suppress must be denied.

Motion to Produce Confidential Informant

Finally, the defendant asks the court to compel the Commonwealth to disclose the identity of the confidential informant. I find the defendant has failed to meet his burden, and thus disclosure is not warranted.

Pennsylvania courts recognize the Commonwealth's qualified privilege not to disclose a confidential informant's identity. Commonwealth v. Washington, 438 Pa. Superior Ct. 131, 651 A.2d 1127 (1994). "[B]efore an informant's identity may be revealed, the defendant must establish ... that the information sought is material to the preparation of the defense and that the request is reasonable." Commonwealth v. Bing, 551 Pa. 659, 664, 713 A.2d 56, 58 (1998). "[M]ore is necessary than a mere assertion by the defendant that such disclosure might be helpful in establishing a particular defense. ... "Washington, supra at 140, 651 A.2d at 1132 (quoting Commonwealth v. Herron, 475 Pa. 461, 466-67, 380 A.2d 1228, 1230 (1977)). "The defendant need not predict exactly what the informant will say, but he must demonstrate a reasonable possibility the informant could give evidence that would exonerate him." Commonwealth v. Belenky, 777 A.2d 483, 488 (Pa. Super. 2001).

If the defendant makes this initial showing, a court must then balance "the public interest in protecting the flow of information against the individual's right to prepare his defense" before determining whether the identity must be revealed. Bing, supra at 663, 713 A.2d at 58 (citing Commonwealth v. Carter, 427 Pa. 53, 59, 233 A.2d 284, 287 (1967)). "[T]he safety of the confidential informant is a controlling factor in determining whether to reveal his identity." Id. at 664, 713 A.2d at 58.

I find the defendant has failed to make the initial showing that disclosure of the CI's identity is material to the defense. The defendant makes a boilerplate allegation that disclosure "would enable counsel to find exculpatory evidence that would support [defendant's] innocence." Memorandum of Law in Support of Defendant's Pre-Trial Motions, p. 7. This "mere assertion" that disclosure might be helpful to the defense is insufficient, and disclosure of the CI's identity is not warranted. See Washington, supra.

ORDER

AND NOW, this 23rd day of December 2016, upon consideration of the defendant's Omnibus Pretrial Motions, filed May 26, 2016, IT IS HEREBY ORDERED that said motions are DE-NIED.
