

CIVIL JURY TRIALS, JUNE OF 2009

Caption: Kenneth Smith and Kathy Smith vs. Linda Rohrbaugh (2007 - SU - 5093 - Y01)

Judge: Renn

Type of Action: This case involves a motor vehicle accident. On January 24, 2006, Defendant rear-ended Plaintiff's vehicle which was stopped on West Market Street. On April 24, 2008, Plaintiff underwent an anterior cervical diskectomy with an interbody fusion at C5-C6. Liability was admitted and the sole issue for the jury was damages. Plaintiff was a self-employed barber and claimed pain and suffering and a vocational loss as a result of the neck injuries. Defendant offered \$22,500.00. The Jury found in favor of Plaintiff in the amount of \$50,036.00. Post-trial, the Court awarded \$1,081.59 in Delay Damages. However, the Court reduced the verdict by \$15,000.000 for a credit for wage loss benefits and a credit of \$75,000.00 for underinsured motorist benefits resulting in a molded verdict in Plaintiff's favor of \$0.00.

Caption: John C. McGreevy and Marybeth McGreevy vs. John M. Garber and Diane P. Owen Garber (2004 – SU – 0144 – Y01)

Judge: Linebaugh

Type of Action: This case involves a Quiet Title Action. Plaintiffs acquired Lots 6 and 11 and Defendants acquired Lots 22 and 23 in the Lauxmont Farms residential Community. Plaintiffs argued that the Lot 23 Deed clearly included an easement. The Defendants argue that their sales agreement stated that Defendants could opt out of the Common Driveway Easement. The Court found that the evidence at trial was insufficient to overcome the presumption that an easement exists. The Court held that the Easement was not terminated and Defendant had to acknowledge the Plaintiff's right to use the common driveway system.

Type of Action: This case involves a contract. Plaintiff alleges that Defendants entered into a contract with Plaintiff to purchase a home and Defendant was to perform the rehab work. The agreement was that when the rehab work was completed, the house was to be sold and the profits were to be split. Plaintiff alleges that when the work was done, Defendants secretly sold the property and kept the all the profits. Plaintiffs obtained a judgment by default in the amount of \$108,105.00. The sole issue before the Court was punitive damages. Jury found in favor of Plaintiff in the amount of \$10,000.00.

Caption: Daniel Reiller vs. Megan Dalton, Gabrielle Leppo, North Codorus Township and Gabrielle Leppo and North Codorus Township (2007 – SU – 03034 – Y01)

Type of Action: This case involves a motor vehicle accident. Plaintiff Reiller was a rear-seat passenger in Defendant Dalton's vehicle. Dalton's vehicle was travelling westbound on Waltersdorff Road. As she drove into an intersection, her car collided almost head-on with Defendant Leppo's

vehicle. In suing North Codorus Township, Plaintiff alleged that neither road was controlled by a stop sign. Plaintiff further alleged that Defendant knew it created a dangerous condition. Before trial, Plaintiff entered into a joint tortfeasor release with Defendants Leppo and North Codorus Township. Plaintiff and Dalton agreed that if a binding summary jury found that Defendant Dalton was 25% at fault or more, then Plaintiff would receive \$16,500.00. If Defendant Dalton's negligence was found to be less than 25%, then Plaintiff would not recover. The Jury found Defendant North Codorus Township and Gabrielle Leppo negligent and found Defendant Megan Dalton was not negligent.

Caption: David Morgalis vs. Joseph DePatto and York Hospital (2006 - SU - 1420 - Y01)

Judge: Linebaugh

Type of Action: This case involves a motor vehicle accident. Defendant DePatto drove an ambulance through a red light at the intersection of Market Street and Haines Road, striking Plaintiff's motorcycle. Plaintiff alleged contusions and abrasions, a left lateral tibial plateau fracture, and an aggravation of a prior partial rotator cuff tear, requiring surgery. Plaintiff alleged past lost wages in the amount of \$5,121.00, a medical subrogation lien of \$13,509.53, and out of pocket expenses of \$2,523.43. Plaintiff further alleged pain and suffering and a loss of function in the right shoulder. The Jury found Defendant DePatto was not negligent in operating the ambulance.

Type of Action: This case involves a motor vehicle accident. Plaintiff Kimberli Schlitzer was operating a motor vehicle, with Brooke Schlitzer, her daughter, in the back seat. Defendant's vehicle rear-ended Plaintiff's vehicle, and Defendant admitted negligence. Plaintiff brought the action for past and future pain and suffering, past and future loss of ability to enjoy the pleasures of life. Plaintiffs demanded \$19,500.00 for the mother and \$6,500.00 for the daughter. Defendant offered \$3,500.00 for the daughter's claim and \$4,000.00 to resolve the mother's claim. The Jury found in favor of Plaintiff in the amount of \$11,300.00.

Caption: Kenneth S. Johnson and Caroline D. Johnson vs. James P. Halkias a/k/a James Halkias a/k/a James R. Halkias (2005 – SU – 438 – Y01)

Judge: Linebaugh

Type of Action: This case involves an Equity Action. Plaintiffs entered into an agreement to purchase seven tracts of land from Defendant. A title search revealed that Defendants did not hold clear title. The parties agreed to enter into another agreement to extend the settlement in order for Defendants to provide clear title. A financing Addendum was also executed. Additional agreements were entered into to extend settlement; however, Defendant failed to

appear at the settlement. Plaintiffs sued Defendant for specific performance. The Court found in favor of Plaintiff and ordered specific performance.

The Owners before Defendant disclosed the water in the basement and the dampness in the crawl space to Defendant. Plaintiffs brought this action to recover damages or rescind the contract. The Court found in favor of Plaintiffs and awarded \$35,423.93 in damages.

Caption: Maclay, et al vs. Richards et al (2003-SU-05396-Y01)

Judge: Renn

Type of Action: This case involves conversion and outrageous conduct. Plaintiffs alleged that Defendants Richards and Derr shot and killed Plaintiff's dogs when the dogs went onto their property. Defendants argued that the dogs tried to attack them. The Jury awarded \$500.00 to the Estate of Gene Maclay and \$200.00 to Ryan Maclay in damages and equal amounts for punitive damages for the outrageous conduct of Defendant Derr in shooting the dogs.

Mr. Wonder died prior to the completion of the contract for sale. The Executor of Decedent's Estate denies the validity of the contract and sold the property to a third party. Plaintiff filed a Praecipe for Lis Pendens and filed a breach of contract and unjust enrichment action. A non-jury trial was held. The Court struck the Lis Pendens, found in favor of Defendant on the Breach of Contract Claim, and found in favor of Plaintiff in the amount of \$12,000.00 for unjust enrichment.
