Dependency – Rule 1925 opinion – Interlocutory appeal – Collateral order – Burden of proof

- 1. There is no dispute that certain interlocutory orders are appealable by right pursuant to Pa.R.A.P. 311; however, an order granting an application to file a private dependency petition is not one of the listed interlocutory orders appealable by right as set forth in the Rule.
- 2. An order granting a petition to intervene in a private dependency matter is interlocutory and not appealable.
- 3. While motions to intervene are different than applications for leave to file dependency petitions and involve different analyses, both occur prior to the hearing on a petition for dependency they are both steps in an ongoing dispute.
- 4. Pennsylvania Rule of Appellate Procedure 313(a) states that an appeal may be taken as of right from a collateral order of a trial court or other government unit.
- 5. A collateral order is defined as an order separable from and collateral to the main cause of action where the right involved is too important to be denied review and the question presented is such that if review is postponed until final judgment in the case, the claim will be irreparably lost.
- 6. The question of whether a private dependency petition is allowed to be filed is not too important to be denied review.
- 7. A child is without proper parental care or control, subsistence, education or other care or control necessary for his/her physical, mental or emotional health, or morals based upon evidence of conduct by the parent, guardian or custodian that places the health, safety or welfare of the child at risk, including evidence of the parent's, guardian's or other custodian's use of alcohol or a controlled substance that places the health, safety or welfare of the child at risk.
- 8. When an Application to File a Private Dependency Petition is filed, the Court must first determine whether the application includes the required information listed in 237 Pa. Code § 1320.
- 9. In accordance with 237 Pa. Code § 1321, the court must hear testimony to determine a) if there are sufficient facts alleged to support a petition of dependency; and b) whether the person applying for the petition is a proper party to the proceedings.
- 10. The burden of proof in a dependency proceeding is on the petitioner to demonstrate by clear and convincing evidence that a child meets that statutory definition of dependency.
- 11. Petitioners filed a Private Dependency Petition and an Order was entered scheduling the matter to be heard before a hearing officer. Thereafter, the Chester County Department of Children Youth & Families filed a Request Under Rule 1187(B)(1) for Hearing Before a Judge. The request was granted

and an adjudicatory hearing was scheduled. Subsequently, a Notice of Appeal was filed by the Chester County Department of Children Youth & Families. Pursuant to Pa.R.A.P. 1925(a)(2)(ii), the Court issued a Statement of the Court seeking dismissal of the appeal.

#### STATEMENT OF THE COURT

An appeal having been taken, pursuant to Pa.R.A.P. 1925(a)(2)(ii), the following statement is submitted for the children's fast track appeal.

On June 16, 2023, Petitioners Mary Ann Pastalone and Richard Mascitti filed an Application for Leave to File a Private Dependency Petition Pursuant to Pa.R.J.C.P. 1321 and 1330. On June 20, 2021, an Order was entered scheduling the Application for Leave to File a Private Dependency Petition before a Hearing Officer. On June 21, 2023, the Chester County Department of Children Youth & Families filed a Motion to Intervene and that the Application and Motion be Heard Before a Judge. On June 21, 2023, an Order was entered scheduling the hearing on the Motion to Intervene to be heard on June 30, 2023, before this Court.

On June 30, 2023, the Chester County Department of Children Youth & Families filed a Response to Application for Leave to File a Private Dependency Petition. Following a hearing on June 30, 2023, an Order was entered granting the Chester County Department of Children Youth & Families' Motion to Intervene. The hearing on June 30, 2023 then moved on to address the underlying Application for Leave to File a Private Dependency Petition Pursuant to Pa.R.J.C.P. 1321 and 1330 that was filed by Petitioners. The hearing was not completed and was resumed on July 10, 2023. At the conclusion of the hearing on July 10, 2023, an Order was entered that set forth the following:

Counsel for Mother and Father and Guardian Ad Litem for Child were not participants at the hearing which serves as the basis for this appeal. We have included counsel as Mother and Father are now parties and a Guardian Ad Litem has been appointed.

- The Application for Leave to File a Private Dependency Petition is GRANTED and Petitioners may file and serve a dependency petition pursuant to Pa.R.J.C.P. 1330 and 1331;
- 2. Chester County Department of Children Youth & Families shall be joined as a party to this action pursuant to Pa.R.J.C.P. 1321(C) upon the filing of the dependency petition by Petitioners. Petitioners shall serve Chester County Department of Children Youth & Families with all pleadings filed in this action in accordance with the Pennsylvania Rules of Juvenile Court Procedure;
- 3. Petitioners Mary Ann Pastalone and Richard Mascitti are proper parties to the proceedings; and
- 4. A hearing on the dependency petition shall be scheduled in due course after the filing of the dependency petition.
- 5. CASA is appointed pre-adjudication as an advocate for the child.

The Private Dependency Petition was filed on July 11, 2023 by Petitioners. On July 12, 2023, an Order was entered scheduling the matter to be heard before a hearing officer on August 1, 2023. On July 13, 2023, the Chester County Department of Children Youth & Families filed a Request Under Rule 1187(B)(1) for Hearing Before a Judge. Said request was granted and an adjudicatory hearing was scheduled for July 21, 2023.

On July 20, 2023, a Notice of Appeal was filed by the Chester County Department of Children Youth & Families. Pursuant to Pa.R.A.P. 1925(a)(2)(i), the Concise Statement of Errors Complained of on Appeal was filed and served with the Notice of Appeal. The Chester County Department of Children Youth & Families argues that "[t]he testimony presented by the Petitioners at the Rule 1321 Hearing failed to establish sufficient facts which would or could allow the Court to 'find sufficient facts to support a petition of dependency.' Pa.R.J.C.P. 1321(B)(1)."

Prior to addressing the underlying issue on appeal, this court notes that this is an interlocutory appeal which should be dismissed as permission to appeal has neither been sought nor granted. There is no dispute that certain interlocutory orders are appealable by right pursuant to Pa.R.A.P. 311; however, an order granting an application to file a private dependency petition is not one of the listed interlocutory orders appealable by right as set forth in the Rule.

There is no caselaw regarding whether an appeal from an Application for Leave to File Private Dependency Petition is a collateral order that is separable from the main cause of action. Recently, the Pennsylvania Superior Court entered a non-precedential opinion In the Interest of: T.W., a minor, 1657 EDA 2022 (December 19, 2022) which provides some guidance. In that case, Petitioners had filed an Application for Leave to File Private Dependency Petition. The trial court granted motions to intervene filed by both Chester County Department of Children, Youth & Families and by parents, and Petitioners filed an appeal. The

Court held that the order granting petitions to intervene was interlocutory and not appealable. Further, the Court stated that there was an ongoing dispute that cannot be immediately appealed without permission from the trial court. In that case, no permission had been sought by Petitioners, and Petitioners did not address whether the order was appealable as a collateral order.

While motions to intervene are different than applications for leave to file dependency petitions and involve different analyses, both occur prior to the hearing on a petition for dependency – they are both steps in an ongoing dispute. Based on similar reasoning, the appeal at bar is also interlocutory.

Pa.R.A.P. 312 governs interlocutory orders by permission; however, the Chester County Department of Children Youth & Families failed to seek this Court's permission to appeal this interlocutory order. Instead, they assert that is an appeal of a collateral order that may be appealed as a matter of right pursuant to Pa.R.A.P. 313. We disagree.

Pa.R.A.P. 313(a) states that "[a]n appeal may be taken as of right from a collateral order of a trial court or other government unit." A collateral order is defined as "an order separable from and collateral to the main cause of action where the right involved is too important to be denied review and the question presented is such that if review is postponed until final judgment in the case, the claim will be irreparably lost." Pa.R.A.P. 313(b). This appeal fails to meet the defined standard.

The question of whether a private dependency petition is allowed to be filed is not "too important to be denied review." If sufficient facts were set forth to allow the petition to be filed, the case would move on to an adjudication hearing where the Chester County Department of Children Youth & Families, as of right, becomes a party to the action and could fully set forth their evidence and position on the issue of dependency. The Agency's argument that this is "important to the Agency because the Agency will be required to devote valuable court time to a dependency petition hearing, and following on, if the Petition is granted, more court time and provide other services and tasks the Dependency Court deems appropriate" is quite astonishing. It was the Agency that applied to intervene and inserted themselves into this action prior to a time where they would be ordered to be parties to this action. To now argue that the Agency did not want to devote "valuable court time" to a matter is incredulous. This does not meet the standard of "too important to be denied review," and is therefore not a collateral order that may be appealable as of right. Accordingly, this appeal should be quashed.

If the Superior Court determines that this is not an interlocutory appeal or is an interlocutory appeal that is otherwise permitted by statute or rule, the following sets forth the analysis of the issues on appeal regarding whether it was proper to grant the Application to File a Private Dependency Petition.

#### Factual Background

The following averments were contained in the Application to File a Private

#### In the interest of: J.B., a minor

Dependency Petition ("Application"):

- 1. [J.B.] is a 3 year old child (DOB 8/16/2019), currently staying with his grandmother and her fiancé, Richard Mascitti, on Strasburg Road in Coatesville, Chester County, Pennsylvania.
  - a. The child previously resided with his mother in West Chester, Chester County, until Mother was evicted.
    - b. The child is not of school age.
    - c. Also living in the home are the child's adult aunts, Ms.

Pastalone's other daughters.

- 2. It is not believed that the child has any Native American heritage.
- 3. [J.B.]'s mother is Samantha Pastalone, and is currently homeless, last known to be at Safe Harbor in West Chester.
  - a. Mary Ann Pastalone, Applicant and Mother of Samantha, assisted Samantha with obtaining that apartment in 2021, after an eviction, so that Samantha had a safe place to go with her child.
    - i. Samantha was diagnosed with bipolar disorder when she was a teenager, and has reported other diagnoses, and has had an on-going struggle with taking her mental health medications as prescribed, particularly not abusing Adderall, and has been hospitalized most recently Summer 2022 and April 2023.
  - b. Samantha was living at the Golf Club Apartments until March 2023, when she was evicted. Samantha reported to her mother that the eviction was due to police presence at the apartment.
  - c. Samantha and [J.B.] began staying with Colleen Paoletti, Samantha's aunt, and the legal and physical custodian of Samantha's first child.
  - d. After approximately three weeks where Samantha was wandering out in the night, made physical threats to all family members, and was not sleeping in a regular pattern, demonstrating to the family that she was in a rapid cycle of her bipolar disorder, on or about April 1, 2023, a 302 was filed, and Samantha agreed to go in-patient for mental health treatment.
- 4. During the time Samantha was in-patient, [J.B.] stayed with Mary Ann Pastalone during the nights, and Colleen watched him during the work day because Samantha will not sign him up for day care. This was continued since Samantha's discharge.
- 5. [J.B.] is overall a happy child, but has some health struggles which his mother is not addressing.
  - a. [J.B.] is diagnosed with multiple hereditary osteochonodroma and Trevor's disease, which causes mostly benign bone tumor growths, which may grow away from joints, or may grow into joints, thus defining which disease the tumor is categorized as.

- b. [J.B.] was examined by a surgeon on April 21, 2023, in the presence of his grandmother, and needs to have two tumors removed from his right hand, one from his left knee, and one from his left foot (he is unable to wear a regular shoe due to the large growth on his foot).
  - i. This surgery has not been scheduled, Mother has not signed consents and did not attend that appointment.
- c. Although the child has had these growths for years, Mother has only taken the child to the doctor when brought by her own mother or her aunt. The child will have to have this condition monitored as he grows and has the potential of having other surgeries.
- d. Mother is unable to care for the child's medical needs and at times exacerbates them.
  - i. On February 18, 2023, Colleen noticed that due to Mother putting a shoe on the child's left foot, the skin was rubbed into a lesion. Over the course of a week, that lesion became infected and Mary Ann took photos of it. Mary Ann forced Mother to call the pediatrician on February 26, 2023, because the lesion was infected, but Mother did not make an appointment to have the child seen nor disclose photos of the oozing wound to the pediatrician.
  - ii. In April 2023, Colleen observed the child get a bottle of supplements, possibly melatonin, and begin eating the chewable supplements. She intervened but learned from the child that Mother left similar items around which are not safe for the 3 year old, and that the 3 year old thought he could eat supplements like this.
  - iii. Samantha reports the child's medical insurance card is lost and has not requested a new one despite repeated requests by Mary Ann Pastalone.
  - iv. Samantha has been prompted by Petitioner to sign the child up for head start and by pediatrician to request a speech evaluation for his inability to say consonant sounds, but Samantha has never done so and will not consent to Mary Ann doing so.
- 6. Mother used to receive Social Security disability benefits, but currently has no income.
  - a. Mary Ann Pastalone was Samantha's representative payee, and assisted with Samantha's use of those funds.
  - b. Social Security, based on information from Samantha's thentreating psychiatrist, removed the representative payee requirement.
  - c. Samantha has since lost benefits and has not been able to restart them.
- 7. The child's father is Lamar Boone, whose address is unknown but believed to be currently staying in Atlantic City.
  - a. Lamar Boone has never had stable housing to the knowledge

of the Applicant and Petitioner.

- b. Lamar Boone last lived with the child when he was invited by Samantha to stay with them while they were staying in Colleen Paoletti's home, in approximately 2020.
  - c. Lamar Boone has been seen to respond to internal stimuli and Samantha reports he has a diagnosis of schizophrenia.
  - d. Lamar Boone has not been active in the child's life; he has other children but their whereabouts are not known to this individual.
- 8. During the time the child was in the Golf Club Apartments with Mother, CCDCYF is averred and believed to have been open with Samantha for the care of [J.B.].
  - a. The CCDCYF caseworker reported that on one occasion she entered the apartment and saw the child unattended and marijuana within the 3 year old's reach.
  - b. Samantha reported another occasion where the child left her apartment and she couldn't find him.
- 9. Petitioner has been contacted by Chester County Department of Children Youth and Families (CCDCYF) multiple times and most recently the child was seen in mid-May.
  - a. Mary Ann and Colleen have been told they are capable of caring for this child together.
  - b. CCDCYF caseworker Juliet Petrin has come out to see the child regularly.
  - c. CCDCYF has not told Mary Ann or Colleen what services they are providing and the only assistance provided was to offer a letter stating that both Mary Ann and Colleen are caregivers, and it is not clear if they are providing any services to Samantha (or if Samantha is cooperating with services).
  - d. For these reasons, CCDCYF has not been contacted prior to the filing of this petition.

The proposed Private Dependency Petition was attached as Exhibit A and included the allegations in the Application with the addition of other averments. Both the Application and proposed petition indicated that the child is without proper parental care or control as defined by 42 Pa.C.S. § 6302, which states as follows: "The child 1) is without proper parental care or control, subsistence, education as required by law, or other care or control necessary for his/her physical, mental or emotional health, or morals; a determination that there is a lack of proper parental care or control may be based upon evidence of conduct by the parent, guardian or custodian that places the health, safety or welfare of the child at risk, including evidence of the parent's, guardian's or other custodian's use of alcohol or a controlled substance that places the health, safety or welfare of the child at risk."
