PIKE COUNTY DISTRICT ATTORNEY PRESS RELEASE PIKE COUNTY SENTENCING INFORMATION

October 17, 2019 — Pike County District Attorney Raymond J. Tonkin announced the following criminal sentences were issued by Pike County Court of Common Pleas President Judge Gregory Chelak:

Diane Phillips, age 56, of Hawley, PA, was sentenced to 11 1/2 months to 23 months in the Pike County Jail and fined \$500.00 for the crime of Delivery of a Controlled or Counterfeit Substance. Phillips sold Heroin/Fentanyl to a confidential informant for U.S. currency at a location in Lackawaxen Township on August 31, 2018.

Jesse Dewayne Bellora, age 29, of Milford, PA, was sentenced to 72 hours to 5 years in the Pike County Jail, fined \$2,500.00 and had his driver's license suspended for 18 months for the crime of Driving Under the Influence. The state police responded to Vanuken Hill Road on February 16, 2019, where Bellora drove his car into a tree. While speaking with Bellora, the trooper detected the smell of an alcoholic beverage emanating from Bellora and observed him to have glassy eyes. Field Sobriety Tests showed signs of impairment and a breath test confirmed a blood alcohol content of .263%.

Colton James Kelty, age 22, of Eldred, NY, was sentenced to 72 hours to 6 months in the Pike County Jail, fined \$1,000.00 and had his driver's license suspended for 12 months for the crime of Driving Under the Influence. The state police were dispatched to Well Road in Blooming Grove Township on October 13, 2018, where Kelty drove off the road and flipped his vehicle. The trooper detected the smell of an alcoholic beverage while speaking with Kelty and observed him to have slurred speech and bloodshot eyes. Kelty admitted to drinking prior to driving. A blood test confirmed a blood alcohol content of .182%.

Joshua Matthew Strobeck-Stormes, age 22, of Matamoras, PA, was sentenced to 20 days to 2 years – less 1 day in the Pike County Jail and fined \$400.00 for the crimes of Possession of Drug Paraphernalia and Disorderly Conduct. Eastern Pike Regional Police were alerted to the fact that Stroebeck-Stormes was residing in Matamoras where drug dealing was taking place. A consent to search the residence revealed baggies, pipes, a grinder and scale.

Kenneth John Lynch, age 48, of Lords Valley, PA, was sentenced to 3 months to 6 months in the Pike County Jail and fined \$300.00 for the crime of False ID to Law Enforcement. The state police were dispatched to a residence in Blooming Grove Township for a domestic dispute on July 18, 2018, where Lynch was intoxicated and damaging items in the residence. When questioned by the troopers, Lynch provided false identifying information.

Kenneth Edward Hicks, age 52, of Tafton, PA, was sentenced to 6 months of probation and fined \$300.00 for the crime of Disorderly Conduct. The state police responded to a domestic disturbance at a residence in Palmyra Township on June 16, 2019, where Hicks acted in an aggressive manner towards an individual during an argument.

Andrew Fedorov, age 57, of Lords Valley, PA, was sentenced to 72 hours to 6 months in the Pike County Jail, fined \$1,000.00 and had his driver's license suspended for 12 months for the crime of Driving Under the Influence. The state police were dispatched to a one-vehicle crash on January 25, 2019, where Fedorov's vehicle left Concours Lane in Blooming Grove Township and struck a tree. Upon speaking with Fedorov, the trooper detected the smell of an alcoholic beverage and observed Fedorov displaying stuttered, slurred speech and glossy, bloodshot eyes. Fedorov admitted to drinking alcohol prior to driving. Field Sobriety Tests were conducted and a breath test confirmed a blood alcohol content of .195%.

Crystal Lee Presto, age 28, of Port Jervis, NY, was sentenced to 9 months to 23 1/2 months in the Pike County Jail and fined \$500.00 for the crime of Retail Theft. Presto took merchandise totaling in excess of \$260.00 from a retail store in Westfall Township on March 18, 2019, without paying for the items.

Harry Bridgman, age 51, of Keyport, NJ, was sentenced to 1 month to 12 months in the Pike County Jail and fined \$300.00 for the crime of Theft. Bridgman took assorted fishing gear with an approximate value of \$1,015.00 from an individual's property without the owner's permission.

Shaniefa Shante Humphrey, age 33, of Cliffside Park, NJ, was sentenced to 1 day to 2 days in the Pike County Jail and fined \$300.00 for the crime of Criminal Trespass. Humphrey entered a residence on December 25, 2016, in Lehman Township after it was communicated to her by the property owner that she did not have permission or authorization to enter.

Eric Martin Garcia, age 33, of Middletown, NY, was sentenced to 24 months of probation and fined \$1,300.00 for the crime of Retail Theft and 4 counts of the crime of Conspiracy to Commit Retail Theft. Garcia took merchandise valued at \$389.00 from a retail store in Westfall Township on May 11, 2017, without paying for it. On June 29, July 1, July 6 and July 7 of 2017, Garcia conspired with another individual to take merchandise without paying for it at the same retail business.

October 24, 2019 — Pike County District Attorney Raymond J. Tonkin announced the following criminal sentences were issued by Pike County Court of Common Pleas President Judge Gregory Chelak:

Christopher John Troianiello, age 50, of Bushkill, PA, was sentenced to 5 years of the IP Pike Care Program, which will include 6 months of house arrest, a fine of \$1,500.00 and a driver's license suspension of 18 months for the crime of Driving Under the Influence. The state police responded to the scene of a vehicle crash where Troianiello's vehicle collided with another vehicle along SR 402 in Porter Township on June 10, 2019. Troianiello then fled the scene in his vehicle. Troianiello was located in his vehicle outside his residence. A breath test confirmed a blood alcohol content of .182%.

Corina Marie Montalvo, age 27, of Port Jervis, NY, was sentenced to 3 years of probation and fined \$500.00 for the crime of Criminal Conspiracy to Possess with the Intent to Deliver a Controlled Substance. During the execution of a search warrant on January 8,

2019, at a residence located in Matamoras Borough, Montalvo and two additional individuals were found in possession of a large amount of Marihuana and U.S. Currency.

Erika S. Thibault, age 22, of Findlay, OH, was sentenced to 1 year of probation and fined \$400.00 for the crime of Possession with Intent to Manufacture or Deliver a Controlled or Counterfeit Substance. The state police responded to I-84 in Dingman Township on January 6, 2018, where Thibault had rolled her vehicle. In speaking with Thibault, the trooper detected the smell of Marihuana. A search of her vehicle revealed two pounds of Marihuana.

Edward John Olejnik, age 36, of Milford, PA, was sentenced to 12 months of probation and fined \$500.00 for the crime of Accident Resulting in Death or Injury. The state police responded to a two-vehicle crash on August 12, 2017, where Olejnik crossed the center lane of travel of SR 739 in Blooming Grove Township, colliding with another vehicle, causing injury to the other vehicle's occupant. Olejnik failed to immediately stop and failed to return to the scene.

Timothy Joseph McNulty, age 38, of Moosic, PA, was sentenced to 6 months of the IP Program which will include 10 days in the Pike County Jail, 60 days of house arrest, a fine of \$975.00 and a driver's license suspension with a duration to be determined by PennDOT for the crime of Driving Under the Influence of Alcohol, and the Summary Offenses of Reckless Driving and Restrictions on Alcoholic Beverages. The state police responded to I-84 in Blooming Grove Township on February 20, 2019, where McNulty was reported to be swerving his vehicle across the road. When contact was made with McNulty, the trooper detected the smell of an alcoholic beverage and observed him to have glossy, bloodshot eyes, slurred speech and a dazed demeanor. Field Sobriety Tests showed impairment and a blood test confirmed a blood alcohol content of .131%.

Ruben K. Bell, age 34, of Philadelphia, PA, was sentenced to a fine of \$250.00 for the crime of Possession of a Small Amount of Marihuana. During a stationary patrol along Route 209 in Lehman Township, the trooper observed Bell operating his vehicle in an unsafe manner on July 20, 2019. When contact was made with Bell, the trooper detected the smell of Marihuana. A search of the vehicle revealed Marihuana.

John Jeffrey Corrigan, age 51, of Honesdale, PA, was sentenced to 3 years of probation and fined \$500.00 for the crime of Stalking. Between October 17, 2017, and March 28, 2018, at a place of business in Milford Township, Corrigan communicated with an individual reportedly in a manner in which to cause the individual stress and fear of bodily injury.

Fredric Daniel Apostolico, age 42, of Lords Valley, PA, was sentenced to 8 days to 18 months in the Pike County Jail and fined \$500.00 for the crime of Terroristic Threats. On December 16, 2015, Apostolico left voice mail messages on an individual's answering machine at a residence in Blooming Grove Township threatening harm to the individual.

Andrew Thomas White, age 29, of Greentown, PA, was sentenced to 18 months of probation and fined \$1,000.00 for the crime of Delivery of a Controlled or

Counterfeit Substance. White sold Marihuana on February 2, 2018 and February 27, 2018 to a confidential informant in Greene Township.

Sarah Beth Steele, age 38, of Port Jervis, NY, was sentenced to 6 months of probation and fined \$200.00 for the crime of False Reports to Law Enforcement Authorities. On February 19, 2019, Steele reported to the Eastern Pike Regional Police that a specific individual broke into her home in Matamoras and stole her television, VCR and DVDs and sold them to a local business, knowing that the statements were false.

John Henry Farro, age 54, of Bushkill, PA, was sentenced to 120 days in the Pike County Jail and fined \$500.00 for 2 counts of the crime of Harassment. The state police responded to a domestic disturbance at a residence in Lehman Township on July 8, 2018, during which Farro attempted to or threatened to harm two individuals before Farro fled into the woods.

Malik Tamar-James Pitchford, age 26, of Milford, PA, was sentenced to a \$300.00 fine for the Summary Offense of Disorderly Conduct. On March 3, 2019, Pitchford engaged in fighting and acted in a violent and threatening manner in that he repeatedly contacted an individual at her work place and followed her home to her residence in Dingman Township and refused to leave despite the repeated request of the property owners.

Sade Dominique Phifer, age 24, of Lackawaxen, PA, was sentenced to 18 months of probation and fined \$500.00 for the crime of Resisting Arrest and the Summary Offense of Harassment. The state police were dispatched to a residence in Lackawaxen Township on November 27, 2017, for a domestic dispute involving Phifer. While the troopers were attempting to arrest Phifer, Phifer resisted and continued to act in a belligerent manner.

Robert A. Hartman, age 53, of Lackawaxen, PA, was sentenced to 5 years of the IP Pike Care Program which will include 3 months of house arrest, a \$2,000.00 fine and a driver's license suspension of 18 months for the crimes of Driving Under the Influence of Alcohol or a Controlled Substance and Possession of Drug Paraphernalia. The state police stopped Hartman on November 11, 2018, while traveling along SR 590 in Lackawaxen for no rear lights. Hartman admitted to being in possession of a baggie of Marihuana and to having smoked Marihuana earlier in the day. Field Sobriety Tests showed impairment and a blood test confirmed the presence of THC in Hartman's blood.

Shaun T. Whitehead, age 38, of Milford, PA, was sentenced to 45 days to 90 days in the Pike County Jail, fined \$300.00 and had his driver's license suspended for 12 months for the crime of Operating without Interlock Ignition. Milford Borough Police stopped Whitehead while traveling along West Harford Street in Milford Borough on January 8, 2019, for an expired registration. Whitehead was found to be operating a vehicle without the required ignition interlock as ordered by a prior sentence originating out of Goshen, NY.
