# COMMONWEALTH OF PENNSYLVANIA VS. DANIEL MICHAEL WHELAN

- 1. The issue before the court is whether there was reasonable suspicion for the Pennsylvania State Police to stop Defendant's motorcycle.

# **OPINION ON DEFENDANT'S MOTION TO SUPPRESS**

Presently before this Court is Daniel Michael Whelan's (hereinafter "Defendant") Motion for Suppression of Evidence, filed January 5, 2023. A hearing was held on February 21, 2023. The issue before the court is whether there was reasonable suspicion for the Pennsylvania State Police to stop Defendant's motorcycle. For the reasons set forth herein, Defendant's Motion for Suppression of Evidence is denied.

# **FINDINGS OF FACT**

1. Trooper Cody Mack (hereinafter "Trooper Mack") is employed with the Pennsylvania State Police and stationed at the Gettysburg Barracks. Trooper Mack has been with the Pennsylvania State Police for approximately three years.

- 2. Trooper Mack has extensive training and experience dealing with vehicle stops and violations of the Pennsylvania Vehicle Code.
- 3. On July 16, 2022 at approximately 12:10 p.m. Trooper Mack was providing patrol support to a DUI regulatory checkpoint. Trooper Mack was in full uniform in a marked Pennsylvania State Police vehicle.
- 4. Trooper Mack observed a motorcycle heading south on Route 97 in Cumberland Township, Adams County, Pennsylvania. Trooper Mack followed the motorcycle and ran the registration of the motorcycle, which was registered to one owner, Daniel Whelan.
- 5. The driver's license for Daniel Whelan was a Class C license, which did not authorize Daniel Whelan to operate a motorcycle.
- 6. Trooper Mack observed the individual operating the motorcycle was a male and was wearing a full-face helmet.
- 7. Trooper Mack initiated a traffic stop of the motorcycle to determine if the operator was Daniel Whelan.
- 8. Trooper Mack obtained identification from the operator and Defendant was identified as the operator.
- 9. The driver's license that Defendant provided was a Class C license, not a Class M license.
- 10. Trooper Mack subsequently filed DUI charges against Defendant.
- 11. This Court found Trooper Mack's testimony credible. His testimony was corroborated by Commonwealth's exhibit one, the MVR recording.

# **CONCLUSSIONS OF LAW**

1. Trooper Mack had reasonable suspicion to stop Defendant's motorcycle.

# LEGAL STANDARD

In a suppression hearing, the Commonwealth has the burden to establish, by a preponderance of the evidence, the admissibility of those items the accused seeks to preclude. **Commonwealth v. Ruey**, 892 A.2d 802, 807 (Pa. 2006). Moreover, "it is the sole province of the suppression court to weigh the credibility of the witnesses. Further, the suppression court judge is entitled to believe all, part or none of the evidence presented." **Commonwealth v. Benton**, 655 A.2d 1030, 1032 (Pa. Super. 1995) (internal citations omitted).

An encounter between a police officer and a citizen constitutes a seizure if "a reasonable person would [not] have felt free to leave or otherwise terminate the encounter." Commonwealth v. Singleton, 169 A.3d 79, 83 (Pa. Super. 2017) (quoting Commonwealth v. Lyles, 97 A.3d 298, 302–03 (Pa. 2014)). "[A]n investigative detention occurs when a police officer temporarily detains an individual by means of physical force or a show of authority for investigative purposes." Commonwealth v. Cauley, 10 A.3d 321, 325 (Pa. Super. 2010) (quoting Commonwealth v. Smith, 904 A.2d 30, 35 (Pa. Super. 2006)). A traffic stop is a type of investigative detention and is a seizure for Fourth Amendment purposes. Commonwealth v. Sadvari, 752 A.2d 393, 399–400 (Pa. 2000).

A police officer may conduct a traffic stop of a vehicle if, in "the totality of the circumstances," the officer has "reasonable suspicion[] . . . of criminal activity."

Commonwealth v. Salter, 121 A.3d 987, 993 (Pa. Super. 2015) (quoting Commonwealth v. Feczko, 10 A.3d 1285, 1290–91 (Pa. Super. 2010)); Commonwealth v. Raglin, 178 A.3d 868, 872 (Pa. Super. 2018). "The police must be able to point to specific and articulable facts which reasonably support that suspicion," including "both suspicious conduct on the part of the person[] so detained and a reasonable belief of some sort of criminal activity." Commonwealth v. Riley, 715 A.2d 1131, 1135 (Pa. Super. 1998) (internal citations omitted). However, "[e]ven a combination of innocent facts, when taken together, may warrant further investigation by the police officer." Raglin, 178 A.3d at 872 (emphasis removed) (quoting Commonwealth v. Rogers, 849 A.2d 1185, 1189 (Pa. 2004)). In determining whether a police officer's detention of an individual was supported by reasonable suspicion, courts also "must give 'due weight . . . to the specific reasonable inferences [the police officer] is entitled to draw from the facts in light of his experience." Id. (quoting Rogers, 849 A.2d at 1189).

# **DISCUSSION**

The facts of the case and the applicable law require the court deny Defendant's Motion for Suppression of Evidence. Trooper Mack clearly had reasonable suspicion to stop Defendant's motorcycle. The reasons for this determination are elaborated herein.

First, as a threshold matter, it is clear that Trooper Mack conducted a traffic stop of the motorcycle and thereby detained Defendant. A seizure occurs when a citizen, during an encounter with a police officer, does not "fe[el] free to leave or otherwise terminate the encounter." Singleton, 169 A.3d at 83 (quoting Lyles, 97 A.3d at 302–03). Thus, a police officer's activation of his or her vehicle's overhead lights often renders a subsequent interaction with a citizen an investigative detention. See Commonwealth v. Krisko, 884 A.2d 296, 300 (Pa. Super. 2005) ("Activation of overhead lights are a strong indication of an investigative detention . . . where the driver of a stationary vehicle has no reason to believe that an officer is simply carrying out his duty of rendering aid."). Here, Trooper Mack activated his emergency blue and red lights and stopped Defendant's motorcycle; in the circumstances, Defendant could not but have regarded this action as a show of authority that prohibited Defendant from leaving the scene. Accordingly, Trooper Mack seized Defendant by activating his emergency equipment and stopping the motorcycle. Because Trooper Mack seized Defendant for investigative purposes, their encounter was an investigative detention. See Sadvari, 752 A.2d at 399-400; Riley, 715 A.2d at 1135.

Trooper Mack's detention of Defendant was supported by reasonable suspicion. Trooper Mack ran the motorcycle's registration while he was following the motorcycle, which came back to a single owner, Daniel Whelan. Trooper Mack determined that Daniel Whelan did not have a valid Class M driver's license to operate a motorcycle. Trooper Mack observed the individual operating the motorcycle was a male but could not further identify the individual because he was wearing a helmet. Given all of these factors, Trooper Mack was able to point to specific and articulable facts which reasonably support Trooper Mack's suspicion that Defendant was operating the motorcycle without a valid Class M driver's license. Trooper Mack's stop of the motorcycle is supported by Commonwealth v. Jefferson, 256 A.3d 1242 (2021).

Therefore, for the reasons set forth above, the attached Order is entered.
