District Attorney's Office

PRESS RELEASE

December 13, 2024 – Wayne County District Attorney A.G. Howell announced today the arrest of 39-year-old Anthony Gately, Starlight PA. Gately faces charges including counts of Child Pornography – videoing and possessing, Corruption of Minors, Criminal use of a communication facility, dissemination and possession of sexually explicit materials, and indecent exposure.



ANTHONY GATELY

The investigation began in October 2024 after the state police received a complaint that a 13 year old minor child received and sent concerning and criminal messages, photographs, and videos with Gately. The messages were sexually explicit and pornographic.

Gately sent to the minor child pornographic photographs and videos of both himself and others.

The investigation is ongoing as well.

Gately was arrested and appeared before a Magisterial District Judge for a preliminary

arraignment, where bail was set at \$50,000.00. He was remanded to the Wayne County Correctional Facility. Gately's next court appearance is set for December 18, 2024.

*The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.

MARK BOWSER, age 34, of Honesdale, PA was sentenced to no less than 98 days (time served) nor more than 12 months incarcerated in the Wayne County Correctional Facility on one count of Simple Assault.

JULIAN HYLAND, age 33, of Thompson, PA was sentenced to no less than 115 days (time served) nor more than 23 ½ months incarcerated in the Wayne County Correctional Facility on one count of Terroristic Threats and one count of False Reports to Law Enforcement Authorities.

MELISSA SCURTO, age 41, of Chester, WV was sentenced to no less than 5 days nor more than 6 months incarcerated in the Wayne County Correctional Facility on one count of DUI: General Impairment /Incapable of Safe Driving – 2nd Offense.
