PIKE COUNTY DISTRICT ATTORNEY PRESS RELEASE PIKE COUNTY SENTENCING INFORMATION

October 1, 2020 — Pike County District Attorney Raymond J. Tonkin announced the following criminal sentences were issued by Pike County Court of Common Pleas President Judge Gregory Chelak:

Andy M. Nieves, age 22, of Matamoras, PA, was sentenced to 16 months to 10 years in a state correctional facility and fined \$1,300.00 for the crimes of Robbery, Criminal Conspiracy to Commit Robbery and Theft by Unlawful Taking. Nieves and his codefendant agreed to carry out a robbery of an individual which they picked up with their vehicle on March 18, 2019, in a residential development in Delaware Township, struck him on the head causing an injury and forcibly took property from him.

Korey A. Brace, age 31, of Sparrowbush, NY, was sentenced to 6 months of probation and fined \$500.00 for the crime of Simple Assault. During a domestic dispute, Brace struck an individual in the head with a closed fist causing injury on June 27, 2019, along Pennsylvania Avenue in Matamoras.

Alexandru D. Irinyi, age 50, of Marshalls Creek, PA, was sentenced to 1 year to 7 years in a state correctional facility, fined \$2,800.00 and had his driver's license suspended for 30 months for 2 counts of the crime of Driving Under the Influence. The state police were dispatched to Winona Falls Road in Lehman Township on April 28, 2019, where Irinyi was sitting in the driver's seat of his vehicle, slumped over the steering wheel, with the vehicle running and the door open. The trooper observed Irinyi to have glassy, bloodshot eyes, and emanating the smell of an alcoholic beverage. Field Sobriety Tests showed impairment and a blood test confirmed a blood alcohol content of .256%. On May 18, 2019, the state police were dispatched to a business parking lot along Route 6 in Palmyra Township where Irinyi was acting in a suspicious manner and having difficulty standing up. The trooper detected the smell of an alcoholic beverage and observed Irinyi's movements to be sluggish and his eyes red, bloodshot and glassy. Field Sobriety Tests showed impairment and a blood test confirmed a blood alcohol content of .300%.

William Wayne Smith, age 54, of Old Forge, PA, was sentenced to 90 days to 5 years in the Pike County Jail, fined \$1,500.00 and had his driver's license suspended for 18 months for the crime of Driving Under the Influence. The state police responded to a domestic dispute involving Smith on June 14, 2014, along SR 507 in Greene Township. While speaking with Smith, the trooper detected the smell of an alcoholic beverage. Smith admitted to drinking beer prior to driving. A breath test confirmed a blood alcohol content of .235%.

Kimberley Lynn Shupe, age 39, of Dingmans Ferry, PA, was sentenced to 3 months to 18 months in the Pike County Jail and fined \$300.00 for the crime of Retail Theft. While working as an employee at a gas station in Palmyra Township, Shupe took cigarettes on October 18, 2019, valued at \$27.00 without paying for them.

Michael Craig Bower, age 32, of Hawley, PA, was sentenced to 6 months of the Pike Care Program which will include 30 days of house arrest, a fine of \$1,000.00 and driver's license suspension of 12 months for the crime of Driving Under the Influence. The state police stopped Bower on October 6, 2019, for driving erratically along SR 507 in Greene Township. When contact was made with Bower, the trooper observed him to have exaggerated movements, being very talkative and exhibiting body tremors. A glassine baggie was visible in his vehicle. Field Sobriety Tests showed impairment. Bower admitted to the trooper that he suffered from Heroin addiction.

Frederick Smith, age 27, of Port Jervis, NY, was sentenced to 72 hours to 6 months in the Pike County Jail, fined \$1,000.00 and had his driver's license suspended for 12 months for the crime of Driving Under the Influence of a Controlled or Counterfeit Substance. Smith was stopped by the state police on May 8, 2019, for traveling too closely behind another vehicle along I-84 in Westfall Township. In speaking with Smith, the trooper detected the smell of Marihuana and observed Smith to have bloodshot, glassy eyes with dilated pupils. Smith admitted to the trooper that he smoked Marihuana prior to the stop. Smith was found in possession of Marihuana. Field Sobriety Tests showed impairment. Smith refused a blood test.

Nalasjia Harris-Johnson, age 21, of Wilkes Barre, PA, was sentenced to a fine of \$300.00 for the crime of Possession of Drug Paraphernalia. The state police responded to a gas station along SR 507 in Greene Township on October 2, 2019, where Harris-Johnson and another individual were involved in a domestic dispute. When Harris-Johnson was patted down, she was found in possession of a Marihuana pipe containing residue.
