

NOTICE IS HEREBY GIVEN that a hearing has been set for July 7, 2014 at 10:00 a.m., in Courtroom #1 of the Bradford County Courthouse, 301 Main Street, Towanda, Pennsylvania 18848; and, per Court Order dated May 27, 2014 by the Honorable Maureen T. Beirne, at Docket No. 2014IR0037.
