

- Support for children who have demonstrated desire and reasonable ability for education beyond high school.

**NOTE:** "Children" shall include all children who have been or shall be referred to the Juvenile Probation Office or York County Children and Families having been found delinquent, neglected or dependent children, until they be discharged from the jurisdiction of the Court, or shall no longer be subject thereto by reason of having attained the age of 21 years, whichever is earlier. *In special cases, consideration may be given to community quality of life initiatives of particular interest to the Bar and operating support for start-up costs for new programs provided the program meets the grant criteria. YCBF will not consider proposals for annual operating expenses.* 

<u>What is the process to apply for funding?</u> Proposals may be summitted for early consideration at any time thru August 19, 2022. For consideration in 2022, the deadline is 12:00 Noon on Friday, August 19 at York County Bar Foundation, 137 East Market Street, York PA 17401 or by e mail to <u>victoria.connor@yorkbar.com</u>.

Following review of proposals by the YCBF Lenz Fund Advisory and Grants Committees, those submitting proposals will be notified by September 1 of our decision to invite full grant applications. Full grant applications are due no later than September 30.

<u>How much funding is available?</u> YCBF anticipates that *up to* approximately \$100,000 will be available for programs/projects not otherwise receiving YCBF funding. Selected grants will be funded from the total allotment available.

Proposals (no more than 2 pages) should include:

- A summary of the program / project and how it addresses YCBF's funding interests
- Program / project leadership and partners
- Estimated cost and other funders
- How the program / project will be sustained after initial funding
