NOTICE IS HEREBY GIVEN that the Palmerton Area Community Endeavor, Inc. (hereinafter "PACE") has filed a Petition on April 2, 2024 with the Court of Common Pleas of Carbon County, Orphans' Court Division, at No. 24-OC-0009. All of PACE's Class A shares of stock are currently owned by Palmerton Area Chamber of Commerce, a Pennsylvania non-profit corpo-

ration, and pursuant to PACE's Articles of Incorporation, approved on May 7, 1959, only the holders of Class A shares in PACE are authorized to vote. At the present time, PACE is holding the proceeds from the sale of Class B shares of stock in PACE, which as of December 31, 2023, had a value of \$889,510.42 (hereinafter "restricted funds"). PACE desires to re-purpose the restricted funds such that an amount of no more than \$5,000 is paid each year to the Palmerton Area Chamber of Commerce, as long as it remains the sole holder of the Class A shares of PACE, for the sole purpose of defraying administrative expenses associated with the proposed use of restricted funds. PACE further desires to re-purpose the restricted funds to make loans to businesses in the Palmerton area in accordance with guidelines which PACE developed through the Palmerton Area Chamber of Commerce, as the sole Class A shareholder, and to make other uses of the restricted funds as set forth in the Petition. The Court has scheduled a hearing on said Petition for June 7, 2024 at 2:00 o'clock p.m. in Courtroom #1, Carbon County Courthouse, Jim Thorpe, Pennsylvania 18229 to consider PACE's request. Any holders of Class B shares of PACE, or their heirs, successors and assigns, or any other interested parties, may attend the hearing and provide
