

MARISA HESSLER, 32, was sentenced to 24 months to 60 months as a result of a guilty plea to Endangering the Welfare of Children, Resisting Arrest, Possession of Drug Paraphernalia, and Simple Assault.

HONESDALE, PA, August 2, 2024 — Wayne County District Attorney A.G. Howell announced the following case was addressed by the Honorable President Judge Janine Edwards.



TODD WIGNALL, 57, was sentenced to 82 months to 164 months as a result of a guilty plea to Involuntary Manslaughter and Delivery of Heroin laced with Fentanyl. This incident occurred on January 11, 2023, when Wignall brought drugs to a residence. Amanda Parry and he both ingested the drugs. Amanda Perry died from an overdose. Wignall also overdosed but survived the toxic drugs. Wignall has been incarcerated in the

Wayne County Correctional Facility since his arrest in 2023.
