

TERMINATION OF PARENTAL RIGHTS

32 ADOPT 2022

IN RE: ADOPTION OF L.R.D.

TO: UNKNOWN BIOLOGICAL FA-

A Petition has been filed asking the court to put an end to all rights you have to your child L.R.D. born on July 26, 2020 in Wilkes-Barre, Pennsylvania. The mother is the Kirsten Shaw a/k/a Kirsten Durling born August 16, 1999. The court has set a hearing to consider ending your rights to your child. The hearing will be held at the Bradford County Courthouse, Courtroom 1, 301 Main Street, Towanda, PA 18848 on April 12, 2023 at 8:30 a.m. before the Honorable Maureen Beirne. You have an important option that may be available to you under Pennsylvania Law. Act 101 of 201 permits the adoptive parents, child, birth parents and/ or relatives to enter into a voluntary Post-Adoption Agreement. You are warned that even if you fail to appear at the scheduled hearing, the hearing will go on without you and your rights to your child may be ended by the Court without you being present.
