Attorney's fees

- A litigant cannot recover counsel fees from an adverse party unless there is express statutory authorization, a clear agreement of the parties, or some other established exception.
- 2. Plaintiff innocently testified she attended a medical examination at the request of Defendant's insurance company. The Court granted Defendant a mistrial. Defendant sought a court order by which Plaintiff would compensate Defendant for the counsel fees Defendant owed her trial counsel for time leading up to the mistrial which will have to be duplicated at a second trial. MEMORANDUM

Plaintiff testified during the jury trial on May 9, 2022 that she attended a medical examination at the request of Defendant's insurance company. Defendant moved for a mistrial which this court granted on the record in open court. This court filed a separate Order and Memorandum on May 10, 2022.

On May 16, 2022, Defendant filed Defendant Casey Grentz's Motion for Attorney's Fees. Defendant asked this court to order Plaintiff to compensate Defendant for the counsel fees she owes to her trial counsel for his time leading up to the mistrial which will have to be duplicated at a second trial. Motion, 5/16/2022, ¶¶ 6, 10. Defendant argued that this court has "discretion to award costs and reasonable attorney's fees when a party causes mistrial." Motion, 5/16/2022, ¶¶ 7 (citing Davis v. Southeastern Pennsylvania Transportation Authority, 680 A.2d 1223 (Pa.Cmwlth. 1996) and Zito v. Merit Outlet Stores, 647 A.2d 573 (Pa. Super. 1994)). Motion, 5/16/2022, ¶¶ 7. Plaintiff filed a Response on May 17, 2022 arguing that Defendant has no right to reimbursement because Plaintiff's mention of Defendant's insurance company was caused by "unintentional and innocent inadvertence." Response, 5/17/2022, ¶ 6-10.

"Under the American Rule, applicable in Pennsylvania, a litigant cannot recover counsel fees from an adverse party unless there is express statutory authorization, a clear agreement of the parties, or some other established exception." Trizechahn Gateway LLC v. Titus, 976 A.2d 474, 482-83 (Pa. 2009) (citing Mosaica Charter School v. Commonwealth, Department of Education, 813 A.2d 813, 822 (Pa. 2002)).

Here, Defendant argued that this court has "discretion to award costs and reasonable attorney's fees when a party causes mistrial." Motion, 5/16/2022, ¶ 7. Defendant supported that claim by citation to Davis v. Southeastern Pennsylvania Transportation Authority, 680 A.2d 1223 (Pa.Cmwlth. 1996) where the trial judge precluded evidence of the plaintiff's drug convictions, the defendant's attorney willfully attempted to elicit that evidence at trial, the trial judge declared a mistrial, and the trial judge properly fined the defendant's attorney \$500 and charged the defendant for the court's wasted time. Defendant also cited Zito v. Merit Outlet Stores, 647 A.2d 573 (Pa.Super. 1994) where the jury was selected and trial set to begin, the unprepared counsel for the plaintiffs requested a recess to take a physician's video deposition which the trial judge granted, and the trial judge properly charged plaintiffs for the county/city's wasted time since the delay was "directly attributable to the failure of counsel to timely prepare for trial or earlier advise the court of scheduling problems." 647 A.2d at 576-77.

This court does not read Defendant's cases to stand for the broad proposition that causing a mistrial is an established exception to the American rule. It is true that "the courts possess inherent power to enforce their orders and decrees by imposing penalties and sanctions for failure to comply." Yeager v. Kavic, 765 A.2d 812, 814 (Pa.Super. 2000) (citing Brocker v. Brocker, 241 A.2d 336 (Pa. 1968)

and <u>Travitzky v. Travitzky</u>, 534 A.2d 1081, 1084 n. 3 (Pa.Super. 1987)). However, it is also true that "there can be no recovery of counsel fees from the adverse party in the absence of express statutory allowance of the same." <u>Yeager</u>, 765 A.2d at 814-15 (citing <u>DeFulvio v. Holst</u>, 362 A.2d 1098, 1100 (Pa.Super. 1976)). In <u>Yeager</u> the trial judge precluded testimony on syndromes that cause nerve paralysis after surgery but a defendant's expert witness testified during cross-examination as to the statistical likelihood of long thoracic nerve palsy following surgery. The trial judge declared a mistrial and ordered the defendant to pay the plaintiffs' counsel fees pursuant to 42 Pa.C.S. § 2503(7) for dilatory, obdurate, or vexatious conduct but without making a "specific finding that a participant-party, counsel, or witness had engaged in dilatory, obdurate or vexatious conduct." 765 A.2d at 815. The trial judge's shifting of fees without statutory authority or a showing of bad faith was an abuse of discretion and the Superior Court reversed the trial judge's award of counsel fees for causing the mistrial.

Similarly, it is not enough here that Plaintiff caused a mistrial. Plaintiff's mention of Defendant's insurance company was an innocent mistake. The question asked by Plaintiff's counsel was in no way intended to elicit mention of Defendant's insurance company and Plaintiff in no way mentioned Defendant's insurance company in an attempt to prejudice the jury. Here there was no misconduct that warrants sanctions and Defendant has not identified any established exception to the American Rule that would authorize this court to order Plaintiff to reimburse Defendant for her counsel fees leading up to the mistrial. Under these circumstances the law provides no remedy for Defendant's loss.

Accordingly, for the reasons set forth above this court will enter an order denying Defendant Casey Grentz's Motion for Attorney's Fees filed May 16, 2022.

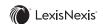


