

RESOLUTION HONORING THE LATE HERBERT E. MILLEN

The time for remembrance of and tribute to Herbert E. Millen is long past. He was not one of our colleagues in the Lancaster Bar Association but we do proudly claim and honor professional fellowship with him.

Herbert E. Millen was born in 1892 in Strasburg, Lancaster County, Pennsylvania. Mr. Millen grew up in and spent many months each year in that Borough, keeping the family home at 20 East Main Street until 1951. His parents, John A. and Emma Millen, lived in that house and maintained a successful barbershop there for many decades.

In his youth, Mr. Millen worked harvesting tobacco and other crops, all the while carrying the full load of his educational pursuits in the Strasburg Schools. Mr. Millen graduated in the class of 1906, being the first Black graduate of that school.

In 1912 Mr. Millen graduated from Lincoln University. Thereafter he entered law school at the University of Pennsylvania, graduating in 1920. During his years in law school he was employed and worked full time at the Philadelphia Post Office. He was known to sustain himself on four hours of sleep a night.

In the same year he graduated from law school he was sworn in as an attorney in Philadelphia County (Admission to practice on a county by county basis was available until 1968). Mr. Millen made himself known by his active involvement in Philadelphia politics and community endeavors. Governor Gifford Pinchot appointed him as a Deputy Attorney General in 1935.

Reams of paper might be consumed by the simple listing of his volunteer and pro bono work. Perhaps one example may suffice. Attorney Millen was active in the financial rescue and institutional upgrading of the Mercy-Douglass Hospital in Philadelphia. During his active tenure on the Board he led a capital campaign, successfully meeting the campaign's goal of three million dollars. He was Chairman of the Board of that hospital for his last ten years of service there.

In 1947, by Governor Duff's appointment, he became a Judge of the Philadelphia Municipal Court. By this act, Herbert E. Millen, Esquire, became the Honorable Herbert E. Millen. He was the first Black judge in Pennsylvania and the thirteenth in the United States. In 1949 he won election to a full ten year term. He was the highest vote getter as to the four judgeships on the ballot that year.

Judge Millen appeared on the Edward R. Murrow program "This I Believe," broadcast by CBS May 10, 1952. From this broadcast, available on YouTube, one may acquire a glimpse of his philosophy of law and life.

"The misdeeds and misfortunes crowded into a court calendar, often seem to make a mockery of the things we have been taught to regard as virtuous and good. Nevertheless, I am something of an optimist. I still believe that man is basically a positive creature, capable of great things beyond himself. It is ironic, perhaps, that it usually takes a disaster to bring out the best in people. Invariably, in a flood or famine, or in the midst of war, we become a little more human, a little more brotherly

towards our immediate neighbors. That proves, I think, that a potential of decency exists in us.”

Judge Millen died July 25, 1959, survived by his second wife, Mrs. Madeleine Green. His first wife, Carrie N. Millen predeceased him.

BECAUSE Herbert E. Millen led a distinguished career and life, and BECAUSE he was born and nurtured in Lancaster County, maintaining his ties to Lancaster County his entire life, and

BECAUSE the Lancaster Bar Association is proud of its professional bond with him, his appointment and election as the first Black judge in Pennsylvania being a milestone in our legal, social, and governmental history,

NOW, THEREFORE BE IT RESOLVED that the Association supports the preservation of his legacy.
