Background: Daniel Kambic, D.O. is a family doctor working for Family Practice Center, P.C. and was the family physician for Curtis L. Meixner, deceased. In late 2007, Mr. Meixner had a right hip replacement surgery and developed a pulmonary embolism, a serious complication. Mr. Meixner also needed a left hip replacement a few months later. To avoid a potential pulmonary embolism, Dr. Kambic referred Mr. Meixner to an interventional radiologist for placement of an inferior vena cava (“IVC”) filter to prevent another life-threatening pulmonary embolism. The left hip surgery was successful with no complications, including no pulmonary embolism. Dr. Kambic placed Mr. Meixner on Coumadin after his left hip surgery and discontinued its use six months thereafter.

It was Dr. Kambic’s understanding that these IVC filters were intended to be permanent although the radiologist wrote to Dr. Kambic at this time stating that he would be happy to consider taking the filter out when the risk of pulmonary embolism from the left hip surgery subsided.

The filter remained in Mr. Meixner for nine years until his death of a pulmonary embolism in August of 2017.

Plaintiff’s theory was that because this IVC filter is a foreign body, that a blood clot developed on top of the filter which broke off and caused the pulmonary embolism and Mr. Meixner’s death. In 2014, the FDA issued an advisory that taking these filters out should be considered because of various risks. The Plaintiff argued that this advisory included the risk of pulmonary embolism while the Defendant argued it did not. Dr. Kambic testified that he never received this advisory as it would be something that would likely go to the interventional radiologist. Plaintiff argued that Dr. Kambic should have referred his patient back to the interventional radiologist to consider the removal of the filter within six months of its placement.

There were various experts on both sides, including family physicians, interventional radiologists, and a hematologist. The hematologist, expert for the Defendants, opined that if this filter created a blood clot on top of it and broke off to cause the pulmonary embolism, you would have seen smaller blood clots around the filter. The autopsy report showed the filter was clean with no blood clots.
