Appeal from probate regarding revocable trust

- 1. There is no requirement that a revocable trust and/or any amendments thereto be probated.
- 2. The statutory provisions governing actions before a register of wills are not applicable to revocable trusts.
- 3. 20 Pa. C.S. § 908 states any party in interest seeking to challenge the probate of a will or who is otherwise aggrieved by a decree of the register, or a fiduciary whose estate or trust is so aggrieved, may appeal therefrom to the court within one year of the decree.
- 4. An Amended Petition for Appeal from Probate was filed pursuant to § 908 alleging undue influence, lack of testamentary capacity and fraud regarding one or all of the trust documents and incorrectly alleged the trust documents were admitted to probate. The Amended Petition did not allege that Petitioner was in any way aggrieved by the will, the only instrument admitted to probate, nor that the will was invalid based on undue influence, lack of testamentary capacity or fraud.
- 5. Preliminary Objections were filed in response to the Amended Petition for Appeal from Probate. The Court <u>Held</u> the Petition was dismissed without prejudice, noting Section 908 does not provide the Court with the authority to address a challenge to the trust documents, which were not admitted to probate. The Court noted a challenge to the trust documents must be filed with the court pursuant to 20 Pa.C.S. § 7754, entitled "Actions contesting validity of revocable trust."

AND NOW, this 22nd day of March, 2022, the Amended Petition for Appeal from Probate filed by Martha-Lisa Flinsch is hereby DISMISSED without prejudice.¹

On October 11, 2021, Martha-Lisa Flinsch, Decedent's daughter, filed a Petition for Appeal from Probate pursuant to 20 Pa. C.S. § 908. Section 908 states, in pertinent part, that, "any party in interest seeking to challenge the probate of a will or who is otherwise aggrieved by a decree of the register, or a fiduciary whose estate or trust is so aggrieved, may appeal therefrom to the court within one year of the decree." The Petition set forth three counts alleging undue influence, lack of testamentary capacity and fraud, on the part of Margaret Jean Leonard (Decedent's Second Wife), regarding one or all of the Trust Documents. The Petition incorrectly concludes in each wherefore clause that the Trust Documents were admitted to probate. Not one of the three counts in the Petition seeks to have the Will, which is the only instrument admitted to probate, declared invalid or stricken based on undue influence, lack of testamentary capacity or fraud.

On December 10, 2021, Executor filed Preliminary Objections to the Petition for Appeal from Probate. On December 14, 2021, The North Dakota State University Foundation & Alumni Association ("the Foundation"), a beneficiary of the Trust, filed Preliminary Objections to the Petition for Appeal from

Probate. On December 15, 2021, Pennsylvania Attorney General Josh Shapiro ("AG") joined the Preliminary

¹ On January 13, 2021, the Chester County Register of Wills issued a Decree of Probate granting Letters Testamentary to Howard Hodel, Decedent, Charles J. Mode's nephew ("Executor"), and admitting to Probate the Last Will and Testament (Pour-Over) of Decedent, dated October 3, 2017 (the "Will"). The Will was the only instrument admitted to probate. The Charles J. Mode Family Trust, dated February 27, 2008 (the "Trust"), the 1st Amendment to the Trust, dated June 27, 2017, the 2nd Amendment to the Trust, dated November 17, 2017, and the 3rd Amendment to the Trust, dated January 3, 2019 (collectively the "Trust Documents"), were not admitted to probate. The Trust is a revocable trust. *See*, 20 Pa. C.S. § 7703 (defining the term "revocable trust"). There is no requirement that a revocable trust and/or any amendments thereto be probated. 20 Pa. C.S. § 7754 cmt. In addition, the statutory provisions governing actions before a register of wills are not applicable to revocable trusts. *Id.; See*, 1 Pa. C.S. § 1939 (Comments by commissions or committees may be consulted in construction or application of a statute.); *Lessner v. Rubinson*, 527 Pa. 393, 398 n.4, 592 A.2d 678, 680 n.4 (1991) ("Official comments are to be given weight in the construction of statues.").

Objections filed by Executor and the Foundation.

On January 11, 2022, Ms. Flinsch filed an Amended Petition for Appeal from Probate pursuant to § 908. The Amended Petition again set forth three counts alleging undue influence, lack of testamentary capacity and fraud, on the part of Margaret Jean Leonard, regarding one or all of the Trust Documents. The Amended Petition incorrectly concludes in each wherefore clause that the Trust Documents were admitted to probate. The Amended Petition does not allege that Petitioner is in any way aggrieved by the Will. Not one of the three counts set forth in the Amended Petition seeks to have the Will, which is the only instrument admitted to probate, declared invalid or stricken based on undue influence, lack of testamentary capacity or fraud.

Petitioner's challenge in this case is not to the Will, but to the Trust Documents. Section 908 does not provide the Court with the authority to address a challenge to the Trust Documents, which have not been admitted to probate. *Compare* 20 Pa. C.S. § 908 (appeals from a decree of the register); *and* 20 Pa. C.S. § 7754 cmt. (Statutory provisions governing actions before a register of wills are not applicable to revocable trusts.). A challenge to the Trust Documents must be filed with the court pursuant to 20 Pa.C.S. § 7754, "Actions contesting validity of revocable trust."
