

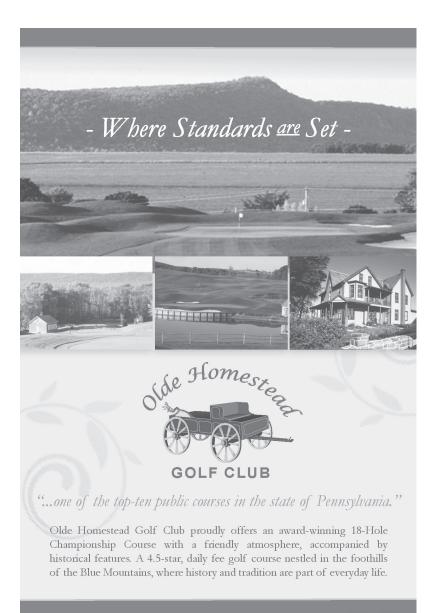

COMMONWEALTH OF PENNSYLVANIA vs. JAVIER TORO DELGADO, DEFENDANT/APPELLANT

Post Conviction Relief Act—Ineffective Assistance of Counsel—Guilty Plea—Sentencing—Knowing and Voluntary Plea—Concurrent Sentences—Length of Sentence.

Defendant could not establish the elements of ineffective assistance of counsel under the Post Conviction Relief Act (PCRA) because both his attorney at the time of his guilty plea and the judge in his case adequately explained the potential sentence he was facing prior to the plea.

In the Court of Common Pleas of Lehigh County, Pennsylvania—Criminal Division. Nos. CP-39-CR-4647-2012, CP-39-CR-4650-2012, CP-39-CR-4656-2012, CP-39-CR-1159-2013, Superior Ct. No. 752 EDA 2015. Commonwealth of Pennsylvania vs. Javier Toro Delgado, Defendant/Appellant.

FORD, J., April 7, 2015. Defendant/appellant, Javier Toro Delgado, appeals from an order denying his petitions filed under Pennsylvania's Post Conviction Relief Act (PCRA), 42 Pa. C.S. §§9541-46. Through these petitions, appellant claimed that he was denied effective assistance of counsel in his guilty plea negotiations and that this ineffectiveness caused him to enter unknowing and involuntary pleas. As I now explain, appellant did not prove these allegations so this appeal should be denied.

PROCEDURAL HISTORY

On September 19, 2013, appellant entered his guilty pleas. In case CP-39-CR-4647-2012, appellant pled guilty to two counts of robbery graded as felonies of the first degree. In case CP-39-CR-4650-2012, appellant pled guilty to one count of disorderly conduct, a summary offense. In case CP-39-CR-4656-2012, appellant pled guilty to one count of driving with a suspended license, a summary offense. In case CP-39-CR-1159-2013, appellant pled guilty to one count of theft by unlawful taking and one count of

simple assault, both misdemeanors of the second degree. Attorney Steven R. Mills was appellant's plea counsel.

Appellant's charges stemmed from several armed robberies of mini-markets in Allentown, Lehigh County, in September of 2012. In each robbery, appellant was masked, brandished a firearm and demanded money from a mini-market employee. During one of the robberies, appellant pistol whipped an employee who then required medical attention.

Appellant entered these pleas pursuant to a plea bargain with the Commonwealth. In exchange for the guilty pleas, the Commonwealth agreed to withdraw all remaining counts in the four cases. Some of the withdrawn charges were felonies. The parties agreed that all of appellant's sentences would be served concurrently. There was no agreement as to the length of the sentences to be imposed.

On November 4, 2013, I imposed an aggregate confinement sentence on appellant of ten years to twenty years. The confinement for each of the two robberies was the statutory maximum sentence. I ordered that all sentences be served concurrently. The sentences complied with the plea bargain. In imposing the sentences, I considered the sentencing guidelines, the evidence from the guilty plea and sentencing hearings and the information in the presentence investigation report (PSI) prepared on appellant. Appellant did not file a direct appeal of his sentences.

Appellant filed a *pro se* PCRA petition on October 31, 2014. Because this was appellant's first PCRA petition, I appointed Assistant Public Defender Kathryn R. Smith to represent him by order filed on November 7, 2014. Attorney Smith filed an amended PCRA petition for appellant on December 24, 2014. On February 6, 2015, I conducted a hearing on the two PCRA petitions.

On February 17, 2015, I entered an order denying and dismissing appellant's *pro se* PCRA petition and the amended PCRA petition. My reasons for entering the order were stated in an accompanying opinion.

Appellant filed the current notice of appeal on March 16, 2015. In response to an earlier order, appellant filed a "Statement

of Matters Complained of on Appeal" (Concise Statement) as required by Pa. R.A.P. 1925(b) on March 25, 2015.

DISCUSSION AND CONCLUSION OF LAW

Appellant makes some nonspecific allegations in the Concise Statement including an incorporation of the entire amended PCRA petition into the Concise Statement. On the other hand, he makes specific contentions about the plea bargain so I am able to address those.

Appellant maintains that I erred in denying his PCRA petitions in which he contended that his plea counsel, Attorney Mills, was ineffective. He accused Attorney Mills of deceiving him about the sentences he would receive under the plea bargain. He also faulted Attorney Mills for his confusion about other components of the plea bargain although he did not state what he did not understand.

In order to establish eligibility for PCRA relief, appellant must prove by a preponderance of the evidence that the conviction or sentence resulted from "[i]neffective assistance of counsel which, in the circumstances of the particular case, so undermined the truth-determining process that no reliable adjudication of guilt or innocence could have taken place." 42 Pa. C.S. §9543(a)(2)(ii).

In order to be entitled to relief on a claim of ineffective assistance of counsel, the PCRA petitioner must plead and prove by a preponderance of the evidence that (1) the underlying claim has arguable merit; (2) counsel whose effectiveness is at issue did not have a reasonable basis for his action or inaction; and (3) the PCRA petitioner suffered prejudice as a result of counsel's action or inaction.

Commonwealth v. Steele, 599 Pa. 341, 360, 961 A.2d 786, 796 (2008). A defendant's failure to meet any prong of this test defeats his claim. Commonwealth v. Wright, 599 Pa. 270, 321, 961 A.2d 119, 149 (2008) (citation omitted). Counsel is presumed to be effective and the defendant must prove otherwise. Commonwealth v. Rivers, 567 Pa. 239, 246, 786 A.2d 923, 927 (2001) (citation omitted).

The Superior Court explained:

A criminal defendant has the right to effective counsel during a plea process as well as during a trial. ... Allegations of ineffectiveness in connection with the entry of a guilty plea will serve as a basis for relief only if the ineffectiveness caused the defendant to enter an involuntary or unknowing plea. ... Where the defendant enters his plea on the advice of counsel, 'the voluntariness of the plea depends on whether counsel's advice "was within the range of competence demanded of attorneys in criminal cases."'

Commonwealth v. Hickman, 799 A.2d 136, 141 (Pa. Super. 2002) (internal citations omitted).

At the PCRA hearing on February 6, appellant and his mother, Aracelly Delgado, testified that, on a number of occasions before the guilty pleas were entered, Attorney Mills assured them that appellant's total prison sentences in these cases would be five and one-half to eleven years.

In his PCRA testimony, Attorney Mills denied that such assurances were made. He stated that he never told appellant a specific sentence that he would receive. Attorney Mills had discussions with appellant about the plea bargain before the pleas were entered and the various considerations that would be factored into the sentences. He explained the sentencing guidelines to appellant. He told appellant that the district attorney would be asking for a minimum sentence in the aggravated range, namely, eighty-four months. He also told appellant that he was facing a ten-year to twenty-year confinement sentence under the plea bargain. The attorney found appellant knowledgeable on sentencing topics. He reviewed the PSI with appellant which, interestingly, contains a five-and-one-half-year to twelve-year confinement recommendation by the PSI probation officer (as opposed to the five-and-onehalf-year to *eleven*-year promise that appellant said was made to him). Attorney Mills believed that he had appellant fully prepared for sentencing.

Attorney Mills' testimony was corroborated by the record of the guilty plea and sentencing hearings. The record from those hearings shows that appellant understood the plea bargain, that he knew that he was facing a ten-year to twenty-year aggregate confinement sentence, and that there were no assurances to him of some other specified lesser aggregate sentence. A defendant is bound by the statements he makes "during a [guilty] plea colloquy, and may not successfully assert claims that contradict such statements." Commonwealth v. Muhammad, 794 A.2d 378, 384 (Pa. Super. 2002) (citation omitted).

In setting forth the plea bargain at the plea hearing with appellant present, Assistant District Attorney Kevin McCloskey said, "All of the charges I have mentioned will run concurrent and no agreement on sentence, so open pleas to all these counts." I then asked "But all must run concurrent?" Attorney McCloskey responded, "Yes, Judge, but basically an open plea." N.T., 9/19/13, p. 3.

A bit later in the hearing, the assistant district attorney repeated what appellant was facing with this plea bargain. "Again, Your Honor, no agreement on sentence, but all charges, all counts to run concurrent. So his exposure, what he's looking at, is a possible ten to twenty years." N.T., 9/19/13, p. 5.

A colloquy then ensued between appellant and me. After I explained the concurrent sentence aspect of the plea bargain, I said to him,

And then, finally, there's no plea bargain on what your sentences should be, though, as to each one of these. That's left up to the court. And I will consider—by the court I mean the judge—and I will consider everything I hear in this hearing and the next hearing and also the pre-sentence [sic] report in deciding what the appropriate sentence should be.

N.T., 9/19/13, p. 10. I then asked appellant if he wanted to plead guilty with the plea bargain as I explained it to him. He answered, "Yes, Your Honor." N.T., 9/19/13, p. 10.

After the assistant district attorney, and then I, explained the plea bargain to appellant, I asked appellant, "Other than the plea bargain, have any promises been made to get you to plead guilty?" Appellant answered, "No." N.T., 9/19/13, p. 13.

Just before appellant entered his pleas I stated to him, "Each of the two robberies has a maximum prison sentence you could get of twenty years in prison. Do you understand that?" Appellant answered, "Yes." N.T., 9/19/13, p. 21.

At the start of the sentencing hearing on November 4, 2013, Assistant District Attorney McCloskey reiterated the plea bargain. That included his statement, "Your Honor, our agreement is that all charges in all cases run concurrent, but it would basically be an open plea, Judge." N.T., 11/04/13, p. 2. Appellant offered no objection to that statement. Appellant testified at the PCRA hearing that he did not know what "open plea" meant. Whether that was true or not, I found that appellant did know at that point and well before that point that he could receive confinement of ten years to twenty years.

During the guilty plea and sentencing hearings, appellant did not give any indication that he was promised a five-and-one-halfyear to eleven-year sentence despite the many opportunities to tell me that.

What I now explain provided some insight on the credibility of appellant. Appellant testified at the PCRA hearing that he did not understand the sentence when it was pronounced. Appellant gave this testimony even though, at the end of the sentencing hearing, I explained to appellant:

What's the bottom line, sir? The bottom line is you serve confinement in the state penitentiary of not less than ten years to not more than twenty years. You do get credit for the time you spent in custody toward that. That's all the sentences combined. That is the bottom line. Do you understand that?

N.T., 11/4/13, p. 19. The record reflects that appellant did not verbally respond to my question but he gave an affirmative nod.

Appellant met with Attorney Mills after the sentencing. He claims that he still did not understand the sentences he received when he was meeting with his attorney. He claims that he only knew that he received a ten-year to twenty-year sentence after a telephone conversation with his mother following the sentencing hearing and the meeting with Attorney Mills. I find this difficult

to believe in light of my pronouncement of sentence directly to appellant and then the last quoted explanation of his sentence which I gave appellant right after I imposed the sentence.

The PSI probation officer restated the plea bargain on page two of the PSI: "A plea agreement, entailing that the present sentences run concurrent to each other, was made between the District Attorney's Office and the [appellant]." He repeated on page ten of the PSI: "A plea agreement, entailing that the present sentences run concurrent to each other, was made between the District Attorney's Office and the [appellant]." There was no mention in the PSI of a promised five-and-one-half to eleven-year sentence. Attorney Mills reviewed the PSI with appellant. These statements by the probation officer in the PSI should have prompted appellant to question his attorney or the court at the sentencing hearing, but appellant did not raise the topic.

In addition to appellant's allegation of a promise by his counsel of a sentence less than what he actually received, appellant complained that he was generally confused about the provisions of the plea bargain. Appellant does not point to any specific subject about which he was confused. Be that as it may, the record just referenced illustrates an accused who was fully aware of every significant aspect of his pleading and sentencing consequences.

Appellant failed to show ineffectiveness on the part of Attorney Mills. The record establishes that appellant knowingly and voluntarily entered his guilty pleas and understood what he faced as sentences. Therefore, this appeal lacks merit and should be denied.
