## PIKE COUNTY DISTRICT ATTORNEY PRESS RELEASE PIKE COUNTY SENTENCING INFORMATION

October 31, 2019 — Pike County District Attorney Raymond J. Tonkin announced the following criminal sentences were issued by Pike County Court of Common Pleas President Judge Gregory Chelak:

Damion Anthony Lacosta, age 23, of Bushkill, PA, was sentenced to 2 months to 23 months in the Pike County Jail, followed by 12 months of probation and a fine of \$900.00 for 2 counts of the crime of Recklessly Endangering Another Person, and 1 count of Simple Assault. During a domestic dispute on April 3, 2018, at a residence in Lehman Township, Lacosta shoved an individual causing her to hit her head. The injury required medical attention. On August 15, 2018, during a domestic dispute along Milford Road in Lehman Township, Lacosta jumped on the hood of an individual's vehicle, and kicked in the windshield putting the safety of two minor children at risk.

David Alan Hallman, age 25, of Effort, PA, was sentenced to 5 days to 6 months in the Pike County Jail, fined \$300.00 and had his driver's license suspended for 12 months for the crime of Driving Under the Influence. The state police were dispatched to Wallenpaupack Drive in Greene Township on May 11, 2019, where Hallman crashed his UTV into a residential septic mound. When contact was made with Hallman, the trooper detected the smell of an alcoholic beverage and observed Hallman to have bloodshot, watery eyes. Hallman admitted to drinking alcohol prior to operating the UTV. Field Sobriety Tests showed impairment and a breath test confirmed a blood alcohol content of .099%.

Damon Bradley Robinson, age 55, of Honesdale, PA, was sentenced to 45 days to 12 months in the Pike County Jail, fined \$1,275.00 and had his driver's license suspended for a duration to be determined by PennDOT for 2 counts of the crime of Driving Under the Influence and the Summary Offense of Operation of a Vehicle without the Official Certificate of Inspection. Robinson's vehicle was observed weaving along Pine Ridge Drive West in Lehman Township on January 21, 2018, striking an embankment and continuing along erratically. When contact was made with Robinson, the trooper detected the smell of an alcoholic beverage. Robinson admitted to drinking prior to driving. Field Sobriety Tests showed impairment and a blood test confirmed a blood alcohol content of .117%. On October 8, 2018, Robinson was involved in a one-vehicle crash along Bushkill Falls Road. Robinson admitted to drinking prior to driving. Field Sobriety Tests were administered which resulted in multiple indicators and a blood test confirmed a blood alcohol content of .120%. Robinson was also found to be driving a vehicle lacking a current inspection.

Jonathan Nicholas Rivera, age 24, of East Stroudsburg, PA, was sentenced to 14 months to 28 months in a state correctional facility and fined \$800.00 for the crimes of Criminal Attempt to Commit Burglary and Theft by Unlawful Taking or Disposition. The state police responded to a residence in Lehman Township on February 8, 2016, where Rivera smashed the front door to gain entry into the home which Rivera ransacked and stole the copper piping, a bow, bb gun, television, deerskin, a table, ladder and table saw.

Karen Colleen Hall, age 55, of Dingmans Ferry, PA, was sentenced to a fine of \$300.00 for the Summary Offense of Harassment. Hall was involved in a physical altercation with another individual at a residence in Delaware Township on May 31, 2019, where she subjected the individual to physical contact or threatened to do so.

Nell T. Sheehan, age 23, of Shohola, PA, was sentenced to 90 days to 6 months in the Pike County Jail and fined \$200.00 for the crime of Possession of Drug Paraphernalia. Sheehan was an occupant in a vehicle stopped by the state police along Silver Lake Road in Dingman Township on August 1, 2019. During an arrest of Sheehan on an outstanding warrant, Sheehan was found in possession of Heroin baggies, a spoon and a hypodermic needle.


