ADMINISTRATIVE ORDER

AND NOW, to wit, this 2nd day of December, 2020, pursuant to the Supreme Court's Orders dated March 16, 2020, April 1, 2020, April 28, 2020, and May 27, 2020 (Nos. 531 and 532 Judicial Administration Docket), the Wayne County Court of Common Pleas implements the following additional provisions:

- The January 2021 trial term is CANCELLED. All matters will be individually rescheduled.
- 2. The operation of Rule of Criminal Procedure 600, relating to speedy trials, shall remain suspended in the 22nd Judicial District until March 8, 2021 (the next scheduled trial term).
- Statewide rules that restrict, directly or indirectly, the use of Advanced Communication Technology ("ACT") are hereby suspended in the 22nd Judicial District until January 31, 2021.
- 4. Motions Court shall remain cancelled through January 31,2021.
- 5. Any and all supervised visitation for dependent children of Wayne County Children and Youth Services ("WCCYS") may be conducted via video conference at the discretion of the WCCYS staff. WCCYS shall serve copies of this Order on counsel and parents of all dependent children impacted by this Order.

WAYNE COUNTY PROPOSES NEW LOCAL RULE

Pursuant to a plan proposed earlier this year by the Wayne County District Attorney A.G. Howell, a new booking center fee of \$175.00 is being requested of certain criminal defendants in order to accomplish the following goals:

- To efficiently process offenders charged with criminal actions with the intent to return law enforcement officers to their communities as quickly as possible;
- To accurately and timely process offenders not in custody and treat all with dignity and respect;
- To positively identify offenders by their fingerprints and the updating of their criminal histories within minutes; and
- To confirm notification to offenders of the requirement for fingerprinting and to process offenders in an accurate and efficient manner.

Below is the proposed Administrative Order of Court which would impose the fee to implement the details of the plan.

The fee shall be assessed as a cost of prosecution and collected by the Wayne County Clerk of Courts. The fee shall be allocated to a Central Booking Center Fund for the implementation, start-up, operation, and maintenance of the booking center.

The booking center shall be available for all law enforcement agencies having arrest powers in Wayne County. The effective date of this Administrative order shall be thirty (30) days after publication in the *Pennsylvania Bulletin*.

It is further *ORDERED* that the District Court Administrator distribute this Order as follows:

- File one (1) copy of this Order with the Administrative Office of Pennsylvania Courts;
- File two (2) copies of this Order to the Legislative Reference
 Bureau for publication in the *Pennsylvania Bulletin* along with a
 copy of this Order on a CD-ROM or other agreed upon alternate
 format;
- Publish a copy of this Order on the Wayne County Court of Common Pleas website;
- 4. Compile the local rule within the complete set of local rules no later than 30 days following publication in the *Pennsylvania Bulletin*.
