

ATTENTION MEMBERS

Effective January 3, 2023

All persons, including all attorneys, must follow the Lackawanna County Sheriff's Office Policy regarding security and screening when entering the County Courthouse, Government Center, Criminal Justice Center and all Magisterial District Offices.

Lawyers are asked to continue to show their Attorney ID for entry through the Employee/Attorney entrances. Firearms and weapons are not permitted in these buildings and the Sheriff's Office will NOT store any weapons.

Below is the security and screening policy of the Lackawanna County Sheriff's Office

LACKAWANNA COUNTY SHERIFF'S OFFICE

SECURITY AND SCREENING POLICIES AND PROCEDURES

1. The following policy shall be followed for the Lackawanna County Courthouse, the Lackawanna County Government Center, the Lackawanna County Criminal Justice Center, and all magisterial district offices.
2. Lackawanna County Sheriff's Deputies shall have the authority to conduct reasonable searches of persons and property entering the above-stated buildings to enforce the provisions of 18 Pa. Con. Stat. § 913, which prohibits the possession of firearms or other dangerous weapons in a court facility. A "weapon" is defined to include any firearm, knife, an explosive or incendiary device (whether operational, functional, real, or hoax), chemical substance, and/or any object that is designed, made, or adapted for the purpose of inflicting bodily injury, in addition to any item treated as a weapon under the Crimes Code of Pennsylvania.

BUILDING ENTRANCE PROTOCOL

NOTE: INDIVIDUALS WHO REFUSE TO SUBMIT TO SECURITY SCREENING SHALL BE DENIED ENTRY

1. All persons entering the above-stated buildings shall be processed for screening as follows:
 - Place any bags or personal belongings on the magnetometer or x-ray belt or in the container provided for scanning, including purses, watches, jewelry, backpacks, and pocket contents.
 - Place overcoats or jackets on the belt of the x-ray machine.
 - Walk through the metal detector.

If the metal detector sets off an alert or alarm, a Deputy may perform another scan using a hand-held wand. The Deputy may also conduct a physical search of personal articles to determine the cause of the alert or alarm. If a magnetometer or x-ray belt is unavailable, a Deputy may perform a scan using a hand-held wand.
2. All packages, bags, briefcases, deliveries, mail, and other containers in the immediate possession of persons entering the aforesaid buildings are subject to inspection and screening; provided, however, that such items are not allowed unless necessary for a business-related purpose.
3. Any prohibited offensive weapons shall be confiscated by the Deputy and the individual in possession of the same shall be subject to arrest.
4. Law enforcement officers entering these buildings shall secure their weapon with the Sheriff's Deputy on duty upon arrival. The Deputy shall secure and lock up the weapon and the law enforcement officer shall retrieve the weapon upon departure.
5. Any law enforcement agency presenting to serve an arrest or search warrant at ANY county building, must notify the Lackawanna County Sheriff's Office within 24 hours of execution of the warrant. Should a law enforcement agency fail to give notice, the agency shall not be permitted to be armed when executing the warrant. Should the Sheriff's Office receive prior notice, the agency shall be escorted by a Deputy Sheriff while being armed.
6. Any non-law enforcement officer legally possessing a firearm shall secure the firearm as their own responsibility. The Sheriff's Department shall not secure weapons for non-law enforcement officers.
