- The exclusive method of discontinuing an action before the trial court is pursuant to Pa.R.C.P. 229.
- 2. The decision to grant a discontinuance without prejudice rests within the discretion of the trial court.
- 3. A trial court may strike off a discontinuance to protect the rights of a party to the litigation.
- 4. A party has a heavy burden in challenging the discretion of the trial court in striking a discontinuance.
- 5. Rule 229 does not permit one party to determine lack of prejudice when discontinuing an action.
- 6. A discontinuance without prejudice is not permitted unless by court order.
- 7. The Court struck the Praecipe to Discontinue Without Prejudice *sua sponte*.

There is no authority for a party to discontinue an action without prejudice and the praecipe is stricken *sua sponte* as not authorized by the rules of civil procedure and is necessary in order for the trial court to administer its trial cases.

The exclusive method of discontinuing an action before the trial court is pursuant to Pa.R.C.P. 229. "The de cision to grant a discontinuance without prejudice rests within the discretion of the trial court, and the ruling of the trial court will not be reversed absent an abuse of discretion." Foti v. Askinas, 639 A.2d 807, 808 (Pa. Super. 1994). Any discontinuance must be by leave of court but practice in Pennsylvania grants a party leave to discontinue if Pa.R.C.P. 229 is followed. Pohl v. NGK Metals Corp., 936 A.2d 43 (Pa. Super. 2007). A trial court may strike off a discontinuance to protect the rights of a party to the litigation. See Pa.R.C.P. 229(c); Hopewell v. Hendrie, 562 A.2d 899 (Pa. Super. 1998), appeal denied, 577 A.2d 890 (Pa. 1990). A party has a heavy burden in challenging the discretion of the trial court in striking a discontinuance. See Fancsali, ex rel. Fancsali v. Univ. Health Ctr. of Pittsburgh, 761 A.2d 1159 (Pa. 2000). A plaintiff commences a lawsuit and is generally in control of its advancement and may settle it, take it to trial or discontinue it before trial. Parties may even stipulate that a discontinuance is with or without prejudice. See Chamberlin of Pittsburgh, Inc. v. Fort Pitt Chemical Co., 352 A.2d 176 (Pa. Super. 1975). However, the language of Rule 229 does not permit one party to determine lack of prejudice when discontinuing an action. Foti v. Askinas, supra., specifically does not permit a discontinuance without prejudice unless by court order.




