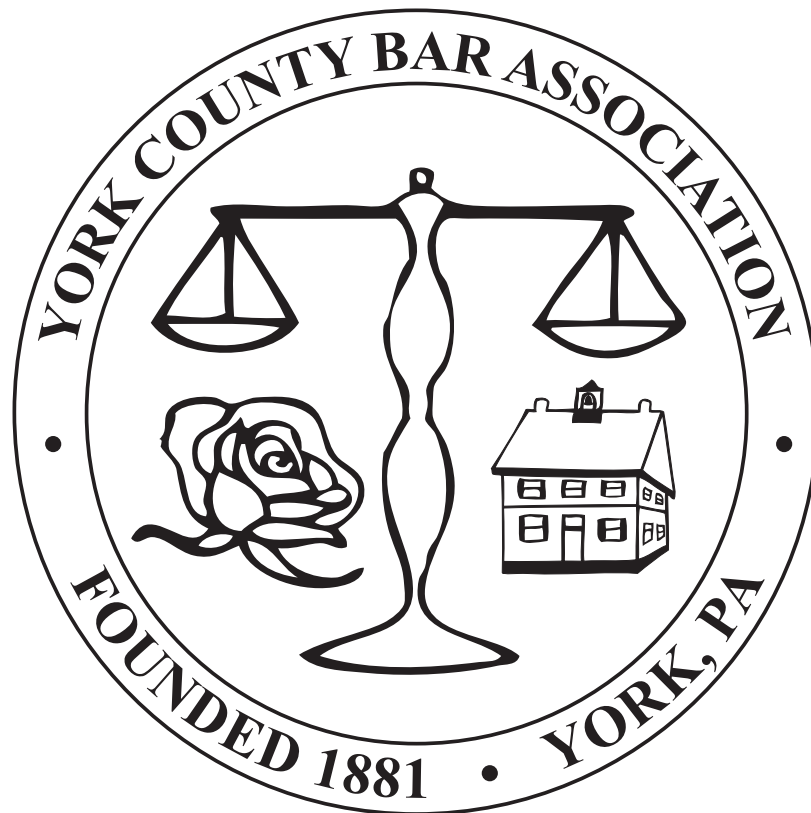

BAR LEGEND: A FEW THINGS ABOUT THE BAR AND ABOUT ME

Most people think of me as a native of York County, which is almost true. Actually, I was born in Phoenixville, Chester County, because my parents, who are true York County natives, assumed teaching positions in the area. A year and a half later we moved to Millersville and, when I was in ninth grade, “back” to York County with my younger brother and brand-new baby sister.

My uncle, Henry Leader, was practicing law which piqued my interest in the law as my chosen profession. After graduating from the Wharton School at the University of Pennsylvania I went to the University of Pennsylvania Law School and graduated in 1958. The same summer, I took the bar exam and was successful. Four new attorneys began practice in York County after passing that exam. The exam was very different than today. It consisted entirely of essay questions. It was held over consecutive days, and I believe that there were sixteen questions to be answered over two eight-hour days. There was a pass rate of approximately fifty percent. Of course, many of the unsuccessful applicants took the exam over and eventually passed.

I received my results while I was at Fort Knox taking basic training for the Army. (General Knox was a Continental Army and U.S. Army General. No naming rights angst there.) Military duty is worth mentioning because, at that time, all men upon reaching the age of 18 – yes, men only – were required to register for “the draft” and, if they had no acceptable reason not to serve, were likely to be drafted for two years of military service. One of the acceptable reasons was to join the Army National Guard, consisting of active duty for six months and part-time service for five and a half years, which I chose. I went to Officer Candidate School in 1960 and became a commissioned officer. Looking back, I feel good about my service and still find it to be appreciated by others. And a 10% discount on most products at Lowe’s isn’t bad!

Henry had joined Judge McLean Stock in the practice of law after returning from World War II and completing law school. I began practicing as law as an associate in March of 1959. When I joined, Emanuel (Mike) Cassimatis and J. Ross McGinnis were partners along with Judge Stock and Henry. Today, Stock and Leader has twenty-three lawyers.

They were only two women in my last school class. There was only one woman in the York County bar in my early practice, Jane Alexander, for whom a Bar Association award is named. This, of course, has changed dramatically, but it took all too long, just like the remediation of so many other injustices. In 1995–96, Maria Musti Cook, now one of our judges, served as the first female president of the York County Bar Association, a position that I held in 1981–82.

For many of my practicing years, every member of the York County bar knew every other member on a first name basis. It was a much smaller group which seemed to explode at one point, so that intimacy became a thing of the past. The contacts between lawyers while dealing with adversarial matters were cordial, with a few exceptions, and, from reports that I have heard, remain substantially so in York County. Unfortunately, things are more impersonal now.

For years there was a minimum fee bill, which did, for most transactional representations exactly what its name suggests: prevent fee cutting. I believe that the local bar associations set these fees and policed compliance. In practice, the minimum fee bill set the fees and was pretty much followed as written. Hence, it was often jokingly referred to as the maximum fee bill. I don’t recall how it ended, but it was utterly indefensible.

In my early years of practice, there was about one murder trial per year. They would be talk of going out to the sidewalk and pulling people into the courthouse to serve as jurors because they didn’t have enough names on the list. This may be apocryphal, but it made a good story. While we have larger population that is being served by the court system, the increased murder trial activity can’t be explained by popular growth alone.

I started as a general practitioner. Almost all lawyers in York County were such. By so-called ethical rules, lawyers weren't allowed to represent themselves as having a specialty or to do anything close to advertising. No asking for business in any way was allowed. Getting yourself out in the community, joining organizations, and impressing your acquaintances with your intellect, knowledge, and friendliness was about it. Everyone had a way. Of course, doing a good job for clients led to word getting around as well as repeat business.

After a few years, I concentrated on several areas, finally spending most of my time on municipal law and municipal bonds. I enjoyed acting as Bond Council because everyone was trying to get to the same place. I enjoyed municipal law and particularly enjoyed representing my principal municipal client, York Township. The people that I dealt with there were both competent and pleasant. Eventually, I became managing partner of the firm and remained so until becoming of counsel in 1999. Today, I am totally retired and my son, Steve, is managing partner.

Pennsylvania Continuing Legal Education Board Announces Formal Approval of CLE Credit for Pro Bono Service

HARRISBURG, PA | February 15, 2022

The Pennsylvania Continuing Legal Education Board has announced changes in rules and regulations that offer lawyers the option of completing a portion of their CLE requirement with credits earned through pro bono service.

By Supreme Court Order, Pa.R.C.L.E. Rule 108 (e) and related CLE Regulations have been updated to reflect this change.

The new amendments allow lawyers to earn one (1) CLE credit for every five (5) hours of pro bono service completed through an Accredited Provider of Pro Bono CLE. A maximum of three (3) credit hours earned in this manner may be applied towards the annual CLE requirement. Work is required to be completed through legal service providers accredited by the CLE Board and performed for a person of limited means or charitable organization. Organizations eligible for accreditation must be Pennsylvania based non-profits that receive funding for their pro bono programs from the Pennsylvania Interest on Lawyers Trust Accounts Board (IOLTA) or the Pennsylvania Legal Aid Network (PLAN). Organizations who do not receive funding from IOLTA or PLAN but maintain partnerships or referral relationship with IOLTA/PLAN grantees are also eligible for accreditation.

These amendments formalize rules and regulations for a model that was evaluated during a three-year pilot project from 2019-2021. During the trial period, twenty participating organizations coordinated with over 1,000 volunteers to report over 2,300 hours of CLE. These credits account for over 11,500 hours of pro bono service.

The CLE Board considers this initiative a successful blending of continuing education opportunities and efforts to serve Pennsylvanians in need. "The Board is quite pleased to administer our Supreme Court's vision of incorporating pro bono service into the continuing legal education mission," said Doug Ress, CLE Board Chair. "We look forward to maintaining and expanding our ongoing relationship with and support of PLAN, IOLTA and other accredited pro bono CLE providers for the mutual benefit of the Bar and the communities served."

The Pennsylvania Legal Aid Network endorses the CLE credit for pro bono initiative. "PLAN, Inc. and our statewide network of civil legal aid programs and projects are delighted that the Supreme Court has made this change permanent," said Max Laun, Interim Executive Director of PLAN. "Getting CLE credit for performing pro bono work is the best of both worlds: lawyers can meet their compliance obligations while doing good for underserved clients, and the clients and programs benefit as more lawyers take on this vital work."

The CLE Board is responsible for administering the rules pertaining to mandatory continuing education for attorneys. This responsibility includes monitoring attorney compliance with the CLE requirements and accrediting CLE providers and courses.
