Pamela A. Carlos Will Be A United States Magistrate Judge for the Eastern District of Pennsylvania

The United States District Court for the Eastern District of Pennsylvania announces that Pamela A. Carlos will be sworn in as a United States Magistrate Judge on November 12, 2021. She succeeds Magistrate Judge Henry S. Perkin and will sit in Allentown.

Prior to her appointment as a Magistrate Judge, Judge Carlos worked as an Assistant District Attorney for the Office of the District Attorney of Philadelphia where she finished her career in the Major Trial Division. In 1993, she joined the law firm of Bennett, Bricklin and Saltzburg, LLC. In 1997, Judge Carlos was elected a member at Bennett, Bricklin, the second female equity member since the firm's inception in 1946. Upon her membership, she was appointed head of the firm's Special Investigative Unit practice group.

With the increase of litigation following enactment of the Pennsylvania Bad Faith statute in 1990, Judge Carlos developed expertise in the areas of bad faith and insurance coverage litigation in both the state and federal courts. In 2004, she was appointed Chair of Bennett, Bricklin's Bad Faith and Insurance Coverage practice group, a position she held until her retirement in 2021. Judge Carlos has regularly lectured on insurance-related topics for a number of organizations including the Pennsylvania Bar Institute and the Defense Research Institute. In addition to her involvement in bad faith and insurance coverage litigation, Judge Carlos also continued to litigate complex casualty claims with a focus on sexual molestation litigation.

In 2009, Judge Carlos became the first woman elected to serve on Bennett, Bricklin's Executive Committee, which oversees management of all firm operations and departments. She also served as the Chair of the firm's Diversity Committee. During her leadership tenure, the firm experienced continuous growth in the area of diverse employment, gaining recognition in PaLaw's Annual Report on the State of the Profession, with respect to its percentage of minority and female attorneys.

Judge Carlos is a 1986 graduate of Franklin and Marshall College in Lancaster, Pennsylvania. She obtained her Juris Doctor from Temple University's Beasley School of Law in 1989, where she was also a member of the school's Moot Court Team.

The world became a brighter place on January 17, 1977 upon the announcement of the birth of Jonathan R. Hofstetter by his loving parents, Orray Hofstetter and Bonnie Yoder. Jon grew up in Milford Delaware, otherwise known as "lower, slower, Delaware", or "that place you pass on the way to the Delaware beaches". Growing up he loved working on his grandfather's farm and he loved all things baseball.

After Jon graduated from Greenwood Mennonite School he decided to use his talents to become a doctor and started pre-med at Eastern Mennonite University. Upon realizing his talents should not lead him to become a doctor, he decided to become a doctor of another type, and joined Eastern Mennonite University Seminary. Jon lived and breathed baseball, and he knew two strikes did not mean you were out. For his third time up to bat he decided to go for his Juris Doctorate at The Dickinson School of Law of Pennsylvania State University and hit a solid homerun.

Jon met Danielle Miller at EMU and soon with the exchanging of rings she became Danielle Hofstetter. Jon and Danielle were blessed with daughters Annika, Liv and Nadia and Jon was preceded in death by his infant daughter, Siri Grace Hofstetter. The Hofstetter girls were the center of his life and were even more important to him than baseball. If you talked with Jon and he was not discussing baseball, then he was definitely talking about his family. His family is what made him who he was and gave him the energy and ability to do all of the things he did. He loved them dearly.

In 2005 Jon started practicing law in Lancaster with Blakinger, Byler & Thomas PC, later known as Blakinger Thomas, PC. He focused mainly on real estate and business with most of his time working with our Amish and Mennonite farmers. Jon had an exceptional career in his short years that were more fulfilled than most of us will experience if we are blessed to practice three or four times as long. Jon would often educate us on the social etiquette for working with his clients, such as the appropriate place to relieve yourself in the barn, how to read the Amish phone book, where to advertise in the Busy Beaver and what type of muck boots were appropriate to wear. He was also an exceptional lawyer and knew his craft well.

He was very active in the community serving on many nonprofit boards over the years. He was faithful member of Mellinger Mennonite Church, and serving as an elder was one of his most prized board seats.

Jon was very social and loved people. If you were fortunate enough to know him or even meet him for fifteen minutes at the LBA holiday party, you would not forget him and your life would likely be better for the experience. He was often telling stories or cracking jokes. I know our lives were forever changed for the better for being able to work with him and call him our colleague, partner, worthy adversary, mentor and friend. During the time he was given to us he changed our practice, our community and our lives.

Jon passed from this life on February 24, 2020 to join the chorus that has gone before us. He shall be missed.

LANCASTER BAR ASSOCIATION MEMORIAL RESOLUTION IN HONOR OF DAVID R. KELLER

On Saturday, August 3, 2019, Dave's three children, his wife, Carol, and the extended family of David R. Keller lost a source of their comfort, humor, and encouragement - when Dave lost his lengthy battle with pancreatic cancer. He was 69 years old.

Born in Plainfield, N.J., to Richard and Frances Keller, Dave was educated in New Jersey and Philadelphia. He graduated with honors from Princeton University, then earned his J.D., magna cum laude, at Temple University School of Law.

Dave had three careers - excelling in each. His first was as husband to Carol for more than 40 years, as Dad to Eric, Drew, and Marley, and as grandfather to Isaac, Abraham, and Malachi.

Dave's second career was as a lawyer. He spent six years as a Senior Labor Management Relations Examiner with the National Labor Relations Board, six years as an attorney with Obermayer, Rebmann, Maxwell & Hippel in Philadelphia, but then more than 33 years at Barley Snyder, here in Lancaster - where he chaired the Labor & Employment Group and he then served as the firm's Managing Partner from 1993 to 2001. Dave also was recognized by his peers, chairing the Labor Law Section of the Pennsylvania Bar Association.

As a third career, Dave was a leader in the Lancaster County business community, fulfilling his stated perspective that, "Giving back to the community is an obligation." He was chosen to chair the boards of the Lancaster Chamber of Commerce, the Lancaster Alliance, the Economic Development Company of Lancaster, the Lancaster Workforce Investment Board, and the Lancaster Private Industry Council. His board memberships also included the United Way of Lancaster and the Visiting Nurse Association of Lancaster.

In 2018, the Lancaster Chamber of Commerce bestowed its annual "Exemplar Award" to David R. Keller. He was recognized as the individual in the Lancaster business community who best exemplified the Chamber's mission - by making significant contributions to the business community and by helping to improve Lancaster County's quality of life, through private sector enterprise.

To his family, his community, and to his colleagues at Barley Snyder, Dave selflessly and effectively was a servant leader and mentor. For himself, Dave looked to his predecessor as Managing Partner at Barley Snyder, saying, "I had one guiding principle as I heard John Shirk say it over and over again and it is, 'Do the right thing'."

Such a man blessed those who knew him socially as well as professionally. Those fortunate enough to play golf with Dave always won

- perhaps not on their scorecards, but in their conversations with Dave. Others shared Dave's appreciation for a fine cigar. How serendipitous that Barley Snyder was adjacent to the Demuth Tobacco Shop, in business since 1770.

Dave flourished in all three of his careers. In doing so, he succeeded in fulfilling words of wisdom that he heard from his own father. In 2018, Dave recalled, "My father told me that the secret of life is to be able to get up in the morning and look forward to what you plan to do. I have been able to do that throughout my career here [at Barley Snyder and in Lancaster County]."

Because of Dave, many in Lancaster County have been able to look forward to their daily lives also. We now are less, because he has left us, but we are so much more, because he was with us.

Dave is and will be missed.

Good afternoon. Thank you for coming to hear the Memorial Resolution I composed for Kirk Wolgemuth. My name is Hanna-Aurelia Levinson, formerly Dunlap. I am a lawyer and was Kirk's business partner for about 12 years.

I miss Kirk very much. He left us way too soon.

When we first started working together, we didn't really have many areas of law in common, but that didn't stop us. Honesty, integrity, and hard work was what kept us together. Kirk did employment law, ERISA, personal injury and some collections. (Having said "ERISA", I have exhausted my knowledge of the subject.) Kirk was really a hard worker. I did debt collection, mechanics liens and litigation.

Initially, we rented various locations, each pretty far from the downtown, thus not very satisfactory. Then we discovered that Gary Efstration had an office space for rent, close to the courthouse and we jumped at the opportunity.

Kirk was not only an excellent lawyer, but he was also an excellent partner and friend. He did many chores for me and always had my back. He drove me to hearings state and federal, because I am "Directionally challenged." When I damaged my foot, he mowed my lawn and prepared my garden for planting.

In his spare time, he liked to cook, and we would get together for "cooking sessions" in my house. Every year, we would buy quite a lot of cabbage at the Farm Wagon and make sauerkraut. We would get together with other sauerkraut-loving folks and work very hard at it. Kirk loved it. Life was good.

At some point, I moved out of our downtown office because it was time to think about retirement, at least partial. I decided to work out of my home office. Every morning I would go to the Post Office, where we had a PO Box for our business. I checked the mail, took pictures of all pieces and texted them to Kirk. Kirk lived in Mount Joy and if there was nothing urgent in the mail, and if he could do it, he would simply work from home that day.

Kirk developed a nasty back pain and had to have surgery. The recovery was going slowly, but he was getting better. Then one morning, I believe it was a Thursday, I went to the Post Office, took pictures of Kirk's mail and sent them to him. He would normally acknowledge receipt, but this time he didn't. Although Kirk was a creature of habit, I didn't think much of it until the next morning he didn't acknowledge receipt of his mail, either.

I started to worry. It wasn't like Kirk at all. I called him - no answer.

I then called his brother: Kirk had died. It was like being kicked in the stomach and as if a ton of bricks hit me. It is still hard to believe. I miss him.

May he rest in peace.
