

1. **INTENT**

Chambersburg Area School District (the "District") is soliciting proposals from qualified, licensed law firms to represent the District as Solicitor, including Pennsylvania School Code matters and litigation, excluding special counsel agreements and cases assigned by school district insurance carriers. The District anticipates entering into a three (3) year agreement with the selected law firm starting July 1, 2015.

2. **QUALIFICATION REQUIREMENTS**

Respondents to this RFP must meet the following minimum requirements:

- 2.1 Member in good standing of the Bar Association of the State of Pennsylvania.
- 2.2 Member in good standing of the Bar of the U. S. District Court, Middle District of Pennsylvania.
- 2.3 Must have experience with Federal and State Education laws and have a minimum of five (5) years working with or for Pennsylvania school districts in all areas of service required herein.
- 2.4 Ability to provide same day response.
- 2.5 Assignment of a lead attorney with appropriate experience.
- 2.6 A minimum of three attorneys with experience in education law.
- 2.7 Must have no conflict of interest in representing the Chambersburg Area School District.

3. **SCOPE OF SERVICES**

3.1 **Background Information**

The Chambersburg Area School District covers 250 square miles in Franklin County, Pennsylvania, near the center of the Cumberland Valley. More than 61,000 people live in the district, which is composed of the Borough of Chambersburg, Greene, Hamilton, Letterkenny, and Lurgan townships, and most of Guilford Township. With more than 9,000 students, the District is the 22nd largest in Pennsylvania, and ranks 37th out of 500 in geographic size.

The District comprises 384 acres of property and 1.5 million square feet of building space:

- 12 elementary schools
- 4 secondary schools
- 1 administration building
- 2 support service buildings
- 1 transportation building
- 1 alternative education building

3.2 Specific Tasks

- Although the District may elect to secure specialized legal services from other firms at its discretion, the successful legal firm will be prepared to provide services including, but not limited to:
- 3.2.1 Represent and advise the Board, District and individual staff members on detailed requirements in various areas of the law, including, but not limited to, educational, child custody and protection, subdivision and land development, zoning, utility, real estate and conveyancing, bankruptcy, construction management, debt collection, decedents' estates, and criminal law.
- 3.2.2 Consultation on personnel, labor relations, student discipline and general school law from its offices and in person. Telephone inquiries from District shall be responded to by an attorney within 60 minutes of receipt.

- 3.2.4 Representation during collective bargaining negotiations, both at the table and on a consulting basis, including mediation and arbitration.
- 3.2.5 Representation at meetings and before the School Board on school law matters, including student discipline hearing, employee discipline, non-renewals, reductions-in-force, dismissal, and expulsion hearings.
- 3.2.6 Representation of the District before the Franklin County Board of Assessment and Revision of Taxes, the Court of Common Pleas of the 39th Judicial District, Franklin County Branch, and the appellate courts of Pennsylvania in all aspects of direct tax assessment appeals, reverse tax assessment appeals, exemption appeals and PURTA appeals.
- 3.2.7 Representation of the District before the Office of Open Records, the Court of Common Pleas of the 39th Judicial District, Franklin County Branch, and the appellate courts of Pennsylvania under the Pennsylvania Right-To-Know Law.
- 3.2.8 When appropriate, review of student records, proposed and existing IEP's and case files, including an initial assessment of all potential appeals.

4. TIMEFRAME

The successful legal firm will be expected to commence the provision of services commencing July 1, 2015 and the term of the resultant contract will be for three years.

5. **PROJECT MANAGEMENT**

The Superintendent or designee shall manage the contract for the District.

6. **PROPOSALS**

Respondents to this RFP are hereby notified that all proposals submitted and information contained therein and attached thereto will not become public information until selection of the successful respondent.

6.1 **Submission and Deadline**

All proposals must be received by Thursday, April 30, 2015. The District requests that all firms furnished a copy of this RFP, but deciding not to offer a Proposal to the District, submit a negative reply. The District requests specific comments and observations.

Section 1: Submittal Letter

Respondents shall submit a cover letter, addressed to the Business Manager, signed by an authorized principal or agent of the law firm, which provides an overview of the respondent's offer, as well as the name, title and phone number of the person to whom the District may direct questions concerning the proposal. The letter should also include a statement by the respondent accepting all terms and conditions contained in this RFP, signed by an officer or other individual with authority to bind the firm.

Section 2: Experience

Respondents are to provide a summary of the firm's experience on similar types and sizes of engagements with emphasis on school districts in the State of Pennsylvania, and detail on experience with public sector employment law, and education law. Section 4: Budget/Fee Proposal

All respondents are required to complete and submit a detailed itemized fee schedule and expected schedule of payment to perform all services. The fee schedule shall include services for bond issues and other capital borrowing. The District requests the fee in the form of an annual retainer, against which discounted rates will be billed. 8.3 **Conditions**

- 8.3.1 The selected legal firm must have an office or facility in Pennsylvania. The specific location of the facility must be identified in the proposal submitted.
- 8.3.2 Have personnel/resources reserve sufficient to assure service continuity, and agree to maintain an adequate level of qualified personnel for the term of the Agreement.
- 8.3.3 Agree to maintain and preserve confidentiality in all matters relating to the resultant contract and services provided under it.
- 8.3.4 Agree that the District and the legal firm may terminate the contract at any time with ninety (90) days written notice. Respondents shall provide a statement that no attorney affiliated with respondent has, within five years from the date of submission, been disciplined by the Grievance Committees of the State or Federal Bar.

12. AFFIRMATIVE ACTION STATEMENT
