U.S. BANKRUPTCY JUDGESHIP VACANCY District of Delaware

Chief Judge Michael A. Chagares of the United States Court of Appeals for the Third Circuit announces the application process for a bankruptcy judgeship in the District of Delaware, seated in Wilmington. A bankruptcy judge is appointed to a 14-year term pursuant to 28 U.S.C. § 152.

To be qualified for appointment an applicant must:

- (a) Be a member in good standing of the bar of the highest court of at least one state, the District of Columbia, or the Commonwealth of Puerto Rico and every other bar of which they are members.
- (b) (1) Possess and have a reputation for integrity and good character; (2) possess and have demonstrated a commitment to equal justice under the law; (3) possess and have demonstrated outstanding legal ability and competence; (4) indicate by demeanor, character, and personality that they would exhibit judicial temperament if appointed; and (5) be of sound physical and mental health sufficient to perform the essential duties of the office.
- (c) At the time of the initial appointment, not be related by blood or marriage, within the degrees specified in 28 U.S.C. § 458, to (1) a judge of the United States Court of Appeals for the Third Circuit, (2) a member of the Judicial Council of the Third Circuit, or (3) a judge of the district court to be served.
- (d) Have been engaged in the active practice of law for a period of at least five years. The Judicial Council may consider other suitable legal experience as a substitute for the active practice of law.

The selection process will be confidential and competitive. At present, the annual salary for this position is \$205,528. Applicants shall be considered without regard to race, color, sex, gender, gender identity, pregnancy, sexual orientation, religion, national origin, age (40 years and over), or disability. The name of the person selected will be submitted to the Director of the Administrative Office, who shall request background reports by the Federal Bureau of Investigation (FBI) and the Internal Revenue Service (IRS). In addition, a nominee for a bankruptcy judgeship may be required by the court of appeals to complete a preliminary disclosure statement that includes questions seeking sensitive financial and personal information. The disclosure must be filed with the court of appeals and will be kept confidential. The individual selected must comply with the financial disclosure requirements pursuant to the Ethics in Government Act of 1978, Pub. L. No. 95-521, 92 Stat. 1824 (1978) (codified as amended at 5 U.S.C. app. §§ 101-111).

The application process is entirely automated. No paper applications will be accepted. Applications must be submitted electronically by **noon on June 30, 2022**. Applications must be submitted only by the applicant personally, indicating the applicant's willingness to serve if selected. OPINION BY: ASHWORTH, P.J., JANUARY 3, 2022. Before the Court is Nicky Israel Cruz's pro se petition filed pursuant to the Post Conviction Relief Act (PCRA), 42 Pa. C.S.A. §9541-46. For the reasons set forth below, this petition will be dismissed without a hearing.¹

I. PROCEDURAL BACKGROUND

On June 22, 2017, Cruz was charged at Information No. 2840-2017 with delivery of heroin and criminal use of a communications facility,² stemming from criminal activity occurring in the City of Lancaster, Lancaster County, Pennsylvania, whereby Cruz delivered approximately six packets of heroin to a confidential informant on or about March 1, 2017. On June 26, 2017, Cruz was further charged at Information No. 284-2017 with possession with intent to deliver heroin, and the misdemeanor offenses of possession of marijuana and possession of drug paraphernalia, stemming from events occurring on East Chestnut Street in the City of Lancaster on or about April 7, 2017.³ Dennis Dougherty, Esquire, was court-appointed to represent the indigent Cruz on all charges.

On February 23, 2018, Cruz filed a motion in limine to preclude certain testimony related to the underlying probable cause at Docket 2841-2017. An evidentiary hearing was ultimately held on that motion on October 21, 2019, after which the Court issued an Order on October 25, 2019, denying the motion in limine in its entirety. Cruz next filed a motion on October 29, 2019, to compel the Commonwealth to produce the identity of its confidential informant for the charges at Docket 2841-2017, which the Court denied by Order of November 5, 2019. On January 7, 2020, the Commonwealth filed a Notice of Intent to consolidate the two dockets for trial.

On January 27, 2020, Cruz appeared before the undersigned and tendered an open guilty plea on both dockets. After an extensive oral colloquy conducted on the record,⁴ the Court accepted both guilty

Under Pa. R.Crim.P. 907, a PCRA court may dispose of post-conviction collateral relief petitions without a hearing if it is satisfied after reviewing the materials submitted that no genuine issues of material fact exists and that petitioner is not entitled to relief. Cruz initially appeared on January 27, 2020, prepared to proceed with a jury trial. Prior to empaneling

pleas, finding that Cruz entered his pleas knowingly, intelligently, and voluntarily. Cruz then waived his right for a presentence investigation and stood for sentencing that same day. The Court sentenced Cruz on combined dockets to an aggregate term of incarceration of two to five years in a state correctional institution, plus costs.⁵ N.T. at 20-22. Cruz was not eligible for a Recidivism Risk Reduction Incentive ("RRRI") sentence due to the nature of his prior convictions. No post sentence motion was filed, and no appeal was taken.

Acting *pro* se, Cruz filed a timely⁶ petition for post-conviction collateral relief on November 5, 2020,⁷ challenging his guilty pleas. Pursuant to Rule 904(A) of the Pennsylvania Rules of Criminal Procedure, Daniel C. Bardo, Esquire, was appointed to represent Cruz on his collateral claims and was granted leave to file an amended petition by January 12, 2021. Upon request of PCRA counsel, the deadline was twice extended. Ultimately, after a careful and conscientious review of the entire record, PCRA counsel concluded that the petition did not present any issues of arguable merit and was frivolous as a matter of law. Accordingly, on April 12, 2021, a "no merit" letter⁸ and motion to withdraw was filed with the Court.

After reviewing the pro se PCRA petition, counsel's "no merit" letter, and conducting an independent review of the record, the Court found there were no disputed issues of fact, Cruz was not entitled to post conviction collateral relief, and no purpose would be served by any further proceedings. Therefore, pursuant to Pa. R.Crim.P. 907 (1), the Court filed a notice of intent to dismiss the PCRA petition without a hearing, allowing Cruz additional time within which to file an amended petition or to otherwise respond to the court's Notice. No response by Cruz has been filed, and this matter is ripe for adjudication.

II. DISCUSSION

Initially, the Court notes that Cruz does not actually raise any issues in his pro se PCRA petition, choosing instead to rely on appointed

a jury, however, the Court discussed with Cruz his options for pleading and provided him time to discuss the same in private with his attorney. Notes of Testimony ("N.T.") at 2-7. After conferring with trial counsel during a recess of approximately 45 minutes, Cruz informed the Court of his decision to enter an open plea of guilty. *Id.* at 7. During the recess, Cruz and his counsel had reviewed, completed, and signed the seven-page written Guilty Plea Colloquy, which

the Court officially entered as part of the record. Id. at 12-13.
Specifically, at Docket No. 2840-2017, Cruz was sentenced to the following: 2 to 5 years' incarceration on Count One (PWID); and 1 to 2 years' incarceration on Count Two (criminal use of communication facility), to be served concurrent to Count One. At Docket No. 2841-2017, Cruz was sentenced to the following: 2 to 5 years' incarceration on Count One (PWID), to be served concurrent to the sentences at Docket 2840-2017; 6 to 12 months' incarceration on Count Two (possession of marijuana); and 30 days' incarceration on Count Three (use/possession of drug parapherna-lia); both Counts Two and Three to be served concurrent with Count One.

⁽iii); both Counts Iwo and Three to be served concurrent with Count One. 6 Pursuant to 42 Pa.C.S.A. § 9545(b), a petition for relief must be filed within one year of the date the judg-ment of sentence becomes final. For purposes of the PCRA, a judgment of sentence becomes final at the conclusion of direct review, including discretionary review in the Supreme Court of Pennsylvania, or at the expiration of the time for seeking such review. Id. at § 9545(b)(3). See also Commonwealth v. Jones, 54 A.3d 14, 17 (Pa. Super. 2012). As Cruz did not file a notice of appeal with the Pennsylvania Superior Court, his judgment of sentence became final on February 27, 2020, when the period for filing an appeal with the Superior Court expired (30 days after the guilty plea and sentencing hearing on January 27, 2020). ⁷ Pursuant to the "prisoner mailbox rule" the pleading is deemed filed on the date of mailing rather than the date of docketing. See Commonwealth v. Crawford, 17 A.3d 1279, 1281 (Pa. Super. 2011) ("Under the prisoner mailbox rule, we deem a pro se document filed on the date it is placed in the hands of prison authorities for mailing."). Unfortunately, the envelope in which the instant petition was sent to the Court is no longer available, rendering it is impossible to discern the precise date of posting. wealth v. Finley, 379 Pa. Super. 390, 550 A.2d 213 (1988), and their progeny.

counsel to review the record and raise any issues of arguable merit on his behalf. Counsel found none. Nonetheless, the Court has undertaken a careful, independent review of the record and is satisfied and agrees that there are no issues of merit that could be raised.

Generally, "a plea of guilty amounts to a waiver of all defects and defenses except those concerning the jurisdiction of the court, the legality of the sentence, and the validity of the guilty plea." *Commonwealth v. Morrison*, 173 A.3d 286, 290 (Pa. Super. 2017) (citation omitted). There are no grounds for challenging the jurisdiction and authority of this Court to prosecute Cruz. Neither does the record support an allegation that the individual sentences imposed on Cruz were not legislatively permitted.⁹ Rather, the only possible basis for post-conviction collateral relief under the PCRA would be that Cruz's guilty pleas were not knowingly, voluntarily, and intelligently made; no evidence to support such a claim exists here.

In assessing the validity of a guilty plea, our Superior Court has noted that "[t]he law does not require that [the defendant] be pleased with the outcome of his decision to enter a plea of guilty; rather [a]ll that is required is that [the defendant's] decision to plead guilty be knowingly, voluntarily and intelligently made." *Commonwealth v. Brown*, 48 A.3d 1275, 1277 (Pa. Super. 2012) (citations and internal quotation marks omitted).

> With regard to the voluntariness of a plea, a guilty plea colloquy must affirmatively demonstrate the defendant understood what the plea connoted and its consequences. Once the defendant has entered a guilty plea, it is presumed that he was aware of what he was doing, and the burden of proving involuntariness is upon him.

Commonwealth v. Willis, 68 A.3d 997, 1002 (Pa. Super. 2013) (citations and internal quotation marks omitted). In determining whether a defendant entered into a plea of guilty knowingly, voluntarily, and intelligently, the court "is free to consider the totality of the circumstances surrounding the plea, . . . including, but not limited to, transcripts from other proceedings, 'off-the-record' communications with counsel, and written plea agreements." *Commonwealth v. Allen*, 557 Pa. 135, 146-47, 732 A.2d 582, 588-89 (1999). Moreover, "[a] defendant is bound by the statements made during the plea colloquy, and a defendant may not later offer reasons for withdrawing the plea that contradict statements made when he pled." *Brown*, 48 A.3d at 1277. Where the defendant enters his plea_on the advice of counsel, "[t]he voluntariness of [the] The individual sentences imposed by this Court on Cru are clearly legal sentences as the fall well below the permissible statutory maximums. A person convicted of the felony offense of PWID heroin "shall be sentenced to imprisonment not exceeding fiften years, or to pay a fine not exceeding two hundred fifty thousand dollars (\$250.000). or both or such larger amount as is sufficient to exhaust the assets utilized in and the profits obtained from the illegal activity." 35 Pa.CS.A. §780-113(f)(1). Thus, Cruz's sentence of just 2 to 5 years' incarceration on each of his PWID charges (running concurrently) is clearly a legal sentence. The criminal use of a communication facility carries a maximum statutory maximum.

plea depends on whether counsel's advice was within the range of competence demanded of attorneys in criminal cases." *Commonwealth v. Lynch*, 820 A.2d 728, 732 (Pa. Super. 2003) (citation omitted).

To analyze the voluntary, knowing and intelligent nature of Cruz's plea, the Court examines the totality of the circumstances surrounding it. The procedure for pleas and plea agreements is set forth in Rule 590 of the Pennsylvania Rules of Criminal Procedure. Before a trial court may accept a plea of guilty, it must determine, after inquiry of the defendant, that the plea is voluntarily and understandingly tendered. Pa.R.Crim.P. 590(A)(3).¹⁰ The comment to this Rule notes that "at a minimum," the judge should ask the following questions in the guilty plea colloquy: (1) Does the defendant understand the nature of the charges to which he is pleading guilty; (2) Is there a factual basis for the plea; (3) Does the defendant understand that he has the right to trial by jury; (4) Does the defendant understand that he is presumed innocent until he is found guilty; (5) Is the defendant aware of the permissible range of sentences and/or fines for the offenses charged; and (6) Is the defendant aware that the judge is not bound by the terms of any plea agreement tendered unless the judge accepts such agreement. Commonwealth v. Hart, 174 A.3d 660, 667 (Pa. Super. 2017). Our Supreme Court has held that inquiry into these six areas is essential to ensure a knowing, voluntary and intelligent plea. Commonwealth v. Flanagan, 578 Pa. 587, 605, 854 A.2d 489, 500 (2004).

The comment to Rule 590 does allow that a determination into these areas may be accomplished by a written colloquy that is "read, completed, signed by the defendant, and made part of the record of the plea proceedings," supplemented by some on-the-record oral examination. In this case, the undersigned did specifically inquire into the six designated areas identified above (N.T. at 8-14), and Cruz also completed a seven-page written colloquy through which he manifested his understanding of the offenses against him, the maximum sentences, and the procedural due process rights waived by a guilty plea. (Id. at 12-13). Cruz indicated that he reviewed the colloquy form with his attorney and signed it. (Id.). Thus, the record clearly establishes that Cruz was aware of his charges (Id. at 9-11), that he understood the nature of these charges (Id.), that he was giving up his right to a jury trial and the presumption of innocence (Id. at 9). Moreover, Cruz indicated that he knew he did not have to plead guilty and that it was his voluntary decision to plead guilty. (Id.); see also Guilty Plea Colloquy at ¶¶ 10, 49. Cruz denied being forced to plead guilty, and indicated that it was his decision to plead guilty of his own free will. (Id. at $\P\P$ 50-51).

As required by Pa.R.Crim.P. 590, this Court must also satisfy itself that there is a factual basis for the plea. *Commonwealth v. Fluharty*, 429 Pa. Super. 213, 219, 632 A.2d 312, 315 (1993). In the instant case, there was substantial independent evidence of guilt on both dockets, as acknowledged by Cruz and his counsel.¹¹ (N.T. at 14-16).

Rule 590 provides in relevant part: "The judge . . . shall not accept [a plea of guilty] unless the judge determines after inquiry of the defendant that the plea is voluntarily and understandingly tendered. Such inquiry shall appear on the record." Pa.R.Crim.P. 590(A)(3).

¹¹ The Commonwealth represented that on March 1, 2017, Cruz was observed and video recorded

In light of the totality of the circumstances surrounding the pleas in this case, it is clear that there was a sufficient factual basis to support both guilty pleas. By the nature, extent, and tone of the guilty plea hearing, and especially the discussions held by the Court directly with Cruz and trial counsel on the record, this Court was well satisfied that Attorney Dougherty had fully executed his duties in advising Cruz of the nature of the charges and the possible consequences of his plea. Thus, considering all the circumstances attendant to the pleas, including the adequacy of the written and oral plea colloquies, Cruz's responses therein, and the representations by Cruz's trial counsel, the guilty pleas were entered knowingly, voluntarily, and intelligently.

III. Conclusion

For the reasons set forth above, Nicky Israel Cruz's *pro se* PCRA petition fails to state any issues of merit and must be denied and dismissed without further proceedings.

Accordingly, I enter the following:

delivering six marked bags of heroin to a confidential informant. (N.T. at 14-15). On April 7, 2017, a search warrant was executed on Cruz's residence, at which time a small amount of marijuana, scales, a glass pipe, \$1,061.00 in cash, and 30 bags of heroin were discovered and seized. (*Id. at 15*). These heroin bags were marked consistently with those Cruz had previously delivered to the confidential informant on March 1, 2017. (*Id.*)

ORDER

AND NOW, this 3rd day of January, 2022, upon consideration of Nicky Israel Cruz's *pro se* petition for post-conviction collateral relief, it is hereby ORDERED that said petition is DENIED without a hearing. There are no genuine issues concerning any material fact, Cruz is not entitled to post conviction collateral relief, and no purpose would be served by any further proceedings.

Further, the no-merit letter of Defendant's court-appointed attorney, Daniel C. Bardo, Esquire, states that the *pro se* petition is lacking in merit as a matter of law, a conclusion with which the Court agrees after its independent review of the record. Accordingly, Mr. Bardo is GRANTED his request for leave to withdraw as counsel.

Pursuant to Pa. R.Crim.P. 907(4), this Court advises Cruz that he has the right to appeal from this Order. Cruz shall have **30 days** from the date of this final Order to appeal to the Superior Court of Pennsylvania. **Failure to appeal within 30 days will result in the loss of appellate rights.**

It is further ORDERED that Cruz shall have the right, if indigent, to appeal *in forma pauperis* and to proceed with assigned counsel as provided in Pa. R.Crim.P. 122.
