# PIKE COUNTY DISTRICT ATTORNEY PRESS RELEASE PIKE COUNTY SENTENCING INFORMATION

October 3, 2019 — Pike County District Attorney Raymond J. Tonkin announced the following criminal sentences were issued by Pike County Court of Common Pleas President Judge Gregory Chelak:

Christopher Thomas Kerkhoven, age 30, of Swartswood, NJ, was sentenced to 72 hours to 6 months in the Pike County Jail, fined \$1,000.00 and had his driver's license suspended for 12 months for the crime of Driving Under the Influence. The state police stopped Kerkhoven on November 21, 2018, for speeding along SR 739. Upon speaking with Kerkhoven, the trooper detected the smell of Marihuana. Kerkhoven admitted to recently smoking Marihuana. Field Sobriety Tests were conducted which showed impairment and a blood draw confirmed the presence of Cannabinoids in Kerkhoven's blood.

Kareem R. Dallas, age 29, of East Stroudsburg, PA, was sentenced to a \$500.00 fine for the crime of Disorderly Conduct for creating a physically offensive condition towards two individuals which served no legitimate purpose.

Steven Michael Simkin, age 23, of Bronx, NY, was sentenced to 6 months of probation and fined \$300.00 for the crime of Possession of Drug Paraphernalia. The state police were dispatched to the park and ride along SR 739 in Delaware Township on April 27, 2019, for a report of drag racing. In speaking with Simkin, the trooper detected the smell of Marihuana. Through a probable cause search, the trooper uncovered a vape pen, grinder and a soda can ashtray in Simkin's possession.

Rebecca Lee Brojakowski, age 34, of Carbondale, PA, was sentenced to 72 hours to 6 months in the Pike County Jail, fined \$1,000.00 and had her driver's license suspended for 12 months for the crime of Driving Under the Influence of a Controlled Substance. Brojakowski was stopped by the state police for following another vehicle too closely along I-84 in Blooming Grove Township on May 26, 2018. Upon speaking with Brojakowski, the trooper detected the smell of Marihuana, and observed her to have dilated pupils, bloodshot eyes and droopy eyelids. Field Sobriety Tests indicated impairment and a blood test confirmed the presence of THC in her blood.

Kenneth John Soule, age 46, of Tamiment, PA, was sentenced to 10 months to 23 months in the Pike County Jail, followed by 2 years of probation and a fine of \$1,200.00 for 2 counts of the crime of Terroristic Threats, and 2 counts of Simple Assault. During a domestic dispute at a residence in Lehman Township on April 17, 2018, Soule threatened to kill an individual. During a domestic dispute at a residence in Lehman Township on November 7, 2018, Soule inflicted bodily injury upon an individual, squeezing her mouth making it difficult to breathe and threatened her.

Bryan Thomas Engvaldsen, age 47, of Hawley, PA, was sentenced to 100 days to 2 years in the Pike County Jail, fined \$1,025.00 and had his driver's license suspended for 24 months for the crimes of Driving Under the Influence, Driving While

Operating Privilege is Suspended or Revoked and Immediate Notice of Accident to Police Department. Engvaldsen struck a pole with his vehicle in a development in Lackawaxen Township on April 29, 2019, and fled the scene, failing to notify the police of the accident. The state police located Engvaldsen walking in the woods and observed him to have glassy, bloodshot eyes and emanating the smell of an alcoholic beverage. Engvaldsen refused a breath test. He was also found driving on a suspended license.

Gregory Alan Krisanda, age 52, of Matamoras, PA, was sentenced to 90 days to 5 years in the Pike County Jail, fined \$1,500.00 and had his driver's license suspended for 18 months for the crime of Driving Under the Influence. Eastern Pike Regional Police Department responded to a three vehicle crash involving Krisanda along Route 6 & 209 in Westfall Township on October 1, 2018. While speaking with Krisanda, the officer detected the smell of an alcoholic beverage. Field Sobriety Tests were conducted which showed impairment and a breath test confirmed a blood alcohol content between .10% and .16%.

Andrew Patrick O'Donnell, age 32, of Lackawaxen Township, PA, was sentenced to 10 days to 6 months in the Pike County Jail, fined \$1,000.00 and had his driver's license suspended for 12 months for the crime of Driving Under the Influence. The state police responded to a one-vehicle crash involving O'Donnell at the Dingman Bridge Toll Plaza on February 1, 2017. O'Donnell was observed to have bloodshot eyes and constricted and nonresponsive pupils. Field Sobriety Tests showed impairment and a blood test confirmed the presence of Cocaine, Fentanyl and THC in O'Donnel's blood.

Ryan Benjamin Cole, age 26, of Milford, PA, was sentenced to 6 months of probation and fined \$300.00 for the crime of Possession of Drug Paraphernalia and the Summary Offense of Harassment. The state police responded to Log Tavern Road in Dingman Township on December 29, 2018, where Cole was involved in a domestic dispute during which he threatened violence against an individual. Cole was also found in possession of a baggie which contained Marihuana.

Nicholas Barbella, age 55, of Dingmans Ferry, PA, was sentenced to 1 day to 2 days in the Pike County Jail and fined \$500.00 for the crime of Harassment. During a domestic dispute at a residence in Delaware Township on January 9, 2019, Barbella threatened an individual.

Zina Aniela Mieszkuc, age 36, of Port Jervis, NY was sentenced to a fine of \$500.00 for the crime of Disorderly Conduct. On November 19, 2018, along Pennsylvania Avenue in Westfall Township, Mieszkuc caused a public annoyance or alarm when she created a physically offensive condition through an act which served no legitimate purpose.

Tyler Jon Tooley, age 27, of Matamoras, PA, was sentenced to 12 months of probation and fined \$300.00 for the crime Theft. Tooley took \$1,595.14 from a business in Matamoras, while an employee between August 2, 2014 and August 13, 2014.
