SUMMARY OF OPINION:

After counsel for the parties had represented to the court that the trial of this matter would last three weeks, and an Order was issued on December 20, 2016, scheduling this case for a jury trial during the three week period from October 30, 2017, through November 17, 2017, defendants suddenly disclosed on August 9, 2017, that four trial weeks or twenty trial days would be required "for Defendants' case only." Although the ability to present an opening statement and a closing argument is part of the constitutional right to representation by an attorney in civil cases, Pa.R.C.P. 223(3) vests trial courts with the authority to issue orders "regulating the number and length of addresses to the jury or to the court." Under Rule 223(2), trial courts also may implement orders limiting the number of attorneys representing the same group of parties who may examine witnesses during the trial. Consequently, in order to ensure that the trial was concluded within the allotted time period, counsel for the twelve defendants were assigned an aggregate period of 180 minutes within which to present all their opening statements, and a comparable collective period of 180 minutes within which to deliver their closing arguments for all defendants. Additionally, defendants were required to designate one counsel to conduct on behalf of all defendants the cross-examination of plaintiffs' witnesses, with the exception of any expert witnesses who would proffer opinions on liability as to more than one defendant.

SUMMARY OF OPINION:

The original mortgagee's assignee filed a motion for summary judgment in this mortgage foreclosure action against a commercial borrower that defaulted on its monthly note and mortgage payment obligations, as a result of which the assignee thereafter accelerated the loan debt in accordance with the note and mortgage provisions. To secure summary judgment, the assignee was required to establish that there were no genuine issues of material fact that (1) the commercial borrower was in default and failed to pay interest on the obligation, (2) the recorded mortgage was in the stated amount of the underlying note, and (3) the assignee owned or held the note and owned the mortgage by virtue of a duly recorded assignment. Even when the record was viewed in the light most favorable to the commercial borrower as the nonmoving party, it reflected no genuine issue of material fact with regard to the default, the recorded mortgage, the assignee's ownership and possession of the original note, and the assignee's ownership of the mortgage via a properly recorded assignment§. Therefore, the assignee was entitled to judgment in its favor as a matter of law, and its motion for summary judgment was granted in the amount of \$9,166,404.76.
