Reynoldsville Borough Council will be formally adopting several ordinances related to the following topics at its regular meeting on Monday, November 18, 2024 at 7:00 p.m. The meetings are open to the public and held at the fire hall.

 AN ORDINANCE DEFINING AND REGULATING THE SITING OF, USAGE OF, AND STORAGE OF RECREATIONAL VEHICLES WITHIN THE BOROUGH OF REYNOLDSVILLE. The ordinance will contain a provision setting forth criminal and civil penalties for violations of this Ordinance. Each criminal violation shall be a summary offense, the maximum period of incarceration shall be thirty (30) days, and the applicable fine shall be a maximum of \$300.00 per violation. Each civil violation shall be subject to a \$25.00 penalty at the discretion of the Borough Code Enforcement Officer.

 AN ORDINANCE WHICH ADDRESSES THE USE AND DISPLAY OF FIREWORKS WITHIN THE BOROUGH OF REYNOLDSVILLE. The ordinance will contain a provision setting forth criminal penalties for persons or entities using Display Fireworks in violation of this Ordinance. Each separate violation shall be subject to a fine of not more than \$1,000.00 and a term of imprisonment not to exceed ninety (90) days. Each separate date that a violation occurs shall be deemed a separate violation.
- AN ORDINANCE RELATING TO THE LICENSING OF AMUSEMENT DEVICES LOCATED WITHIN THE BOROUGH OF REYNOLDSVILLE. The ordinance will contain a provision requiring a yearly license fee for PA Skill, Video Poker, and similar machines which offer payment to players in the form of cash, credit, bitcoin or similar remuneration. The yearly licensing fee shall be \$350 per game/machine.
- AN ORDINANCE WHICH AMENDS THE EXISTING VACANT PROPERTY REGISTRATION ORDINANCE WITHIN THE BOROUGH OF REYNOLDSVILLE. The ordinance will amend the definition of "vacant property" and amend the registration fees that are payable on a yearly basis.
