## Bradford Crossing Homeowners Assoc., Inc. v. DeSimone

Petition practice – Motion to make rule absolute – Service of process

- 1. The Chester County Rules of Civil Procedure provide that if no answer has been timely filed, the petitioning party, not less than five (5) days after the rule return date, may move to have the rule made absolute, granting the prayer of the petition, and the Court may consider such petition as unopposed and grant such motion as of course.
- 2. A judgment is void when entered by a court lacking personal jurisdiction obtained pursuant to proper service of original process, waiver, or consent.
- 3. It is the general rule that original process may be served (a) by handing a copy to the defendant; or (b) by handing a copy (i) at the residence of the defendant to an adult member of the family with whom he resides; but if no adult member of the family is found, then to an adult person in charge of such residence; or (ii) at the residence of the defendant to the clerk or manager of the hotel, inn, apartment house, boarding house or other place of lodging at which he resides; or (iii) at any office or usual place of business of the defendant to his agent or to the person for the time being in charge thereof.
- 4. Plaintiff initiated the action by filing a complaint as well as a petition for special relief in the nature of a preliminary injunction. Plaintiff obtained a Rule *per curiam* requiring defendant's response to the petition within twenty days. Thereafter, plaintiff filed a motion to make rule absolute, which was unopposed. The Court *Held*, that the motion was denied without prejudice as the record did not indicate original service of process, waiver of right to proper service or consent to jurisdiction.

## **MEMORAND**UM

Plaintiff Homeowner's Association commenced this action by Complaint filed August 16, 2023 against Robert DeSimone to repair the windows and siding of the property he owns at 34 Woodstream Drive, Wayne, PA 19087.¹ Plaintiff asks this court to enjoin Defendant to allow Plaintiff access the exterior and interior of the property to make repairs. Complaint, 8/16/2023, ¶¶ 15, 24 (wherefore clause). Plaintiff also seeks from Defendant estimated repair costs of \$7,800.00 together with fines, late fees, and attorneys' fees totaling \$23,749.23 or more. Complaint, 8/16/2023, ¶¶ 21, 24. On August 16, 2023, Plaintiff filed Plaintiff's Petition for Special Relief in the Nature of a Preliminary Injunction seeking access to the property. On August 17, 2023, Plaintiff obtained a Rule, *per curiam*, pursuant to C.C.R.C.P. 206.4(c)(1) requiring Defendant's response to the Petition within twenty days.

On October 31, 2023, Plaintiff filed its Motion to Make Rule Absolute Pursuant to C.C.R.C.P. Rule 206.4(c)(4) which is presently before this court. Plaintiff averred that the Petition and Rule were served on Robert DeSimone on October 4, 2023 and that no timely response has been filed to the Petition. Motion, 10/31/2023, ¶¶ 3-5.

The Chester County Rules of Civil Procedure provide that "[i]f no answer has been timely filed, the petitioning party, not less than five (5) days after the rule return date, may move to have the rule made absolute, granting the prayer of the petition, and the Court may consider such petition as unopposed and grant such motion as of course." C.C.R.C.P. 206.4(c)(4). However, a judgment is void when entered by a court lacking personal jurisdiction obtained pursuant to proper service of original process, waiver, or consent. See, e.g., Sharpe v. McQuiller, 206 A.3d 1179, 1184 (Pa. Super. 2019). Here, nothing of record indicates that Robert DeSimone was properly served with original process. The Sheriff's Return for October 4, 2023 indicates the reinstated Complaint and the Petition<sup>2</sup> were served at the property on Daira Hertel<sup>3</sup> but nothing of record indicates that Robert DeSimone resides at the property and thus the service attempted is outside the scope of the general rule controlling original service of process.4 Moreover, nothing of record indicates that Robert DeSimone has waived his right to proper service or consented to this court's jurisdiction. This court cannot grant Plaintiff's Motion because this court lacks personal jurisdiction over Defendant and any judgment entered in Plaintiff's favor would be void.

Accordingly, for the reasons set forth above this court will enter an order denying Plaintiff's Motion to Make Rule Absolute Pursuant to C.C.R.C.P. Rule 206.4(c)(4) without prejudice.<sup>5</sup>

Plaintiff alleged that the property is occupied by a tenant. Complaint, 8/16/2023, ¶ 14.

live at the property. See Return of Service, 9/14/2023, p. 1. Ms. Hertel's representation comports with Plaintiff's averment at  $\P$  14 of the Complaint that Robert DeSimone owns the property but rents it to others.
