U.S. BANKRUPTCY JUDGESHIP VACANCY District of Delaware

Chief Judge Michael A. Chagares of the United States Court of Appeals for the Third Circuit announces the application process for a bankruptcy judgeship in the District of Delaware, seated in Wilmington. A bankruptcy judge is appointed to a 14-year term pursuant to 28 U.S.C. § 152.

To be qualified for appointment an applicant must:

- (a) Be a member in good standing of the bar of the highest court of at least one state, the District of Columbia, or the Commonwealth of Puerto Rico and every other bar of which they are members.
- (b) (1) Possess and have a reputation for integrity and good character; (2) possess and have demonstrated a commitment to equal justice under the law; (3) possess and have demonstrated outstanding legal ability and competence; (4) indicate by demeanor, character, and personality that they would exhibit judicial temperament if appointed; and (5) be of sound physical and mental health sufficient to perform the essential duties of the office.
- (c) At the time of the initial appointment, not be related by blood or marriage, within the degrees specified in 28 U.S.C. § 458, to (1) a judge of the United States Court of Appeals for the Third Circuit, (2) a member of the Judicial Council of the Third Circuit, or (3) a judge of the district court to be served.
- (d) Have been engaged in the active practice of law for a period of at least five years. The Judicial Council may consider other suitable legal experience as a substitute for the active practice of law.

The selection process will be confidential and competitive. At present, the annual salary for this position is \$205,528. Applicants shall be considered without regard to race, color, sex, gender, gender identity, pregnancy, sexual orientation, religion, national origin, age (40 years and over), or disability. The name of the person selected will be submitted to the Director of the Administrative Office, who shall request background reports by the Federal Bureau of Investigation (FBI) and the Internal Revenue Service (IRS). In addition, a nominee for a bankruptcy judgeship may be required by the court of appeals to complete a preliminary disclosure statement that includes questions seeking sensitive financial and personal information. The disclosure must be filed with the court of appeals and will be kept confidential. The individual selected must comply with the financial disclosure requirements pursuant to the Ethics in Government Act of 1978, Pub. L. No. 95-521, 92 Stat. 1824 (1978) (codified as amended at 5 U.S.C. app. §§ 101-111).

The application process is entirely automated. No paper applications will be accepted. Applications must be submitted electronically by **noon on June 30, 2022**. Applications must be submitted only by the applicant personally, indicating the applicant's willingness to serve if selected. OPINION BY: ASHWORTH, P.J., JANUARY 26, 2022. Before the Court is Pedro Luis Gavilan-Cruz's amended pro se petition filed pursuant to the Post Conviction Relief Act (PCRA), 42 Pa.C.S.A. §§ 9541-46. By previous Opinion,¹ the Court thoroughly addressed the factual and procedural background of this matter as well as the reasons why Gavilan-Cruz is not entitled to relief. This brief supplemental opinion is written to address the two additional issues raised by Gavilan-Cruz in his responsive Amended Petition. For the reasons set forth below, in addition to those stated previously, both the original and amended petitions shall be dismissed without a hearing.

I. Discussion

A. After-Discovered Evidence

In the Amended Petition, Gavilan-Cruz asserts a claim of "after-discovered" evidence in an effort to avoid dismissal of his petition as untimely.² To be entitled to relief under the PCRA on the basis of "after-discovered" evidence, the petitioner must plead and prove by a preponderance of the evidence "[t]he unavailability at the time of trial of exculpatory evidence that has subsequently become available and would have changed the outcome of the trial if it had been introduced." 42 Pa. C.S.A. § 9543(a)(2)(vi). As our Supreme Court has summarized:

> [t]o obtain relief based on after-discovered evidence, [a petition er] must demonstrate that the evidence: (1) could not have been obtained prior to the conclusion of the trial by the exercise of reasonable diligence; (2) is not merely corroborative or cumu-

lative; (3) will not be used solely to impeach the credibility of a witness; and (4) would likely result in a different verdict if a new trial were granted.

Commonwealth v. Pagan, 597 Pa. 69, 106, 950 A.2d 270, 292 (2008). This test is conjunctive; "the defendant must show by a preponderance of the evidence that each of these factors has been met in order for a new trial to be warranted." *Commonwealth v. Padillas*, 997 A.2d 356, 363 (Pa. Super. 2010).

After careful review, the Court must conclude that the claim raised by Gavilan-Cruz in his Amended Petition does not constitute "after-discovered" evidence entitling him to post-conviction relief. The claimed "evidence" consists of unspecified "records and telephone calls that happen [sic] while the Petitioner was in the County jail." Am. Pet. at 3 (unpaginated). These referenced records and telephone calls are not described or specified in any further detail whatsoever. Gavilan-Cruz provides neither the date, time, nor content of the referenced phone calls. He does not name the individuals who were parties to the alleged calls. Gavilan-Cruz fails to recount or even summarize for the Court the substance of the alleged telephone calls or how such substance would, if presented at trial, operate to produce a different verdict. Instead, Gavilan-Cruz asks the Court to appoint an investigator to search for evidence that "said charges were brought out of ill-feelings from [Gavilan-Cruz's] child's mother." Am. Pet. at 3 (unpaginated). Thus, Gavilan-Cruz is essentially asking this Court for permission to embark upon an impermissible "fishing expedition" based solely on bald assertions and conclusory allegations. See Commonwealth v. Chhea, 2015 WL 6957265 *4 (Pa. Super. June 23, 2015). He has given the Court no reason to believe that the requested investigator would uncover any evidence that would entitle him to relief under the PCRA. On the contrary, the record that is available amply supports the conclusion that Gavilan-Cruz's post conviction collateral claims must be dismissed as meritless.

B. Language Barrier

Finally, in the Amended Petition, Gavilan-Cruz raises for the first time the claim that he lacks proficiency in the English language to the extent that "basically nothing/anything was understood" by him during the trial. Am. Pet. at 4 (unpaginated). The Court presumes Gavilan-Cruz intends to allege that the supposed language barrier was so severe that it effectively denied him the right to counsel under the Sixth Amendment to the United States Constitution. Like all the other issues Gavilan-Cruz has raised in his collateral attack, this claim is as untimely as it is meritless. Gavilan-Cruz has litigated various issues in multiple forums, including litigation in the Magisterial District Court and Court of Common Pleas in Lancaster County, in the appellate courts of this Commonwealth through direct appeal, and in the United States District Court via petition for *habeas corpus* relief. At no time throughout any of

these proceedings, from the preliminary hearing stage through the first, second, and even this third petition for post-conviction collateral relief, has Gavilan-Cruz so much as hinted that he required the services of an interpreter to understand the proceedings against him. Nor has he set forth, either previously or presently, a single fact showing that he requested and was denied an interpreter at any stage of the proceedings. Gavilan-Cruz's supposed inability to understand English has not prevented him from filing multiple pro se post-conviction pleadings, leading the Court to the conclusion that he does indeed understand the proceedings against him. Even if Gavilan-Cruz did not actually prepare the pro se filings himself, this fact would confirm for the Court that he understands the proceedings enough to seek assistance when necessary. Thus, had Gavilan-Cruz required the assistance of an interpreter at any time prior to, during, or after his trial, the available record indicates that he would have sought it. He did not, rendering it disingenuous for him to raise the issue of a language barrier for the first time now, nearly eight years beyond his initial arrest and prosecution. The Court finds no grounds upon which to grant post-conviction relief on this basis.

II. CONCLUSION

For the reasons set forth above, in addition to those previously stated in the Opinion of September 29, 2021, Petitioner Pedro Luis Gavilan-Cruz's *pro se* petition must be dismissed.

Accordingly, I enter the following:

ORDER

AND NOW, this 26th day of January, 2022, upon consideration of Pedro Luis Gavilan-Cruz's Amended Petition for relief pursuant to the Post Conviction Relief Act (PCRA), 42 Pa.C.S.A. §§ 9541-46, and for the reasons set forth in this Court's Opinion of September 29, 2021, it is hereby ORDERED that Petitioner's Amended PCRA Petition is DENIED.

Pursuant to Pa. R.Crim.P. 908, this Court advises Petitioner that he has the right to appeal from this Order. Petitioner shall have 30 days from the date of this final Order to appeal to the Superior Court of Pennsylvania. Failure to appeal within 30 days will result in the loss of appellate rights.

It is further ORDERED that Petitioner shall have the right, if indigent, to appeal *in forma pauperis*.
