SUMMARY OF OPINION:

A plaintiff, who fell down a flight of steps, sued her landlord for allegedly failing to provide adequate lighting. Plaintiff also asserted a promissory estoppel claim against the landlord on the basis that his liability insurance representative supposedly "agreed to accept full liability" for the fall, as a result of which plaintiff's counsel "did not take any further action" or conduct "any further investigation" which purportedly made "evidence no longer available." In her promissory estoppel count, plaintiff requested that liability be entered in her favor such that "the only issue with this case is the amount of compensatory damages."

The landlord filed a motion for judgment on the pleadings on the ground that plaintiff could not state a promissory estoppel claim against him. To maintain an action in promissory estoppel, the aggrieved party must show that (1) the promisor made a promise that the promisor should have reasonably expected to induce action or forbearance on the part of the promisee (2) the promisee actually took action or refrained from taking action in reliance on the promise, and (3) injustice can be avoided only by enforcing the promise. Only the promisor who made the express promise may be liable based upon the doctrine of promissory estoppel if the promisee actually took action or refrained from taking action in reliance on the promise. There was no allegation that the landlord made any promise to the tenant, or that he expressly or impliedly authorized his insurance representative to make any promise on his behalf. The pleadings lacked any factual basis to sustain a claim that the landlord could be deemed a "promisor" for purposes of promissory estoppel liability. Therefore, the motion for judgment on the pleadings was granted.

SUMMARY OF OPINION:

Plaintiffs in this auto case filed a motion *in limine* requesting spoliation sanctions comprised of an adverse inference charge based upon defendant's failure to retain cell phone records. The record reflected that no party or witness testified during their depositions that defendant was using her cell phone at the time of the accident. By the time that the plaintiffs filed a motion seeking to compel defendant to produce her cell phone records, they had already been destroyed by her cell phone carrier. Moreover, in the parties' discovery dispute, the court ruled in favor of the defense by only requiring the defendant to produce cell phone records for the one hour periods before and after the accident.

Spoliation of evidence sanctions may be imposed upon a party that has destroyed relevant evidence. Neither the defendant nor her employer ever had custody of the cell phone records prior to their destruction, and no party had obtained, or even requested, a court order directing them to preserve those records prior to the date that they were purged by the cell phone carrier. Since those records were destroyed by a third party, rather than defendants, and there was no claim that defendants knew that those records would automatically be deleted by the cell phone carrier within two years, neither defendant could be characterized as a spoliator of evidence, and plaintiffs' motion for spoliation sanctions was denied.
