MEMORANDUM OPINION AND ORDER

Commonwealth v. Charles Kent Butler

CP-22-CR-0004848-2021

Criminal/Post Conviction Relief Act/ Knowing and Intelligent Guilty Plea/Non-Acceptance into State Drug Treatment Program / Withdrawal of Appointed Counsel

- Appointed Counsel sought to withdraw from representation of Defendant's claim for relief under the Post Conviction Relief Act based upon Counsel's conclusion that Defendant's claim lacked merit.
- 2. Defendant asserted that he entered the guilty plea upon the belief that he would be able to participate in the State Drug Treatment Program but that he was wrongfully denied acceptance thereto.
- 3. Only issues impacting the reliability of the adjudication of guilt or innocence are cognizable under the Post Conviction Relief Act. See 42 Pa. C.S.A. 9543(a)(2). State Drug Treatment Program participation had no bearing on Defendant's guilt or innocence. Further, although the sentencing court may deem Defendant eligible for State Drug Treatment Program participation, the decision as to acceptance in the program lies with the Board of Corrections, not the court. See, Bouie v. Pennsylvania Dep't of Corr., 302 A.3d 1261 (Pa. Commw. Ct. 2023), aff'd, 313 A.3d 946 (Pa. 2024)("[R]egardless of an inmate's Program eligibility or the results of a Department-administered addiction assessment, nothing in the statutes that govern the SDTP gives an inmate a legally enforceable right to gain admission thereto". citing §§ 4104(b)-(c), 4105(b)-(c), (f), 4108-(1)(i))
- 4. The Court deemed Defendant's guilty plea voluntary, knowing and intelligent for purposes of review of his Post Conviction Relief claim despite post-sentence denial of admission to the State Drug Treatment Program in that a defendant lacks a legally enforceable right to admission thereto. Because Defendant's claim lacks merit, the Court permitted Appointed Counsel to withdraw from representation pursuant to the standards set forth in Commonwealth v. Turner, 544 A.2d 927 (Pa. 1988).

This matter comes before the Court on the Motion of Court Appointed Post Conviction Relief Counsel, Brandy G. Hoke, Esq., to Withdraw from representation of Charles Kent Butler ("Defendant"). For the reasons set forth, we **GRANT** the Motion to Withdraw pursuant to the terms of our ORDER and apprise Defendant of our **INTENT TO DISMISS** the Petition.

DAUPHIN COUNTY REPORTS COMMONWEALTH V. CHARLES KENT BUTLER

RELEVANT PROCEDURAL HISTORY

On October 25, 2022, Defendant plead guilty to (1) Aggravated Assault By Vehicle While DUI1, (2) DUI: Controlled Substance or Metabolite 1st Offense2, (3) DUI: Gen Imp/Inc of Driving Safely – 1st Off³, (4) Careless Driving – Serious Bodily Injury⁴, and (5) Use Wrong Lane - Left Turn Lane Design⁵ based upon the following facts: On October 15, 2021, Lower Swatara police were dispatched for a motor vehicle accident involving a bicycle. (Transcript of Proceedings, Guilty Plea, "N.T." October 25, 2022, p. 3). An officer arrived and observed that the driver of a pickup truck had just put breath mints in his mouth. Id. When he spoke to this individual, he admitted to drinking alcohol and the officer smelled the odor of alcohol coming from his mouth when speaking to him. (N.T. p. 4). The driver of that truck was the Defendant. Id. He stated that he was making a left turn onto White House Lane and never saw the bicyclist. Id. The bike rider was unconscious and had a deep laceration down the length of his left arm. Id. The bike frame was completely snapped in half. Id. The Defendant did submit to field sobriety tests as well as a PBT which was positive. Id. He initially refused a blood draw stating that he would test hot for marijuana. Id. Police did not apply for a search warrant and did get blood results which showed he had a BAC of .026 as well as methamphetamine and THC in his system. Id. The bike rider had multiple injuries as a result of this accident including broken ribs and a shoulder blade, a large open laceration down his left arm, severed tendon in the left arm, limitations to his range of motion in left knee and left arm, as well as a concussion. Id.

On January 23, 2023, the Court imposed the sentence as follows:

In satisfaction of Counts 1, 2, and 3, at Count 1 the Defendant shall pay the costs, the mandatory fine of \$2,500, and be sentenced to a term of not less than 4 nor more than 8 years in the state correctional institution.

He is eligible for the State Drug Treatment Program as well as other incentive programs. He is not RRRI eligible as a matter of law.

The Defendant is entitled to one day of time credit.

No sentences are imposed with respect to Counts 4 and 5.

Standard conditions and standard DUI conditions of probation and parole are specifically imposed that will also require him to be actively participating in a 12-Step Program and to have a sponsor in place within 90 days of his release from the state correctional institution.

The Defendant shall pay restitution in the amount of \$4,291.91 to Alan Snavely, 52 Thomas Street, Hummelstown, Pennsylvania 17036. If that amount is satisfied by insurance, he would not have to pay that. In the event that he pays that and then insurance comes thorough, it will be part of the subrogation process as well.

Sentencing Order, January 23, 2023.

Defendant filed a *pro se* Petition for Post Conviction Collateral Relief on December 19, 2023⁶. The Court appointed Brandy G. Hoke, Esq., as PCRA Counsel. Defendant filed an Amended PCRA Petition on January 31, 2024. Defendant filed a Motion for an Extension of the Deadline Filing a Supplemental PCRA Petition on February 2, 2024. Appointed Counsel filed a Motion to Withdraw as Counsel on March 6, 2024.

DISCUSSION

Appointed Counsel's Petition to Withdraw sets forth a thorough analysis of Defendant's claims for relief based upon ineffective assistance of counsel and convinces this Court that such claims lack merit.

When seeking to withdraw from representation of a collateral appeal, counsel must file a "no merit" letter that (1) details the nature of counsel's review, (2) lists the issue the petitioner wishes to raise and (3) explains why the issue lacks merit. *Commonwealth v. Shultz*, 707 A.2d 513, 516 (Pa. Super. 1997). Further, assistance of counsel in presumed effective. *Commonwealth v. Holbrook*, 629 A.2d 154 (Pa. 1993). In order to prove ineffective assistance of counsel, a defendant must show that the underlying claim has merit, that trial counsel's decision was not intended to promote the defendant's interest, and that the defendant suffered prejudice as a result of the attorney's error. *Commonwealth v. Faulkner*, 735 A.2d 67, 69 (Pa. 1999).

Defendant claims that he was wrongfully denied the opportunity to participate in the State Drug Treatment Program and that he only entered into a guilty plea with the belief that he would be able to participate in the program. (*Pro Se* Motion for Post Conviction Collateral Relief, p. 4). No basis for relief exists based upon Defendant's claim.

In order to prove ineffective assistance of counsel in relation to a guilty plea, there must be an allegation of a "fair and just reason for withdrawal of the guilty plea before the question of prejudice arises." Commonwealth v. Michael, 755 A.2d 1274 (Pa. 2000). If petitioner seeks to withdraw a guilty plea after sentencing, he must demonstrate that the original plea was a result of manifest injustice. Holbrook, at 158. To meet this standard, the defendant must establish that the plea was "involuntary or given without knowledge of the charge." Commonwealth v. Blackwell, 647 A.2d 915, 921 (Pa. Super. 1994). A guilty plea will be considered invalid if it was not given "knowingly, voluntarily and intelligently." Commonwealth v. Yager, 685 A.2d 1000, 1003 (Pa. Super. 1996).

Defendant fails to demonstrate that his guilty plea was the result of any manifest injustice or that it was less than knowing and intelligent for any reason. Defendant admitted in open court that he reviewed the written guilty plea colloquy, made part of the record, and that it

had been explained to him. (N.T. pp. 2-3; Guilty Plea Colloquy). Defendant admitted that he understood the charges. At no time did he question the charges. (N.T. pp. 2-3).

Defendant's allegation that he is entitled to relief from his knowing and intelligent guilty plea based upon non-acceptance into the State Drug Treatment Program, is meritless. Only issues impacting the reliability of the adjudication of guilt or innocence are cognizable under the Post Conviction Relief Act. See 42 Pa. C.S.A. 9543(a)(2). State Drug Treatment Program participation had no bearing on Defendant's guilt or innocence. Further, although the sentencing court may deem Defendant eligible for State Drug Treatment Program participation, the decision as to acceptance in the program lies with the Board of Corrections, not the court. See, Bouie v. Pennsylvania Dep't of Corr., 302 A.3d 1261 (Pa. Commw. Ct. 2023), aff'd, 313 A.3d 946 (Pa. 2024)("[R]egardless of an inmate's Program eligibility or the results of a Department-administered addiction assessment, nothing in the statutes that govern the SDTP gives an inmate a legally enforceable right to gain admission thereto". citing §§ 4104(b)-(c), 4105(b)-(c), (f), 4108-(1)(i))

Therefore, our independent review of the record leads us to conclude that Defendant's claim lacks merit, and that Appointed Counsel should be permitted to withdraw from representation pursuant to the standards set forth in *Commonwealth v. Turner*, 544 A.2d 927 (Pa. 1988).

For these reasons, we enter the following:

ORDER

AND NOW, this 26th day of June, 2024, it is ORDERED that:

We find that no genuine issues exist concerning any material fact that Defendant/PCRA Petitioner is not entitled to Post Conviction Collateral Relief. No purpose could be served by any further proceedings.

Defendant/PCRA Petitioner is hereby advised of this court's intention to **DISMISS** the Petition for Post Conviction Collateral Relief within *twenty (20) days* of receipt of this ORDER. If no objection is filed within *twenty (20) days* the court will enter a final ORDER dismissing the Petition for Post Conviction Collateral Relief.

In the event of Defendant's failure to file objections or dismissal of objections, Counsel shall be permitted to withdraw from representation.
