Proposed Ordinance No. 437 would confirm Roseto Borough's

[continued] membership in the Pennsylvania Townships Health Insurance Cooperative Trust ("Trust"), which consists of governmental units from throughout the Commonwealth of Pennsylvania that have created an intergovernmental cooperative arrangement to permit participating employers to pool resources to develop, administer, and make available medical, prescription, dental, life, disability and/or other employee welfare benefit coverage in a cost-effective manner.

Proposed Ordinance No. 437 includes provisions addressing the conditions that must be met to participate in and withdraw from the Trust, the organizational structure of the Trust, the appropriation of funds required for the operation of the Trust, the authority of the Trust to enter into contracts and take other actions appropriate to carry out the purposes of the Trust, and the effective date of Roseto Borough's participation in the Trust. The proposed ordinance also provides for severability and confirms that it does not affect any rights or liabilities existing prior to the adoption of the ordinance. It also references the Trust Agreement that governs the operations of the Trust.

The full text of Proposed Ordinance No. 437 and the Trust Agreement are on file for inspection and review without charge (or a copy may be obtained for a charge not greater than the cost thereof) at Roseto Borough's offices at 164 Garibaldi Avenue, Roseto, PA 18013.
