Commonwealth v. Jamie Cruz-Rivera PCRA Opinion — Ineffective Assistance of Counsel — Failure to File Direct Appeal — Credibility of Witness

OPINION BY ASHWORTH, P.J., January 7, 2022. Before the Court is Jamie Cruz-Rivera's Amended Petition filed pursuant to the Post Conviction Relief Act (PCRA), 42 Pa. C.S.A. §9541-46. For the reasons set forth below, this petition will be denied following a hearing.

I. PROCEDURAL BACKGROUND

On May 3, 2017, Petitioner, Jamie Cruz-Rivera ("Petitioner") appeared before the Court and entered a negotiated guilty plea to two charges at Docket No. 2987-2016, specifically to Corruption of Minors (Count Two) and Unlawful Contact with a Minor (Count Three).¹ The Court accepted the guilty plea and proceeded to sentence Petitioner on that date in accordance with the terms of the negotiated plea agreement to time served to twenty-three months incarceration, five years of probation, restitution, and costs.² Petitioner did not adjust well to supervision and was back before the Court for a parole violation hearing on August 23, 2017. At that time, the Honorable Judge Howard F. Knisely found Petitioner in violation of the terms of supervision and sentenced him to the unexpired balance of his parole term. Petitioner was to be paroled after three months with special conditions and the continuation of the previously imposed five-year probation period.

Petitioner appeared before this Court on May 24, 2019, this time for a probation violation.³ After a hearing, the Court revoked Petitioner's probation and deferred sentencing pending the completion of a Pre-Sentence Investigation ("PSI") to assist the Court in fashioning an appropriate and reasonable sentence. Judgment of sentence was entered on August 22, 2019, when the Court sentenced Petitioner to an aggregate term of two to five years' incarceration in a state correctional facility.⁴ No post sentence motion was filed, and no appeal was taken. Petitioner was represented throughout both violation proceedings by privately retained counsel, Anthony J. Ratasiewicz, Esquire ("trial counsel").

Acting pro se on March 20, 2020,⁵ Petitioner submitted a plead-

Petitioner's parole expired on March 11, 2018. Specifically, Petitioner was sentenced to two to five years incarceration on the corruption of mi-4 nors count and two to five years incarceration on the unlawful contact with a minor charge, said sentences

ing entitled "Motion for Withdrawl [sic] of Counsel Ineffective Assistance of Counsel (IAC)". Upon review, the Court deemed Petitioner's pleading to be a timely⁶ petition for post-conviction collateral relief under the PCRA, however, at the time of filing, the Court was operating at a severely restricted capacity due to the statewide Judicial Emergency declared in response to the Covid-19 pandemic.⁷ Consequently, the Court did not officially appoint counsel pursuant to Rule 904(A) of the Pennsylvania Rules of Criminal Procedure until June 19, 2020,⁸ at which time it appointed Dennis C. Dougherty, Esquire ("PCRA counsel") to represent Petitioner on his collateral claims, and granted leave to file an amended petition by August 19, 2020. Upon request of PCRA counsel, the Court twice extended the deadline to allow counsel time to obtain the necessary files and records from Petitioner's trial counsel.9 Ultimately, an Amended Petition for Post Conviction Collateral Relief was submitted on November 25, 2020, raising the single issue that trial counsel rendered ineffective assistance for failing to comply with Petitioner's alleged request to file a post-sentence motion and/or a direct appeal to the Superior Court. The Commonwealth filed a response to the Amended Petition, conceding the need for an evidentiary hearing, which the Court held on June 11, 2021. The parties have filed briefs and this matter is ripe for adjudication.

II. DISCUSSION

The Court begins its analysis by noting that "counsel's failure to pursue a direct appeal upon request is grounds alone for relief under the PCRA, in the form of restoration of direct appeal rights." Commonwealth v. Champney, 2001 Pa. Super. 272, 783 A.2d 837, 840 (2001)(citing Commonwealth v. Lanzy, 588 Pa. 214, 736 A.2d 564 (1999)). Further,

[t]he fact that the issue which appellant seeks to raise on appeal, [concerns] the discretionary aspects of his sentence, does not preclude PCRA relief, since [petitioner's] claim that counsel's failure to perfect the appeal denied the accused the assistance of competent counsel guaranteed by the Sixth Amendment to the United States Constitution and Article I, Section 9 of the Pennsylvania Constitution, as well as the right to a direct appeal under

⁶ Pursuant to 42 Pa.C.S.A. § 9545(b), a petition for relief must be filed within one year of the date the judgment of sentence becomes final. For purposes of the PCRA, a judgment of sentence becomes final at the conclusion of direct review, including discretionary review in the Supreme Court of Pennsylvania, or at the expiration of the time for seeking such review. Id. at § 9545(b)(3). See also Commonwealth v. Jones, 54 A.3d 14, 17 (Pa. Super. 2012). As Petitioner did not file a notice of appeal with the Pennsylvania Superior Court, is judgment of sentence became final on September 22, 2019, when the period for filing an appeal with the Superior Court expired (30 days after the judgment of sentence was entered on August 22, 2019). Petitioner filed his Motion, which the Court deemed to be a pro se PCRA petition, on March 20, 2020; it is timely. See Filing Discussion, supra n5. The Supreme Court Decket No. 531/532 of the Supreme Court of Pennsylvania (March 16, 2020, March 18, 2020, March 18, 2020), see also Administrative Orders of the Lancaster County Court of Common Pleas at Supreme Court Decket No. 44 MM 2020 (beginning March 17, 2020 as continued through June, 2020). Pursuant to 42 Pa.C.S.A. § 9545(b), a petition for relief must be filed within one year of the date

⁸ In the interim, Petitioner submitted a second pro se pleading entitled "Motion to Modify Sentence Nunc Pro Tunc" on April 21, 2020, which in substance repeats the alleged grounds for relief stated in Petitioner's filing of March 20, 2020.

The Court entered an Order on October 21, 2020, at PCRA counsel's request, directing trial counsel to provide copies of the necessary documents to PCRA counsel.

Article V, Section 9, and, thus, such neglect by counsel alone is sufficient to establish prejudice for the purposes of 42 Pa. C.S.A. § 9543(a)(2)(ii)."

Commonwealth v. Hernandez, 755 A.2d 1, 6-7 (Pa. Super. Ct. 2000), *aff'd in part*, 572 Pa. 477, 817 A.2d 479 (2003). Importantly, to be entitled to the reinstatement of appellate rights via the PCRA, the burden is on the petitioner to plead and prove that he did in fact request that their counsel file a direct appeal and that counsel failed to do so. *Champney*, 783 A.2d at 840.

While the Petitioner here has adequately pled that he requested, both orally and in writing, that his attorney file a direct appeal on his behalf, he has failed to provide the Court with any credible proof to support a factual basis for this allegation. At the evidentiary hearing, the only two witnesses to testify were the Petitioner and his trial counsel. They both testified to having a verbal conversation in the holding cell behind the courtroom after the sentencing. Notes of Testimony ("N.T.") at 5, 9-10. Their testimony diverges, however, with regard to the substance of that conversation. While trial counsel has no recollection of being asked to pursue an appeal (N.T. at 6), Petitioner maintains the two "talked about filing an appeal," and that Petitioner "told [trial counsel] to talk to [Petitioner's] friend Jess and tell her how much money to send." Id. at 10. Petitioner further presented the Court with a handwritten letter that he claims to have sent trial counsel requesting post sentence motions and a direct appeal. See Pet. Evid. Hearing. Ex.1; see also Pet. Mot. to Withdraw Counsel at Ex. A; Pet. Mot. to Modify at Ex.1. Trial counsel never received that letter. N.T. at 6. The issue, therefore, turns on a single question of fact: did the Petitioner ask trial counsel, whether orally, in writing, or both, to file a direct appeal on his behalf? Counsel agree the answer to this question boils down to a matter of credibility. Does the Court believe the testimony of trial counsel? Or does the Court believe the testimony of Petitioner?

Having examined the conflicting testimony regarding the oral conversation after the sentencing hearing, the Court turns next to the letter offered with Petitioner's pleadings and moved into evidence at the Evidentiary Hearing as Petitioner's Exhibit 1. This Exhibit contains a copy of a handwritten letter Petitioner claims he personally mailed to trial counsel within the time frame for filing an appeal. N.T. at 10. Petitioner explained that since he cannot read or write, he had another individual write the letter on his behalf. Id. Petitioner did not, however, provide the name of that individual or call the individual to testify. Id. at 11. Although the letter bears the date of August 25, 2019, Petitioner stated at the hearing that the date was incorrect. When pressed, however, he could recall neither the date the letter was written nor the date on which he claims to have mailed it. Id. Trial counsel testified that he never received the letter, although he has maintained the same office address both prior to and throughout his representation of Petitioner, including throughout the relevant appeal period. N.T. 6, 7-8. Petitioner clearly

knew his counsel's correct mailing address; he testified to having retained counsel on several prior occasions and to providing copies of trial counsel's business cards to past acquaintances. N.T. at 12.

The Court has heard and reviewed the live testimony of the witnesses and examined the various iterations of the letter submitted by the Petitioner. Considering the totality of the attendant circumstances, the Court finds that while trial counsel's testimony was candid and credible, the Petitioner's testimony was utterly lacking in indicia of reliability and candor. He could not recall key details, such as the date on which he mailed the letter or who even wrote the letter for him. The letter itself bears no hallmarks of authenticity, having been written by an unnamed individual who the Petitioner failed to produce for authentication. Such a witness could easily have corroborated Petitioner's account that the letter was written and mailed, as Petitioner claims it was, within the appropriate timeframe for a direct appeal.¹⁰ On the contrary, trial counsel is an experienced and respected member in good standing with the Pennsylvania Bar who has no motivation to testify untruthfully. He stated plainly that Petitioner neither verbally requested nor directed through written letter that counsel file post sentence motions or a direct appeal on his behalf. Trial counsel represented the Petitioner on more than one occasion prior to the instant matter without incident. In fact, Petitioner himself admitted that trial counsel had never before failed to be responsive to his needs and that he had recommended trial counsel to others. N.T. at 12. Based on all of these factors, it is apparent to the Court that while Petitioner may now wish he had requested that trial counsel file post trial motions or a direct appeal, Petitioner simply cannot prove that he actually did so.

III. CONCLUSION

For the foregoing reasons, Petitioner Jamie Cruz-Rivera's Amended Petition must be dismissed.

Accordingly, I enter the following:

¹⁰ The Court further notes its independent observation that with Petitioner's original pleading of March 20, 2020 (entitled "Motion to Withdrawl [sic] of Counsel"), he attaches (as Exhibit A) a two-sided letter that appears to be a photocopy of the letter Petitioner claims to have mailed trial counsel. In his subsequent pleading of April 21, 2020 (entitled "Motion to Modify Sentence Nun Pro Tunc"), however, he attaches (Exhibit 1) a seemingly identical yet noticeably different letter. A cursory glance at this second letter would lead the unwary to believe the two exhibits are duplicates; however, a closer examination reveals that the exhibits contain two different letters. First, Exhibit A is a photocopy, while Exhibit 1 is an original document, handwritten in blue ink. Second, although the handwriting of the two letters appears to be the same, the wording is not actually identical. For example, there are misspellings in one letter is broken into two lines in the other, and a word is hyphenated in one and not the other. Although the parties made no mention of these discrepancies or their meaning during the evidentiary hearing, the Court finds Petitioner's intentional yet failed effort at producing identical letters to bear negatively on Petitioner's credibility and testimony as a whole.

ORDER

AND NOW, THIS 7th day of January, 2022, upon consideration of Jamie Cruz-Rivera's Amended Petition for Post-Conviction Collateral Relief, it is hereby ORDERED that said petition is DENIED following a hearing, for the reasons stated in the Opinion filed on this same date.

Pursuant to Pa. R.Crim.P. 907(4), this Court advises Cruz-Rivera that he has the right to appeal from this Order. Cruz-Rivera shall have **30 days** from the date of this final Order to appeal to the Superior Court of Pennsylvania. **Failure to appeal within 30 days will result in the loss of appellate rights.**

It is further ORDERED that Cruz-Rivera shall have the right, if indigent, to appeal *in forma pauperis* and to proceed with assigned counsel as provided in Pa. R.Crim.P. 122.
