Notice is hereby given that the Tax Claim Bureau of Franklin County, Pennsylvania, will hold a tax sale of the properties listed below on Monday, September 26, 2011, beginning at 9:30 a.m. Eastern Time at the office of the Tax Claim Bureau in the Franklin County Courthouse, Chambersburg, Pennsylvania, for the purpose of collecting unpaid taxes for 2009 municipal claims and all costs incident to the tax claim and sale. Properties will be offered for the approximate upset prices indicated, which include any unpaid 2010 taxes.

AT THE OPTION OF THE BUREAU, the properties may be removed from sale if any owner or lien creditor enters into a written agreement to pay the tax in installments before the date of the sale. It should be noted that this sale shall convey title to the property UNDER AND SUBJECT TO the lien of every recorded obligation, claim, lien, estate, mortgage, ground rent and commonwealth tax lien not included in the upset price with which said property may have or shall become charged, or for which it may become liable. It is strongly urged that prospective purchasers make an examination of title to ascertain matters not removed by the sale.

Unpaid taxes may be paid in full at any time before 4:15 p.m. on Friday, September 23, 2011, by cash, certified check or money order only. NO PERSONAL CHECKS WILL BE ACCEPTED.

Conditions of Sale
