- 1. Pennsylvania Rule of Juvenile Civil Procedure (Pa.R.J.C.P.) 1133 provides that a motion to intervene shall include, inter alia, the contact between the child and intervening party, the grounds on which intervention is sought, and what relief is requested.
- 2. Following the grant of an application for leave to file a private dependency petition under Pa.R.J.C.P. 1321, the county agency shall be joined as a party in any further proceedings upon filing and service of a private petition.
- 3. The plain language of the Pa.R.J.C.P. must be construed in consonance with the rules of statutory construction to the extent practicable.
- 4. In interpreting a statute, the Court endeavors to ascertain and effectuate the intention of the General Assembly. Because, generally, the best indicator of legislative intent is the plain language of the statute, the Court must begin its inquiry by considering the words of the statute. In doing so, the Court construes words and phrases according to their common and approved usage or, as appropriate, their peculiar and appropriate or statutorily provided meanings.
- 5. Words and phrases must be viewed not in isolation, but with reference to the context in which they appear.
- 6. The comment to Pa.R.J.C.P. 1320(B) strongly implies that a party wishing to intervene and participate in a Rule 1320 hearing must first file a motion to intervene pursuant to Rule 1133. The rule does not provide that a county agency may simply file a Praecipe to Intervene or otherwise notify the court of its intent to intervene; rather, a motion to intervene must be filed. Nor is a county agency made a party automatically at the stage of the hearing on the application to file a private dependency petition unlike when that application is granted and a petition is actually filed.
- 7. In order for a motion to intervene to be granted, one must show that his/her/its interest is substantial, direct, and immediate.
- 8. The substantial rights of parents, guardians, or caretakers regarding their children or wards warrants the appointment of counsel at the earliest possible stage when there is allegation of neglect or abuse that may result in the removal of a child or ward from their care.
- 9. Pennsylvania Rule of Juvenile Civil Procedure 1151 provides that the court shall assign a guardian *ad litem* to represent the legal interests and the best interests of the child if a proceeding has been commenced pursuant to Rule 1200 alleging a child to be dependent.
- 10. In juvenile matters, venue is governed by 42 Pa.C.S. §6321, which provides that a proceeding may be commenced in the county in which the child resides, or if dependency is alleged, in the county in which the child is present when it is

commenced.

- 11. Pursuant to 42 Pa.C.S. §6321, if the child resides in a county of this Commonwealth and the proceeding is commenced in a court of another county, the court, on motion of a party or on its own motion made after the adjudicatory hearing or at any time prior to final disposition, may transfer the proceeding to the county of the residence of the child for further action. Like transfers may be made if the residence of the child changes during the proceeding. The proceeding may be transferred if the child has been adjudicated delinquent and other proceedings involving the child are pending in the court of the county of his residence.
- 12. The term residence is not a defined term in the Juvenile Act and must be given common and approved usage.
- 13. Residence is a place of abode without the present intention to leave.
- 14. Following a Pa.R.J.C.P. 1320 application to file a private dependency petition, the court shall conduct a hearing within fourteen days of the presentation of the application for a petition to determine: (a) if there are sufficient facts alleged to support a petition of dependency; and (b) whether the person applying for the petition is a proper party to the proceedings.
- 15. Petitioner must testify regarding the Application for Leave to File a Private Dependency Petition Pursuant to Pa.R.J.C.P. 1321 and establish that the allegations would form a sufficient basis for the filing of a petition.
- 16. A dependent child is a child without proper parental care or control, subsistence, education as required by law, or other care or control necessary for his physical, mental, or emotional health, or morals.
- 17. Although the Juvenile Act does not define party, case law has conferred the status of party to a dependency proceeding on three classes of persons: (a) the parents of the juvenile whose dependency status is at issue; (b) the legal custodian of the juvenile whose dependency status is at issue; or (c) the person whose care and control of the juvenile is in question. These categories logically stem from the fact that upon an adjudication of dependency, the court has the authority to remove a child from the custody of his or her parents or legal custodian.
- 18. Due process requires that the child's legal caregiver, be it a parent or other custodian, be granted party status in order to be able to participate and present argument in the dependency proceedings.
- 19. Foster parents and persons acting *in loco parentis* lack standing to intervene in dependence.
- 20. The overarching concern of the court in a dependency matter is the best interests of the child.
- 21. An additional category of individuals having standing, at least for an initial adjudication as a result of the granting of a private application pursuant to Pa.R.J.C.P. 1321, include a current, temporary caregiver unable to provide adequate care due to his/her lack of legal custody coupled with allegations of a parent or guardian's neglect or abuse where the local agency opposes the ultimate filing of the petition.

22. Following oral argument on an Application for Leave to File a Private Dependency Petition Pursuant to Pa.R.J.C.P. 1321 and 1330, and a Motion to Intervene and a Motion for a Hearing Before a Judge filed by CYF, the Court <u>Held</u>, that: (a) the Motion to Intervene by CYF was granted; (b) the Motion for a Hearing Before a Judge was granted; (c) the objection to venue in Chester County by CYF was overruled; (d) the Motion to Appoint a guardian *ad litem* was denied in part and granted in part; (e) the Application for Leave to File a Private Dependency Petition was granted; (f) CYF will be joined as a party upon the filing of a dependency petition; (g) petitioner was a proper party to the proceedings; and (h) a hearing on the private dependency petition would be scheduled in due course after filing.

## **ORDER and MEMORANDUM**

**AND NOW**, this 24th day of February, 2023, following a hearing and oral argument on February 21, 2023 on: (1) the Application for Leave to File a Private Dependency Petition Pursuant to Pa.R.J.C.P. 1321, 1330 filed February 7, 2023 by Petitioner [A.L.];<sup>1</sup> (2) the Motion to Intervene and Motion for a Hearing Before a Judge filed by Movant Chester County Department of Children, Youth & Family (CYF) on February 15, 2023; and (3) any responses thereto, it is hereby **ORDERED** for the reasons set forth in the accompanying Memorandum that:

- 1. The Motion to Intervene by CYF is **GRANTED**;
- 2. The Motion for a Hearing before a Judge is **GRANTED** pursuant to Pa.R.J.C.P. 1187;<sup>2</sup>
- 3. The objection to venue in Chester County by CYF is **OVERRULED**;
- 4. The motion to appoint a guardian ad litem (GAL) is **DENIED in part** and **GRANTED in part**. Specifically, a GAL is not appointed for purposes of the hearing on the Application for Leave to File a Private Dependency Petition but is appointed for all future proceedings, including the hearing on the approved private dependency petition when filed. Carla Goewert, Esquire is appointed as GAL for [E.P.] (Child), for dependency proceedings related to this action. A separate Order shall follow;
- The Application for Leave to File a Private Dependency Petition is GRANTED and Petitioner may file and serve a dependency petition pursuant to Pa.R.J.C.P. 1330, 1331;
- 6. CYF shall be joined as a party to this action pursuant to Pa.R.J.C.P 1321(C) upon the filing of the dependency petition by Petitioner. Petitioner shall

<sup>&</sup>lt;sup>1</sup> On February 15, 2023, the Honorable Analisa Sondergaard issued an Order scheduling a hearing on the Motion to Intervene only; however, at the hearing, the parties and court addressed the Motion to Intervene and then, without objection of any present, proceeded to the hearing on the underlying application itself. Moreover, Pa.R.J.C.P. 1321(A) provides that a hearing on the presentation of the application shall be conducted in fourteen days.

<sup>&</sup>lt;sup>2</sup> Petitioner did not object to CYF exercising its right to a hearing before a judge. Pa.R.J.C.P. 1187 provides, in relevant part, "If a party objects to having the matter heard by the juvenile court hearing officer, the case shall proceed before the judge." A motion may not have been necessary to have the matter heard by a judge as the matter was already scheduled before the undersigned based on the objection; although given the question regarding standing of CYF to make such an objection or to be a party at the application stage, this court issues the ruling granting the motion.

#### **MEMORANDUM**

On February 7, 2023, Petitioner [A.L.] ("Petitioner", "Cousin", or "[L]") filed an Application for Leave to File a Private Dependency Petition Pursuant to Pa.R.J.C.P. 1321, 1330 (the "Application") for the minor child [E.P.] (Child). Chester County Department of Children, Youth & Family (CYF) filed a Motion to Intervene and Motion for Hearing Before a Judge on February 14, 2023 pursuant to Pa.R.J.C.P. 1133.

This court held oral argument on the motions on February 21, 2023 prior to a hearing on the application. Petitioner opposed the Motion to Intervene arguing first that no direct, immediate, and substantial interest exists for CYF or Parents pursuant to Pa.R.J.C.P. 1133 and arguing second that the Motion is untimely due to it being filed hours prior to a scheduled hearing with Hearing Officer Mary Jones, Esq., on February 14, 2023 at 2:00 p.m.<sup>3</sup>

#### Motion to Intervene - CYF

Regarding CYF's Motion to Intervene, Pa.R.J.C.P. 1321 provides: "Following grant of an application under this rule, the county agency shall be joined as a party in any further proceedings upon filing and service of a private petition[.]" CYF argues that because it will necessarily be involved if the Application is granted and the private dependency petition is filed it "shall be joined as a party in any further proceedings upon filing and service of a private petition[.]" Pa.R.J.C.P. 1321(c). CYF additionally argues that it has an interest in the matter due to an open dependency case with Child's sister (A.P.) and that its ongoing involvement with the family grants it a substantial, direct, and immediate interest. CYF cites to its responsibilities pursuant to the Juvenile Act, 42 Pa.C.S. § 6301, et seq.; the Pennsylvania Rules of Juvenile Court Procedure, 55 Pa. Code § 3490.235; and the Pennsylvania Child Protective Services Law, 23 Pa.C.S. § 6301, et seq. Lastly, CYF argues that venue is improper pursuant to Pa.R.J.C.P. 1300(A).

This court starts with the plain language of the rules which must be "construed in consonance with the rules of statutory construction" to the extent practicable. Pa.R.J.C.P. 101(D).

In interpreting a statute, this Court endeavors to "ascertain and effectuate the intention of the General Assembly." <u>1 Pa.C.S. § 1921(a)</u>. Because, "generally, the best indicator of legislative intent is the plain language of the statute," we begin our inquiry by considering the words of the statute. <u>Com., Ofc. of the Gov. v. Donahue</u>, 98 A.3d 1223, 1237 (Pa. 2014); 1 Pa.C.S. § 1921(b) ("When the words of a statute are clear and free from all ambiguity, the letter of it is not to be disregarded under the

pretext of pursuing its spirit"). In doing so, we construe words and phrases according to their "common and approved" usage or, as appropriate, their "'peculiar and appropriate' or statutorily provided meanings." <u>Freedom Medical Supply</u>, 131 A.3d at 983 (citing 1 Pa.C.S. § 1903). Finally, we bear in mind that words and phrases must be viewed "not ... in isolation, but ... with reference to the context in which they appear." Meyer v. Comm. Coll. of Beaver Cnty., 93 A.3d 806, 813 (Pa. 2014).

Scungio Borst & Associates v. 410 Shurs Lane Developers, LLC, 146 A.3d 232, 238 (Pa. 2016) (citations modified); see also Dixon v. Northwestern Mutual, 146 A.3d 780, 784 (Pa. Super. 2016) (applying the same reasoning to rules promulgated by the court) (citing Commonwealth v. Baker, 690 A.2d 164 (Pa. 1997); Commonwealth v. Williams, 125 A.3d 425, 428 (Pa. Super. 2015); and 1 Pa.C.S. § 1921(c)(4)).

The plain language of Pa.R.J.C.P. 1320(B) commands that the court must provide notice to the county agency but does not make them a party at this stage.<sup>4</sup> If the application is granted and the private dependency petition is filed, the plain language of Pa.R.J.C.P. 1321(C) provides that "[f]ollowing grant of an application under this rule, the county agency shall be joined as a party in any further proceedings upon filing and service of a private petition[.]" As such, CYF is not automatically a party at the stage of a Rule 1320 hearing on an application to file a private dependency petition. Moreover, the Comment to Pa.R.J.C.P. 1320(B) states that "This rule is not intended to preclude the county agency from seeking to intervene and participate in the hearing on the application. *See* Rule 1133 (Motion to Intervene)."

The comment to Rule 1320(B) strongly implies that a party wishing to intervene and participate in a Rule 1320 hearing must first file a motion to intervene pursuant to Rule 1133. The rule does not provide that a county agency may simply file a Praecipe to Intervene or otherwise notify the court of its intent to intervene; rather, a motion to intervene must be filed. Nor is a county agency made a party automatically at the stage of the hearing on the application to file a private dependency petition unlike when that application is granted and a petition is actually filed. See Pa.R.J.C.P. 1321(C). By a plain reading of the language of the rules as well as an application of common sense, it would appear that the Pennsylvania Supreme Court in adopting the rules did not wish for an agency such as CYF to be involved as a matter of course or in CYF's sole discretion; rather a motion to intervene must be filed and the standards governing that motion are to apply.

CYF argues that given that it will be named as a party and/or be required to investigate in the event that the Application is granted that it always has a direct, substantial, and immediate interest in the outcome of the proceedings. <u>See South</u> <u>Whitehall Township Police Serv. v. South Whitehall Township</u>, 555 A.2d 793 (Pa. 1989) (holding that in order for a motion to intervene to be granted, one must show that his/her/its interest is substantial, direct, and immediate). In addition, CYF argues

that it has a direct, substantial, and immediate interest that any action be brought in the proper venue. Moreover, CYF argues that it has an open case with Child's sister and involvement with the family granting it a direct, substantial, and immediate interest in the outcome of the Application.

This court finds that CYF's prior involvement with the family and its obligation to be involved if the Application is granted does not rise to the level of a direct, substantial, and immediate interest. Rather, CYF often is in the position of having had dealings with a family either previously or, as here, currently through another child. The background knowledge or information CYF may have as to a different dependency action or, presently, a different child, is not unusual nor does it create a peculiar interest in the Child's matter beyond CYF's normal obligations.

The remainder of CYF's argument regarding its ability to intervene focused on the merits of the underlying application or on a potential adjudication of dependency. Given the plain language of the rules, CYF does not have an interest outside of venue at this stage of the proceedings given that the hearing on an application involves merely determining "[i]f there are sufficient facts alleged to support a petition of dependency." Pa.R.J.C.P. 1321(a)(1). It is this court's view that the veracity of the allegations is not at issue; rather that determination waits for an adjudication hearing if the application is granted. The issue is merely whether or not the facts alleged, if true, support the filing of a petition for dependency. If they do, the merits of the petition and scrutiny of the facts alleged as well as additional facts and findings of CYF or other parties/witnesses will occur at the subsequent hearing.<sup>5</sup>

However, given the concerns regarding venue, discussed below, CYF has a direct, substantial, and immediate interest in the disposition of the Application to avoid the time and cost of preparing for a full hearing if the Application is granted and a private dependency petition is filed with subsequent hearing (at which CYF would then be forced to prepare for the hearing and raise the issue of venue). Accordingly, this court grants CYF's Motion to Intervene on the basis of its argument regarding venue.

#### Parents' Procedural Status and Guardian Ad Litem

Complicating matters at the hearing was the appearance of counsel for each parent and the appearance of the father of the Child, himself. Specifically, on February 9, 2023, the Honorable Analisa Sondergaard appointed counsel for both [E.P.] (Father) and [M.V.R] (Mother) "for the purposes of consulting counsel regarding the Application Hearing and Rules 1320, 1133, and 1321 of the P[a].R.J.C.P." February 9, 2023 Orders. Counsel for Petitioner objected to the intervention of parents or their participation at the hearing noting that Pa.R.J.C.P. 1320

does not require notice of an application to file a private petition be sent to the parents, caretaker, or guardian. <u>Compare</u> Pa.R.J.C.P. 1331 (directing service of a dependency petition be filed upon the child's guardian).

As this court has noted in prior applications to file a private dependency petition, no case law appears to exist on the issue of parental standing at the application stage pursuant to a Rule 1321 hearing. See In re: T.T., Docket # CP-15-DP-53-2008. However, at the hearing, counsel for each parent stated that their client did not seek to intervene but just to observe. Accordingly, the objection to intervention is moot; however, this court believes it worth noting that it granted the parents the right to remain in the hearing (along with minimal commentary by their counsel) because it is hard-pressed to believe that parents (or a caregiver in the appropriate circumstance) should not be granted the right to intervene if requested and to ask questions regarding the application and allegations therein. The substantial rights of parents, guardians, or caretakers regarding their children or wards warrants the appointment of counsel at the earliest possible stage when there is allegation of neglect or abuse that may result in the removal of a child or ward from their care. Moreover, to the extent Petitioner objects to the appointment of counsel for parents, this court is bound by Judge Sondergaard's February 9, 2023 Orders.

Additionally, Petitioner by letter to this Court dated February 16, 2023, and at the hearing, requested a guardian ad litem (GAL) to be appointed for Child. Specifically, Petitioner requested Carla Goewert, Esquire (who is presently the GAL for the sister of Child in an open dependency matter) be appointed for the hearing on the Application. Petitioner argued that whenever counsel for parents is appointed it would be appropriate to appoint a GAL for a child and that here the court has appointed counsel for the parents. This court declined to appoint a GAL for the hearing on the Application because: (1) parents were not actually intervening or participating in the hearing; and (2) Pa.R.J.C.P. 1151 provides that "[t]he court shall assign a guardian ad litem to represent the legal interests and the best interests of the child if a proceeding has been commenced pursuant to Rule 1200 alleging a child to be dependent .... " Presently, a question exists as to whether an application is a proceeding commenced pursuant to Rule 1200, which states in relevant part, "[d] ependency proceedings within a judicial district shall be commenced by: (1) the filing of a dependency petition[.]" Presently, no dependency petition has been filed. Rather a precursor application to file a private dependency petition has been filed. As such, a GAL is not required to be appointed at this time, and given the limited nature of a Rule 1321 hearing (to determine whether sufficient facts have been alleged to support a petition of dependency), this court declined to appoint a GAL. However, Ms. Goewert sat through the hearing, was an available witness given her work with the family through her appointment as GAL for the Child's sibling, and is now appointed pursuant to Pa.R.J.C.P. 1151 given that the Application is granted.




