OPINION AND ORDER

LESKINEN, P.J.

July 19, 2024

Before the Court is the Motion for Judgment on the Pleadings filed by Plaintiff, First Christian Church of New Salem. ("First Christian.") Upon consideration of the Motion, the Response filed by Defendants, Ultimate Structures, LLC, ("Ultimate") and Michele Cramer ("Cramer"), and the briefs filed by the parties, the Court issues this Opinion and Order denying Plaintiff's Motion.

Factual and Procedural History

First Christian entered into an agreement to purchase a 24' by 36' storage building/shed ("Building") from Defendant, Northern Steel Buildings and Structures, ("NSBS"), through their dealer, Ultimate Structures, LLC. The agreement is memorialized by two documents, which were attached to the Amended Complaint as Exhibits. Exhibit "A" is dated March 11th, 2021, which sets forth certain terms and conditions related to site preparation and installation on Ultimate's letterhead and was signed by John Herre for First Christian and by Michele Cramer as "Dealer". The pre-printed term #6 reads, "NO DEPOSIT REFUNDS FOR ANY REASON!" which has been modified with the handwritten notations, "See Below" and "Will Refund deposit for any unforeseen circumstances!" and was initialed with "MC/JH." Exhibit "B" is an order sheet on NSBS letterhead dated March 11th, 2021, and signed by John Herre as "Buyer", Michele Cramer as "Dealer/Witness" and has no signature on the line marked "Accepted." A handwritten notation at the top indicates that the terms were modified on March 15th, 2021. The shed was never delivered or installed, and First Christian has not received any refund of their \$6,256.12 deposit, which was paid by check made out to NSBS.

This action came before the Court of Common Pleas by Notice of Appeal filed by Ron Romeo t/d/b/a Ultimate Structures on April 26th, 2022, of a Magisterial District Judge's judgment in favor of First Christian against Ron Romeo t/d/b/a Ultimate Structures in the amount of \$6,438.37 dated April 5th, 2022. First Christian filed a Complaint on May 17th, 2022, to which Defendant/ Appellant filed Preliminary Objections on June 21st, 2022. First Christian filed an Amended Complaint on July 12th, 2022. Ultimate and Cramer filed Preliminary Objections to the Amended Complaint on August 16th, 2022, which were overruled by this Court by Order dated June 16th, 2023. Ultimate and Cramer filed an Answer and New Matter to the Amended Complaint on July 10th, 2023, to which First Christian has not filed a reply. First Christian filed the Motion for Judgment on the Pleadings currently before this Court on August 3rd, 2023. {1}

^{1} Both sides have contributed to procedural delays in this matter. Defendants filed Preliminary Objections to the Amended Complaint on August 16th, 2022, but did not present them in Motions Court as required by F.C.R. 1028(c)(c) until January of 2023. Plaintiff filed its Motion for Judgment on the Pleadings on August 3rd, 2023, but failed to present a timely Motion for disposition (per the Court's Order dated August 14th, 2023) until May of 2024.

Standard of Review

A motion for judgment on the pleadings is in the nature of a demurrer and may only be entered when there are no disputed issues of fact, and the moving party is entitled to judgment as a matter of law. Kelly v. Nationwide Ins. Co., 606 A.2d 470, 471 (Pa. Super. 1992). The court must accept as true all well-pled facts of the party against whom the motion is made while holding against them only those facts they have specifically admitted. Id. Consideration is limited to the pleadings themselves and any documents or exhibits properly attached to them. The court may not consider any conclusions of law or unjustified inferences as admissions. Id. The moving party's case must be so free from doubt that a trial would prove fruitless. Id. at 472.

Discussion

This Court previously overruled Ultimate and Cramer's Preliminary Objections challenging the legal sufficiency of the claims raised in the Amended Complaint. A court may sustain preliminary objections only when it is clear and free from doubt that the law would permit no recovery under the allegations pled. Lerner v. Lerner, 954 A.2d 1229, 1234 (Pa. Super. 2008). Though First Christian repeatedly characterizes that decision as one "on the merits" in their Motion and Brief, the ruling did not make any findings as to whether First Christian would eventually succeed in their claims, finding only that the evidentiary record was not yet developed to a point where the Court could rule as a matter of law as to the nature of any contractual relationship between First Christian and Ultimate or whether the fraud claim was precluded by the "gist of the action" doctrine.

Breach of Contract

The claim for breach of contract avers that Ultimate, in both its individual capacity and as an agent of NSBS, contracted with First Christian and that NSBS ratified the contract by accepting and depositing the check made out to NSBS. In a contract action, the burden is on the plaintiff to prove the existence of a contract to which the defendant is a party. Viso v. Werner, 471 Pa. 42, 46 (Pa. 1977). The order sheet with specifications and pricing is on NSBS letterhead, with preprinted language near the bottom above the signatures stating, "If accepted below by Northern Steel Buildings & Structures (Seller) at its office in Lee, MA, this order becomes a contract between Seller and the Buyer named above as follows: subject to the terms above." {2}

Pennsylvania law is well-settled that an authorized agent for a disclosed principal is not a party to the contract and not personally liable to the other contracting party, absent a showing of fraud, illegality, or evidence demonstrating that the agent incurred personal liability. Id. at 46 and 49. This creates a strong presumption that the contract was between First Christian and NSBS and not between First Christian and Ultimate (or Cramer). There is no dispute in the pleadings that NSBS did not fulfill its obligations under this contract to provide the building First Christian ordered and has not refunded their deposit. First Christian would appear to be entitled to judgment against NSBS on the breach of contract count, {3} but the Motion for Judgment on the Pleadings only seeks judgment against Cramer (who is not actually named in the Count) and Ultimate.

^{2} Though the document is not signed on the "accepted" line by NSBS, the pleadings and attached documents demonstrate that NSBS cashed the check tendered by First Christian for the amount specified on the order sheet.

^{3} However, the original Complaint filed on May 17th, 2022, names Ron Romeo, t/d/b/a Ultimate Structures, LLC, as the only Defendant, consistent with the caption of the appeal from the MDJ decision that initiated this case. The Amended Complaint filed on July 12th, 2022, after Preliminary Objections, names Ultimate; NSBS; and Cramer, an individual, as Defendants. No Certificate of Service was filed with the Amended Complaint, nor was a Return of Service filed indicating service of original process on NSBS or on Cramer. The Amended Complaint does not include a Notice to Defend or a Notice to Plead. Though Cramer has participated in the litigation with counsel entering an appearance on her behalf, there is nothing in the record to suggest that NSBS was served with original process, nor have they filed any legal papers in this matter. Furthermore, upon review of the other documents filed in this action, it does not appear that counsel for Plaintiff or counsel for Ultimate and Cramer have ever served NSBS with any document filed in this matter, as the Certificates of Service consistently refer only to service upon other counsel of record.

To overcome the presumption that Ultimate and Cramer are not parties to the contract, First Christian would have to establish that Ultimate and/or Cramer made a contractual promise to incur personal liability, or would have to establish fraud or illegality. Id. A plaintiff may overcome the inference that the agent is not a party to a contract by producing other facts connected with the transaction. Restatement 2nd of Agency, §320, comment "c". Though the refund language added to the document included in Exhibit "A" to the Amended Complaint provides some support for such an argument, the ambiguity of the language, particularly where the deposit was paid by check made out to NSBS, is insufficient on its own to find that Ultimate or Cramer incurred liability for the contract based on the pleadings.

First Christian argues in its Motion and Brief that NSBS was not a party to the contract and that Cramer's actions bound Ultimate to the contract. This is predicated on a respondeat superior/vicarious liability theory that does not appear in the Amended Complaint. This theory fails to distinguish between tort and contract concepts and does not address the plain language of the contractual documents which establish a contract with NSBS and not with Ultimate, supported by the check written directly to NSBS. The Motion and Brief also directly contradict the averments of fact in Count I of the Amended Complaint. Thus, the Court cannot find that Cramer or Ultimate breached the contract based solely on the pleadings.

Counts Pled in the Alternative

A party may plead causes of action in the alternative under Pa. R.C.P. 1020(c), but a party may not recover under multiple causes of action when those causes are mutually exclusive. Lugo v. Farmers Pride, 967 A.2d 963, 969-970 (Pa. Super. 2009). For example, a plaintiff cannot ultimately recover on both breach of contract and unjust enrichment claims arising from the same facts and circumstances. Id. at 970. First Christian has pled causes of action for breach of contract, unjust enrichment, conversion, and fraud. First Christian's Motion seeks judgment on all four counts but only against Ultimate and Cramer. This contradicts the Amended Complaint, as Count II, for unjust enrichment, was only pled against NSBS, therefore the Motion for Judgment on that Count as to Ultimate and Cramer must be denied.

Count III for conversion, is similarly titled as "First Christian Church v. NSBS" but then goes on to plead conversion against NSBS and Ultimate (but not against Cramer). Conversion under common law is a tort concept in which a defendant deprives a plaintiff of their right to a chattel or interferes with the plaintiff's use or possession of a chattel without the plaintiff's consent and without lawful justification. Chrysler Credit Corp. v. Smith, 643 A.2d 1098, 1100 (Pa. Super 1994). The facts in this matter, as developed in the pleadings, establish that Ultimate took possession of a check from First Christian made out to NSBS on March 11th, 2021, which was forwarded to NSBS who then deposited the check on or about March 16th, 2021. The pleadings do not establish that Ultimate had control or dominion over First Christian's funds at the time any conversion occurred as would be required to sustain a claim for conversion against Ultimate.

Furthermore, The Pennsylvania courts have consistently held that the "gist of the action" doctrine precludes a plaintiff from re-casting ordinary breach of contract claims into tort claims. Bruno v. Erie Ins. Co., 630 Pa. 79, 112 (Pa. 2014). A plaintiff's label for such a claim as a tort is not controlling: if the facts of a particular claim establish that the duty breached is one created by the parties by the terms of their contract then it is viewed as one of a breach of contract. Id. Claims for conversion have been consistently disallowed where such claims are based on the same facts as the contract claim. Pittsburgh Construction Co. v. Griffith, 834 A.2d at 572, 584 (Pa. Super. 2003). Here, First Christian has not established sufficient facts through the pleadings to support a tort claim for conversion rather than a contract claim.

First Christian's Count IV for fraud names all three Defendants, and is the only Count pled against Cramer in her individual capacity. First Christian avers that at the time the parties executed the contract for the purchase of the building, "NSBS was unable to deliver and/or install the

same on Plaintiff's property." (Amended Complaint, ¶ 79). The Amended Complaint references an email dated March 10th, 2021, which was not attached to the pleadings. First Christian further alleges that Cramer, in her individual capacity, knew or should have known that NSBS was unable to deliver or install the shed. (Id. at ¶ 80.) The Amended Complaint alleges, at ¶ 83, "By misrepresenting material facts to Mr. Herre in order to induce a fraudulent payment, Ms. Cramer acted beyond the lawful scope of her duties as an agent of Ultimate and is therefore liable to the Plaintiff for fraud in her individual capacity."

Ultimate and Cramer specifically denied each of these allegations in their Answer and New Matter, creating disputed issues of material facts. In addition, the factual allegation in the Amended Complaint that Cramer acted beyond the scope of her duties as an agent of Ultimate directly contradicts First Christian's Motion at \P 5, which argues, "As its employee, at all times relevant hereto, Cramer acted as the authorized, lawful, and disclosed agent of Unlimited, which at all times relevant hereto, was Cramer's lawful and disclosed principal." The question of whether a person was acting within the scope of his or her employment is typically a question of fact for the jury. Costa v. Roxborough Memorial Hospital, 708 A.2d 490, 493 (Pa. Super. 1998). As these disputed facts were not resolved by the pleadings, First Christian's Motion as to Count IV for fraud is also denied.

WHEREFORE, the Court issues the following Order:

ORDER

AND NOW, this 19th day of July, 2024, upon consideration of the Plaintiff's Motion for Judgment on the Pleadings, Defendants' Response and New Matter, and the briefs submitted by the parties, the Motion is hereby DENIED, without prejudice, for the reasons set forth in the Opinion filed with this Order.

WHEREAS, the time period set for discovery pursuant to F.C.R. 212.1(a) of 240 days from the filing of the Amended Complaint expired in March of 2023, the Court ORDERS and DI-RECTS that Plaintiff shall have twenty (20) days from the date of this Order to file a Pre-Trial Statement pursuant to F.C.R. 212.2, unless stayed by the Court upon appropriate Motion.


