

- Appellant James Miller, for Chase Miller, filed a Motion for Supersedeas
- 2. Upon consideration of the Motion, the Brief filed in this case, and the relevant statutes and case law, the Court determined that the Appellant failed to meet his burden to establish that there is a likelihood that the appeal will succeed, that there will be irreparable injury if the stay is denied, that issuance of the stay will not substantially harm other interested parties, and that the issuance of a stay would not adversely affect the public interest. Accordingly, the Court denied the Motion for Supersedeas.

** Note — contrary to the Opinion below, the Plaintiff did file a Brief in this matter. The Court issues a Supplemental Order addressing this issue, which is attached below.

OPINION DENYING MOTION FOR SUPERSEDEAS

Facts and Procedural History

On May 2, 2013, Appellant filed an appeal of Eastern York School District's ("School District") decision to expel student Chase Miller. Chase was first questioned by school personnel on April 8, 2013. Chase subsequently wrote and signed a statement admitting to bringing marijuana to school on two occasions. Chase was suspended for three days and an expulsion hearing was scheduled. Chase has not attended school since

April 8, 2013. On April 15, 2013, an expulsion notice was mailed to James Miller, Chase's father, by certified mail. Mr. Miller was notified that he had a certified package on April 16th and signed for and received the Notice on April 17, 2013. The hearing was scheduled for and conducted on April 18, 2013 at 4:30pm. The hearing was conducted by eight board members, all of whom entered the recommended opinion that Chase be expelled. Gareth Pahowka served as Solicitor. At the time of the filing of the Appeal, Appellant had not received a copy of the decision to expel Chase.

In the Appeal, It has been alleged that Chase was likely 14 years old at the time of the incident giving rise to the expulsion, although Appellant alleges that he has been unable to identify any school document which specifically identifies the incident that gave rise to the suspension, that he had previously had no disciplinary record, that no drugs were found in his locker when it was searched, and that the school violated Chase's rights as set forth in 22 Pa. Code. 12.8. For example, it is alleged that Chase did not receive the appropriate amount of statutory notice prior to the hearing, that Chase was denied his right to have counsel present, that sufficient notice of the charge was not given, that Chase was not given discovery and witnesses were not identified, and that the only evidence against Chase was his written statement that he had brought marijuana to school on two occasions. In addition, because of his expulsion Chase is now attending a cyber-school and Appellant avers that the courses in the cyberschool do not challenge Chase and are not the same as the courses as he was taking at the school.

On May 2, 2013, Appellant filed a Motion for Supersedeas. The School District filed a Response on May 13, 2013 wherein it argued that Appellant is not entitled to a stay in this matter. The Motion was presented to the Court at the May 14, 2013 session of Current Business. The Court took the matter under advisement and ordered the Parties to submit Briefs on the sole issue of whether a request for a supersedeas could be made in this case. Both Parties submitted timely briefs. Upon careful review of the Briefs submitted and the applicable law, the Court determined that an appellant is permitted to request a supersedeas during the pendency of an appeal from a school board's decision to expel a student. In making this determination, the Court relied on the Commonwealth Court's decision in Yatron by Yatron v. Hamburg Area School District, 158 Pa.Cmwlth. 204, 631 A.2d 758 (1993),

wherein the Commonwealth Court elucidated the standard under which a trial court should consider the request for a stay of proceedings pending the appeal of a student's expulsion. The Commonwealth Court determined that the applicant for the stay "must establish (1) a likelihood of success on the merits of the appeal; (2) irreparable injury if a stay is denied; (3) issuance of a stay will not substantially harm other interested parties; and (4) issuance of a stay will not adversely affect the public interest." Yatron, 631 A.2d at 761. This Court has similarly considered requests for supersedeas in appeals from a student's expulsion and while the Court has recognized that there is no statutory authority, the Court nevertheless has considered the same factors as enumerated in the Yatron case. See e.a. The Honorable Richard K. Renn's Order filed August 11, 2009 in Craig Warner v. South Eastern School District, 2009-SU-3512-08.

The School District requested, should the Court find the request for supersedeas to be appropriate, an opportunity to submit a brief on the elements necessary for granting the stay. The Court granted the request and entered an Order dated June 6, 2013 that required the Parties to submit Briefs with respect to the four *Yatron* factors within 20 days. The School District filed its Brief in Opposition to Supersedeas on June 26, 2013. Appellant failed to submit a Brief on this issue.

Issue Presented

Whether Appellant has established (1) a likelihood of success on the merits of the appeal, (2) irreparable injury if the stay is denied, (3) that issuance of the stay will not substantially harm other interested parties, and (4) that issuance of the stay will not adversely affect the public interest, and is therefore entitled to a supersedeas during the pendency of this appeal.

Discussion

This appeal is being conducted pursuant to the Local Agency Law, 2 P.S. §551-555, under the authority of the Public School Code, 24 P.S. §13-1318, and in accordance with the due process requirements of the student discipline regulations, 22 Pa. Code. §12.6-8. In addition, "[t]he decision to grant or deny a stay pending appeal is vested in the trial court's discretion." *Yatron*, 631 A.2d at 761. The Court will deny the request for a stay in this case as Appellant has failed to meet its burden as established by the Commonwealth Court in *Yartron*.

Likelihood of Success on the Merits

In order to succeed in an appeal from of a disciplinary action of the School Board, the Appellant will have to overcome a difficult hurdle. In Pennsylvania "local school boards have broad discretion in determining school disciplinary policies." Flynn-Scarcella v. Pocono Mountain School Dist., 745 A.2d 117, 120 (Cmnwlth. 2000). In an attack of "a school board action on matters committed by law to its discretion," the Appellant has a "heavy burden, as the courts are not prone to interfere unless it is apparent that the school board's actions are arbitrary, capricious, and prejudicial to the public interest. In the absence of a gross abuse of discretion, the courts will not second-guess policies of the school board." Id.

Pursuant to Section 13-1318 of the School Code, "[e]very principal or teacher in charge of a public school may temporarily suspend any pupil on account of disobedience or misconduct, and any principal or teacher suspending any pupil shall promptly notify the district superintendent or secretary of the board of school directors. The board may, after a proper hearing, suspend such child for such time as it may determine, or may permanently expel him." 24 P.S. §13-1318. Accordingly, the decision to expel Chase was a matter committed by statute to the School Board's discretion.

"A court of common pleas, in reviewing a decision of a school board in such an appeal on the record before it, cannot modify the penalty even if considered too severe, but can reverse the action taken by a school board only where it finds constitutional rights have been violated, an error of law was committed, or a finding of fact was not supported by the evidence." Southeastern School District v. Abremski, 12 Pa. D. & C.3d 323, 325 (York.Cnty.Ct.Com.Pl. Sept. 19, 1979) (citing In Giles Appeal from Marple Newtown School Dist., 27 Pa.Cmwlth. 588 (1976)); see also T.S. v. Penn Manor School Dist., 798 A.2d 837 (Cmnwlth. 2002). The School Board did create a record in this case, a copy of which was received by the Court on June 10, 2013.

In summary, to succeed on the merits in this case, Appellant will have to establish that the School Board committed a gross abuse of discretion in making its decision to expel Chase; specifically, that the School Board either violated Chase's constitutional rights, committed an error of law, or made a finding of fact not supported by the evidence. In this case, Chase voluntarily admitted to possessing illegal drugs on school property. In light of the high deference due to the School Board,

Chase's admission, the fact that notice of the hearing was received, as well as the failure of Appellant to submit a Brief on this issue, the Court has determined that Appellant has failed to establish that this appeal is likely to succeed on the merits. The inability of the Appellant to establish the likelihood of success of appeal is a sufficient basis for denying this Motion. However, the Court will also review the remaining three *Yartron* factors.

Irreparable Injury to the Student & Substantial Harm to School District

Appellee's original Memorandum of Law, filed May 24, 2013, with respect to whether the request for supersedeas was appropriate, refers the Court to a March 22, 1979, Opinion and Order of this Court. In Southeastern School District v. Abremski (No. 1), 12 Pa. D. & C.3d 320, 1979 WL 481 (Pa.Com.Pl.), the Honorable Joseph E. Erb, Sr., recognized that there was no statutory authority for a request for supersedeas in an appeal from disciplinary action taken by a school board against a student. Nevertheless, Judge Erb determined that consideration of the request for supersedeas required analysis for the important, and conflicting, interests in the case. Judge Erb found that there were two conflicting rights: "the right of the school board to maintain rules and regulations on one hand, and the individual right of the student to an education on the other." Abremski, 12 Pa. D. & C.3d at 322. Taking into consideration the fact that within a few days there would be determination of whether the students could return to school, the fact that argument on the merits of the appeal was similarly scheduled only a few days following the entry of the opinion, and considering that the school board's ability to impose discipline may be harmed should the Court disrupt a determination of the school board, Judge Erb entered an Order denying the request for a supersedeas.

In the present case, Chase was expelled near the end of the school year, he was provided alternative education at cyber-school, school is presently out of session for the summer, and the hearing on the merits of appeal is scheduled in approximately a month. In addition, Appellant failed to submit a Brief in this matter, indicating a lack of concern about receiving the stay at this point. Chase has not suffered irreparable injury. In contrast, the grant of the supersedeas will overrule the decision of the School Board and the administrators of the school, thereby undermining the School District's disciplinary authority. Appellant has failed to establish irreparable harm to Chase and substantial harm to the School District has been established.

Adversely Affect the Public Interest

The School District argues in its Brief that "the health and safety of the public is promoted where school officials take action to remove illegal drugs from the school environment and discipline students who voluntarily admit the possessing and distributing drugs in school" and that "[t]he public interest is also served where the Courts support the disciplinary decisions of local school boards and administrators unless it is apparent that the school's actions have been arbitrary, capricious and prejudicial to the public interest." The Court agrees and since Appellant has presented no facts attesting to or argument to the effect that the actions of the school were arbitrary, capricious or prejudicial to the public interest, the Court has determined that this element of the Yartron test has also not been

The Court would also like to address a concern raised by the School District in their Brief in Opposition to Supersedeas. School District worries that the Court's Order scheduling the hearing in the Appeal indicates that the Court will be hearing the appeal de novo. 2 Pa. C.S.A. §754(b) clearly provides that where there is a complete record, "the court shall hear the appeal without a jury on the certified record of the agency." Nothing in the Scheduling Order was intended to indicate that this matter would be heard de novo; the appeal will be decided on the record. However, the Court will still hold the hearing scheduled for August 15, 2013 at 9:30am and the School District's request that this matter be decided on Briefs is DENIED.

Conclusion

In conclusion, the Court will **DENY** the Motion for Supersedeas filed on May 2, 2013. An Order consistent with this Opinion will be entered.

SUPPLEMENTAL ORDER DENYING MOTION FOR SUPERSEDEAS

Contrary to the Opinion Denying Motion for Supersedeas filed July 11, 2013, it appears that Appellant did in fact file a Brief addressing the Yatron factors which the Court ordered by its June 7, 2013 Order Determining that Request for Supersedeas is Appropriate. Apparently, Appellant had previously filed a Brief in Support of Motion for Supersedeas on May 10, 2013. The Court never received a copy of this Brief nor was the Court notified that it should view the May Brief as the Brief that the Court had ordered in June. The Court did receive Appellant's Supplemental Brief in Support of Supersedeas, which the Court requested when determining whether a request for supersedeas was appropriate. That Supplemental Brief referred to a May 10, 2013 Brief, but no copy of that Brief was attached. The Court has now reviewed Appellant's Brief and the decision to DENY the request for supersedeas will stand.

One of the bases for determining that Appellant had not met their burden to establish the four *Yatron* factors was the Court's belief that a Brief had not been filed. However, the Court also reviewed the applicable law in considering Appellant's request for supersedeas and determined that the request for the stay should be denied.

First, Appellant argues that Chase's constitutional rights were violated. This argument is a basis for reversing the action of the School Board. However, considering the high deference given to the School Board's decisions in these cases, the fact that Appellant and Chase did receive what appears to be reasonable Notice of the hearing, the fact that no request by the School Board that they be informed by a certain date whether Chase has retained counsel could possibly have prevented Chase from retaining counsel at any time he chose, the fact that 22 Pa. Code § 12.8(b) (5) does not entitle Appellant or Chase to have pre-hearing discovery, the fact that the members of the Board were told not to consider statements that were excluded from the record, and the averment by Appellee that the Board indeed did disregard those statements, and the fact that the expulsion was based on the admission of Chase that he possessed and sold illegal drugs in school property on two occasions, convinces the Court to again conclude that Appellant has not established a likelihood of success on the merits. The request for supersedeas must therefore be denied.

As discussed in the previous Opinion, the Court is still convinced that Chase will not suffer irreparable harm: it is currently the summer, the hearing to determine his Appeal is


scheduled to occur in approximately a month, and Chase was provided alternative education. The Opinion also explained in detail the substantial harm to the School District which occurs when the Court overrules disciplinary decisions. Finally, Appellant's Brief does not sufficiently establish that the public interest would be harmed should the supersedeas not be granted. Appellant argues that arbitrary discipline is against the public interest. The Court agrees. Nevertheless, at this point Appellant has not established that the discipline was arbitrary. Arbitrary discipline and the allegations of violations of Chase's due process rights may be grounds on which the Appeal will be sustained, but the allegations at this point are not sufficient for the grant of the supersedeas.

The Order and Opinion Denying Motion for Supersedeas filed June 11, 2013 and hereby SUPPLEMENTED and REAFFIRMED.
